This document contains the ACO Primary Care (PC) Flex Model Annual Spend Plan for Performance Year 2026 prepared by My Choice Quality Care Network, LLC (A5670). Pursuant to Section 8.05.C of the *ACO Primary Care Flex Model Participation Agreement*, the ACO shall publish certain elements, as specified by CMS, of its Spend Plan on its Medicare Shared Savings Program webpage (maintained pursuant to 42 CFR § 425.308), in a form and manner and at a time specified by CMS. PC Flex ACOs are required to publicly publish their Spend Plans, to ensure additional accountability and transparency in how they are spending the Advance Shared Savings Payment and Prospective Primary Care (PPC) Payment to support the provision of primary care. Spend plans are approximate and non-binding and may differ from actual expenditures.

³ Starting in Q3 of PY 2025, if a PC Flex ACO had less than one dollar remaining (\$0.00-\$0.99) of the Advance Shared Savings Payment, CMS waived the remaining amount. As of Q3, any waived amounts are denoted as "N/A" in Tables 1 and 2.
