HOW DOES THE PROCESS WORK AT INSPIRE WELLNESSRX?

Patient Intake Forms must be completed at least 2 days before the appointment.

- Set an initial appointment to meet with the doctor at one of our clinic locations. **You will need:**
 - ✓ Proof of qualifying diagnosed conditions: medical record of diagnosis, prescription for the qualifying conditions, ESA letter, veteran's disability letter, etc.
- You will receive a confirmation with a link to the Patient Intake Form, which must be completed at least 2 days ahead of your appointment, or a reschedule will be necessary.
If you do not have records at home/patient portal to provide, you'll need to complete an Authorization to Release Medical Records.
 - If records DO NOT EXIST for a qualifying diagnosed condition, another clinic may be able to help you.**
- **During your appointment:** we will enter your profile into the Medical Marijuana Use Registry. You will immediately receive two emails from MedicalMarijuanaUse@FLHealth.gov. which we will use to help you register for your medical marijuana card with the state.
 - ✓ Submit PROOF OF RESIDENCY
 - ❖ **PERMANENT** residents will either pull their proof of residency from the DMV through the MMU system or upload a copy of their unexpired current Florida ID.
 - ❖ **SEASONAL** residents will need to upload **two** documents that have **your name** and **Florida address** on them, no more than two months old (electricity, water, gas or sewer bill, financial institution statement, lease, deed, monthly mortgage statement, mortgage payment booklet, letter from any gov't agency, county tax bill, change of address USPS).
 - ✓ Sign your name in the Signature section at the very bottom
 - ✓ Pay the \$75 to the state for your medical marijuana card
 - *Permanent Florida Residents are now approved immediately after completing the MM Card application. Seasonal Residents will receive approval 8-10 days after Card application completion.**
- The day after your initial appointment, the doctor will add your certification, initial orders AND refill orders into the Registry system. (**Six** 35-day orders for the smokable flower route, **three** 70-day orders each of Oral, Edibles, Sublingual, Topical, and Inhalation routes in low and high THC options).
- **Seven months later:** book a follow-up appointment. We would like your feedback, and you receive a new Certification with another 7 months of orders entered into the MMU Registry system.
***Please note that CARD renewal and prescription ORDER renewal are two separate tasks.**

WHAT ARE THE COSTS ASSOCIATED WITH MEDICAL MARIJUANA?

Initial Visit: \$149 (**one-time cost**)

Transfers/ORDER Renewal Visits: \$99 (**every 7 months**)

Medical Marijuana CARD renewal: \$75 (**once a year**)

*We also offer home visits for \$229, for those who cannot travel

ADDITIONAL SERVICES:

Caregiver Card: \$29 Clinic Admin fee (one time) + \$75 paid to MMU (every year)

(Caregivers must provide proof of relationship to the patient or Level 2 background check)

***Please note, due to the high rate of no-shows, rescheduling and canceled appts, there will be a small \$25 rebooking fee, beginning

August 2021***
