## HOW DOES THE PROCESS WORK AT INSPIRE WELLNESSRX?

- 1) When you call to book an appointment, we will first determine if you have been diagnosed with a chronic condition that the state will approve. There <u>must</u> be proof of the condition by providing medical records from your PCP, specialist or therapist, OR 3 months of prescription history that relates to a chronic qualifiable condition. Please note: a doctor certified in medical marijuana cannot diagnose a patient with a <u>chronic</u> condition if the doctor has no prior relationship with the patient.
- **2)** We will text or email a Patient Intake Form link for you to complete and upload your records/prescription history. <u>PLEASE NOTE</u>: there are two parts, Intake Form and Consent Form.
  - a. Complete the Patient Intake Form and review it to make sure all information is correct.
  - b. Upload proper proof of your chronic medical condition. We will not accept records from another medical marijuana clinic.
- 3) We will review your submission to make sure all information provided meets the state's requirements and call/text you for booking an appt.
  - \*\*\*We cannot finalize your appt until all requirements are met, please complete the information in a timely manner\*\*\* A \$29 non-refundable deposit is required for clinic appts, due to the rate of no-shows.
- 4) The day before the appointment, we will text a reminder to you and ask you to confirm that you will be coming to the appointment.
- 5) During your appointment: we will enter your profile into the Medical Marijuana Use Registry. You will immediately receive two emails from <a href="MedicalMarijuanaUse@FLHealth.gov">MedicalMarijuanaUse@FLHealth.gov</a>, which we will use to help you register for your medical marijuana card with the state.
- 6) You will receive card approval by email. For Florida DL holders, approval will go through in 1-10 days. For SEASONAL RESIDENTS approval in 8-10 days.
- 7) The doctor will add your certification, initial recommendations (prescriptions), AND refills into the Registry system (7 months of recommendations) that evening.
- 8) Seven months later: book a follow-up appointment (\$99) to renew recommendations/prescriptions when you receive your renewal reminder text from Kayla's cell: 561-543-9128.

## WHAT ARE THE COSTS ASSOCIATED WITH MEDICAL MARIJUANA?

Home Visit: \$229 Initial Appt: \$149 Transfer Appt: \$119 Scheduled Renewal Appt: \$99 Unscheduled Appt: \$109 Medical Marijuana CARD renewal: \$77.75 (yearly)

Increase Requests: FOR THOSE WHO QUALIFY ONLY \$29 (one-time fee)

## **ADDITIONAL SERVICES:**

Patient's Caregiver Card: \$25 Clinic Admin fee (one time) + \$75 paid to MMU (yearly) (Caregivers must provide proof of relationship to the patient, or Level 2 background check)
