RELIEF REQUESTED

Plaintiff, Her Imports, by and through the undersigned counsel hereby submits this Supplemental Motion for Default Judgment and Memorandum In Support of Relief Requested. In support of this Supplemental Motion, the Plaintiff states:

I. Procedural Background

On November 22, 2022, Plaintiff filed a Motion for Default Judgment and Memorandum In Support of Relief Requested. [Dkt. 26.]

On November 30, 2022, the Honorable Nancy L. Maldonado, by Minute Order directed the Plaintiff to file a supplemental brief and affidavit in support of their requested damages and alternative relief. [Dkt. 28.]

In accordance with the Minute Order, the Plaintiff is filing this supplemental brief with an affidavit and supporting exhibit that ties the requested damages amount to the 2-year period alleged in the complaint. The submitted affidavit provides sufficient detail explaining the previous

supporting spreadsheet and why the items in the spreadsheet constitute improper non-business expenses for which Plaintiff is entitled to recover as damages. *Id*.

Further, Plaintiff is filing this supplement brief to provide legal authority supporting the alternative requests for equitable/injunctive relief. *Id*.

The Plaintiff is not seeking reimbursements costs.

II. Updated Background on Adjusted Damages

- 1. The Plaintiff's original Complaint sought \$753,772 in damages for the period July 31, 2015 through December 21, 2019. [Dkt. 1] and Hall Affidavit ¶ 15.
- 2. Cabello took ownership in Plaintiff, Her Imports starting April 9, 2018. Hall Affidavit ¶ 16.
- 3. Therefore, to reflect the wrongdoing against the Cabello entities, the damages have been adjusted to reflect their ownership for the two year period from April 9, 2018 through December 21, 2019, which amounts to \$657,771 wrongfully taken. Hall Affidavit ¶ 16.
- 4. The difference (\$753,772 minus \$657,771) of \$96,001, represents the money wrongfully taken by Mr. Terry (the control person of the Cabello entities) personally from July 31, 2015 through April 9, 2018, and are not included in damages sought. Hall Affidavit ¶ 16.
 - 5. A payment breakdown of the \$657,771 taken by Cabello entities are categorized as follows:
 - a: Payment of unrelated rents: \$42,673
 - b. Payment of travel expenses: \$331,147
 - c. Employee travel expenses: \$47,330
 - d. Use of company credit card for personal reasons: \$63,925
 - e. Inventory misdirected: \$124,192
 - f. Shipping and freight \$19,288
 - g. Foreign transaction fees: \$4,580
 - h. Dental work: \$6,000
 - i. Payment made to Patrick Terry's daughter: \$5,000
 - j. Miscellaneous: \$13,636

See Hall Affidavit ¶ 17.

- 6. With regards to the inventory, a total of \$124,192 in inventory was misappropriated diverted, and converted, where the Cabello entities took control of the inventory that was subsequently sold for their personal gain at the expense of the Plaintiff, Her Imports. Hall Affidavit ¶ 19.
- 7. Since Cabello Defendants are foreign entities, domiciled in the United Arab Emirates, the Plaintiff anticipates that it will be difficult to collect the monies owed, even with a U. S. Court Order; therefore, in the alterative, if the Defendants fail to pay the damages in 45-days, the Plaintiff respectfully requests that the Court to grant an Order, that NATCO, Her Import's authorized transfer agent cancel the Defendants share ownership of Her Imports to the amount of the monies owed, which would include any and all shares issued to the Cabello entities; transfer their ownership rights and administrative control in the Cabello.divino Instagram account to Her Imports; and transfer their ownership and administrative control over the URL, www.herimports.com to Her Imports. Hall Affidavit ¶ 28.
- 8. This alternative represents an equitable method to protect the value of Her Imports, and its shareholders, whose ownership value in Her Imports suffered due to the misappropriation of \$657,771. Hall Affidavit ¶ 31.

III. Legal Standard

A. Injunctive Relief

A party seeking a preliminary injunction must show (1) that its case has "some likelihood of success on the merits," and (2) that it has "no adequate remedy at law and will suffer irreparable harm if a preliminary injunction is denied." *Ezell v. City of Chi.*, 651 F.3d 684, 694 (7th Cir. 2011). The threshold for establishing likelihood of success is relatively low. *Mich. v. U.S. Army Corps of*

Eng'rs, 667 F.3d 765, 782 (7th Cir. 2011). The moving party must only "present a claim plausible enough that (if the other preliminary injunction factors cut in their favor), the entry of a preliminary injunction would be an appropriate step." *Id.* at 783. If the moving party meets these threshold requirements, the district court "weighs the factors against one another, assessing whether the balance of harms favors the moving party or whether the harm to the nonmoving party or the public is sufficiently weighty that the injunction should be denied." *Id.* The district court's weighing of the factors is not mathematical in nature; rather, it is "more properly characterized as subjective and intuitive, one which permits district courts to weigh the competing considerations and mold appropriate relief." *Ty, Inc. v. Jones Group, Inc.*, 237 F.3d 891, 895–96 (7th Cir. 2001) (quoting Abbott Labs. v. Mead Johnson & Co., 971 F.2d 6, 12 (7th Cir. 1992)).

An injunction is an equitable remedy warranted only when the plaintiff does not have an adequate remedy at law, such as monetary damages. See *Morales v. Trans World Airlines*, 505 U.S. 374, 381 (1992); *Franklin v. Gwinnett Co. Pub. Sch.*, 503 U.S. 60 75-76 (1992)

B. Adequate Remedy At Law

Plaintiffs must show they do not have a remedy at law. *Girl Scouts of Manitou Council* v. *Girl Scouts of the United States of America, Inc.*, 549 F.3d 1079 at 1095 (7th Cir. 2008). In other words, Plaintiffs must show money damages would be inadequate compensation for the harm they have suffered if they win this lawsuit. *Id.* Plaintiff must demonstrate that: (1) absent injunctive relief, it will suffer irreparable harm in the period prior to final resolution of its claim; (2) traditional legal remedies would be inadequate; and (3) its claim has some likelihood of success on the merits. *Id.* The court also must consider the public interest in either the grant or denial of the injunctive relief. *Id.*

Plaintiffs need not show traditional legal remedies would be "wholly ineffectual," but, rather, that they would be "seriously deficient as compared to the harm suffered." *Foodcomm Int'l v. Barry*, 328 F.3d 300, 304 (7th Cir. 2003). "[S]howing irreparable harm is '[p]robably the most common method of demonstrating that there is no adequate legal remedy." *Campbell v. Miller*, 373 F.3d 834, 840 (7th Cir. 2004) (Williams, J., dissenting) (quoting 11A Charles A. Wright, Arthur R. Miller & Mary K. Kane, Federal Practice and Procedure § 2944 (2d ed. 1995)); see also *Fleet Wholesale Supply Co. v. Remington Arms Co.*, 846 F.2d 1095, 1098 (7th Cir. 1988); *Wil-Kar, Inc. v. Vill. of Germantown*, 153 F. Supp. 2d 982, 987 (E.D. Wis. 2001).

IV. Analysis

A. Likelihood of Success on the Merits

To prevail on injunctive relief, the Plaintiff must show some likelihood of success on the merits. This is a low threshold, as the Plaintiff need only demonstrate that its chances of prevailing are "better than negligible." *Roland Mach. Co.*, 749 F.2d at 387 (quoting *Omega Satellite Prods Co.* v. *City of Indianapolis*, 694 F.2d 119, 123 (7th Cir. 1982)).

The Plaintiff argues and demonstrates that the Defendants misappropriated \$657,771. Hall Affidavit ¶ 16. This number includes, \$124,192 in inventory which was misappropriated, diverted, converted, where the Cabello entities took control of the inventory that was subsequently sold for their personal gain at the expense of Her Imports. Affidavit ¶ 19. Based on this unjust enrichment by the Cabello entities, there is a high likelihood on the success of the merits of this case.

B. Irreparable Harm/Inadequate Legal Remedy

To show lack of an adequate remedy at law, the moving party must show that monetary damages would be "seriously deficient as a remedy for the harm suffered." *Roland Mach. Co.* v.

Dresser Indus., Inc., 749 F.2d 380, 386 (7th Cir. 1984). "A damages remedy may be inadequate if it comes 'too late to save the plaintiff's business or if the nature of the plaintiff's loss may make damages very difficult to calculate." Gateway E. Ry. Co. v. Terminal R.R. Ass'n of St. Louis, 35 F.3d 1134, 1140 (7th Cir. 1994) (quoting Roland Mach. Co., 749 F.2d at 386). The same principle applies in the context of irreparable harm; indeed, a business is said to suffer irreparable harm if it is forced to shut down while awaiting trial. Roland Mach. Co., 749 F.2d at 386; see also United Air Lines, Inc. v. Air Line Pilots Ass'n, No. 08-cv-4317, 2008 WL 4936847, at * 45 (N.D. Ill. Nov. 17, 2008).

To show lack of an adequate remedy at law, the moving party must show that monetary damages would be "seriously deficient as a remedy for the harm suffered." *Roland Mach. Co. v. Dresser Indus., Inc.*, 749 F.2d 380, 386 (7th Cir. 1984). "A damages remedy may be inadequate if it comes 'too late to save the plaintiff's business or if the nature of the plaintiff's loss may make damages very difficult to calculate." *Gateway E. Ry. Co. v. Terminal R.R. Ass'n of St. Louis*, 35 F.3d 1134, 1140 (7th Cir. 1994) (quoting *Roland Mach. Co.*, 749 F.2d at 386).

In this instant case, the Plaintiff has suffered a financial loss of \$657,771. Hall Affidavit ¶ 16. These funds were wrongfully taken at the expense of Plaintiff, Her Imports and its 200 shareholders. Hall Affidavit ¶ 21 and ¶ 31. The two Cabello entries are domiciled in the United Arab Emirates. Hall Affidavit ¶ 8. Based on attempted service, these entities cannot be found at the addresses identified on the corporate shareholder list or the addresses listed on their SEC filings.

Therefore, based on these circumstances, it would be extremely difficult to collect on any monetary damages awarded from entities domiciled in the United Arab Emirates, whose addresses are no longer valid. Failure to reclaim financial loss of \$657,771 would cause irreparable harm to

the Plaintiff. Therefore, based on these circumstances, if the \$657,771 could not be recovered, this would make this legal remedy inadequate.

C. Balance of Harms and Public Interest

Once a moving party has satisfied the threshold requirements for injunctive relief, a court must balance the threatened injury to the moving party with the threatened harm that the injunction may inflict on the nonmovant. *Girl Scouts of Manitou Council*, 549 F.3d at 1085.

In this instant case, the Plaintiff believes it has made a satisfactory showing of the likelihood of success, the irreparable harm this has cause the Plaintiff at that under these circumstances there is inadequate legal remedy to collect a judgment against entities with an unknown address in the United Arab Emirates. Therefore, this is now in the hands of the District Court to balance the harm the injunction would impose on the defendant against the injury the Plaintiff would suffer without the injunction. *See Vencor, Inc. v. Webb, 33 F.3d 840*, 845 (7th Cir.1994). b

V. Equitable Remedy in the Alternative of Legal Remedy

As the Seventh Circuit notes, "[a]n injunction is an equitable remedy that does not issue as a matter of course, but rather a remedy that courts may grant at their discretion in the extraordinary situations where legal remedies such as monetary damages are inadequate. *Bedrossian v. Northwestern Memorial Hosp.* 409 F.3d 840, 842 (7th Cir. 2005).

In this instant case, the Plaintiff anticipates that monetary damages will be difficult to recover from foreign entities; and, would be "seriously deficient as a remedy for the harm suffered." *Roland Mach. Co. v. Dresser Indus., Inc.*, 749 F.2d 380, 386 (7th Cir. 1984).

As stated, the Cabello entities cannot be found at the addresses identified on the Her Imports corporate shareholder list or the addresses listed on their SEC filings. Plaintiff anticipates that it would be very unlikely and extremely difficult to enforce or recover on any monetary damages awarded from entities domiciled in the United Arab Emirates, whose addresses are no longer valid. This would make this legal remedy inadequate.

Further, the Plaintiff believes that since the Cabello entities did not answer or respond to this lawsuit, it is highly unlikely that will pay any default money damages. And, it would be very difficult to enforce a U.S. Court Order in the United Arab Emirates.

The Cabello entities collectively own 6,022,696 shares of common stock of Her Imports. The last public sale of the common stock on August 25, 2021. The average price of the stock was \$0.05 per share. \$0.05 a share times 6,022,696 shares equals \$301,135, far less than the \$657,771 owed to Her Imports by the Cabello entities. Hall Affidavit ¶ 16.

Based on this extraordinary situation, in attempting to recover damages from two United Arab Emirates entities, if the Plaintiff is unable able to collect the \$657,771 from the Defendants in 45 days, in the alternative, the Plaintiff respectfully requests this Court's discretion to grant the Plaintiff injunctive relief to recover a portion of the Defendants holdings located in the United States, as an equitable remedy.

If monetary damages are not recoverable as a legal remedy from foreign entities, this would cause irreparable harm to the Plaintiff and its shareholders. Therefore, the Plaintiff respectfully requests this Court to restore its *status quo* via injunctive relief, whereby NATCO, Her Import's authorized transfer agent cancel the Defendants share ownership of Her Imports to the amount of the monies owed, which would include any and all shares issued to the Cabello entities; transfer their ownership rights and administrative control in the Cabello.divino Instagram account to Her Imports; and transfer their ownership and administrative control over in the non-functioning URL www.herimports.com to Her Imports. Hall Affidavit ¶ 28.

Separately, the Plaintiff will serve a copy of this motion for default, supplemental materials and corresponding Affidavit to the Defendants by December 14, 2022.

AFFIDAVIT IN SUPPORT OF THE DAMAGES SOUGHT

- I, BARRY HALL, state under penalty of perjury, that the foregoing is true and correct:
- 1. I am an adult over the age of eighteen (18) years and that the following is true and correct and within my personal knowledge and that I can competently testify to the statements contained herein if called to do so.
- 2. Except as otherwise expressly stated to the contrary, I have personal knowledge of the following facts and, if called as a witness to support damages sought in the above reference case, I could and would competently testify as follows:
 - 3. I am the Chairman and Chief Executive Officer of Her Imports.
- 4. Her Imports, operates a business that globally sources, markets and sells human hair as hair extensions and related haircare and beauty products.
- 5. Its predecessor, Her Imports, LLC, a private limited liability company was originally formed and operated by Patrick Johnathan William Terry (hereinafter "Mr. Terry"). Mr.

Terry is a Canadian citizen, with a residence in the United Arab Emirates, who currently resides in Mexico.

- 6. Mr. Terry began working with Her Imports in 2015. It was not until April 9, 2018 that Mr. Terry's Cabello entities took ownership in Her Imports.
- 7. On April 9, 2018, Cabello Real, FZE took ownership of 1,250,000 common shares and Her Imports and on June 20, 2018, Cabello Real acquired another 3,500,000 common shares of Her Imports. On June 28, 2018, Cabello Real, Ltd. acquired 1,272,696 common shares of Her Imports. (See Exhibit A Excerpt from Her Imports Shareholder List.)
- 8. Cabello Real, Ltd, is domiciled in the United Arab Emirates. They currently own 1,272,696 (13.5%) common shares of Her Imports and Cabello Real, FZE, domiciled in the United Arab Emirates currently owns 4,750,000 (50.3%) common shares of Her Imports. The Cabello entities also received 5,000,000 non-voting, non-cumulative, callable preferred stock.
- 9. The Defendants, Cabello Real, Ltd, and Cabello Real, FZE are United Arab Emirates corporations, therefore, the Defendants are not minors, an incompetent person or in the military service.
- 10. Based on a Form 4 SEC filing and their Schedule 13D filings, the Cabello entities are controlled and owned by Mr. Terry.
- 11. From the beginning of Her Imports, Mr. Terry, with his Cabello entities made positive contributions to help Her Imports succeed. Mr. Terry and Cabello assisted the company in the following ways:
 - Sourcing new products and negotiating with vendors;
 - Designed and oversaw various marketing campaigns;
 - Running the Company's Instagram site;
 - Coordinating the creation of content for the Company's Website and marketing campaigns; and
 - Identified new markets and locations for retail locations

12. These positive contributions started to break down, when Mr. Terry wanted to open a South American subsidiary.

13. Mr. Terry started asking the Plaintiff, Her Imports to pay bills, and pay special bonuses under the pretense that he was helping build the business for Her Imports. The requests continued to increase, and based on the past working relationship, Her Imports accommodated these requests.

14. In Her Imports original Complaint, the Company stated that \$753,772 was wrongfully taken by Mr. Patrick Terry and the Cabello entities.

15. This \$753,772 is correct starting from July 31, 2015, when Mr. Terry begin wrongfully spending corporate funds through December 21, 2019, when payments stopped.

16. The Cabello entities became owners in Her Imports starting April 9, 2018. Therefore, to reflect the wrongdoing against the Cabello entities, the damages have been adjusted to reflect their ownership period from April 9, 2018 through December 21, 2019, which amounts to \$657,771 wrongfully taken. The difference (\$753,772 minus \$657,771) of \$96,001, represents the money wrongfully taken by Mr. Terry personally from July 31, 2015 through April 9, 2018, and should not be included in the Cabello entities totals.

17. A payment breakdown of the \$657,771 taken by Cabello are categorized as follows:

a: Payment of unrelated rents: \$42,673

b. Payment of travel expenses: \$331,147

c. Employee travel expenses: \$47,330

d. Use of company credit card for personal reasons: \$63,925

e. Inventory misdirected: \$124,192

f. Shipping and freight \$19,288

g. Foreign transaction fees: \$4,580

h. Dental work: \$6,000

i. Payment made to Patrick Terry's daughter: \$5,000

j. Miscellaneous: \$13,636

- 18. I became suspicious of Mr. Terry's activities, when management learned that some inventory was missing.
- 19. I later discovered that a total of \$124,192 in inventory was misappropriated diverted, converted, where the Cabello entities took control of the inventory that was subsequently sold for their personal gain at the expense of Her Imports.
- 20. What ended my apprehensiveness, is when Her Import received an invoice for \$15,000 in excess of their normal UPS bills. This was approximately double their standard UPS billing.
- 21. From April 9, 2018 through December 21, 2019, a total of \$657,771 was wrongfully taken by the Defendants at the expense of Her Imports.
- 22. Further, Mr. Terry, under his Cabello entities took control of Her Imports website, URL (www.herimports.com) and the Cabello.divino Instagram account.
- 23. The records demonstrate that Mr. Terry directed Her Imports to pay rents, mortgage payments, travel, and other personal payments, paid directly to the Defendants' third party designees. (See Exhibit B Payments made on behalf of the Cabello entities.)
- 24. When I learned that these were non-business expenses, I immediately directed Her Imports to stop further payments.
 - 25. I confronted Mr. Terry and asked him to pay back the misdirected funds, to no avail.
- 26. On behalf of Her Imports, I am respectfully asking this Court to adjudge and decree a finding in favor of the Plaintiff for the amount of damages sustained by Her Imports as a result of the Defendants' breaches of fiduciary duties, and unjust enrichment.

- 27. The damages amount to \$657,771 in monies wrongfully taken by the Cabello entities; the URL of www.herimports (an inactive website); the Cabello.divino Instagram account; and related court costs of \$4,826.30 (filing fees, service fees and translations fees).
- 28. Since Cabello Defendants are foreign entities, it may be difficult to collect the monies owed even with a U. S. Court Order; therefore, in the alterative, if the Defendants fail to pay the damages in 45-days, I respectfully ask the Court to grant an Order, that NATCO, Her Import's authorized transfer agent cancel the Defendants share ownership of Her Imports to the amount of the monies owed, which would include any and all shares issued to the Cabello entities; transfer their ownership rights in the Cabello divino Instagram account to Her Imports; and transfer their ownership in the non-functioning website called www.herimports.com to Her Imports.
- 29. On behalf of Her Imports, we are looking for the recovery of \$657,771 or if unpaid, in the alternative, the cancellation of their stock, return of the URL and Instagram account, we are not seeking related court costs or attorney fees.
- 30. The Cabello entities collectively own 6,022,696 shares of common stock of Her Imports. The last public sale of the common stock on August 25, 2021. The average price of the stock was \$0.05 per share. \$0.05 a share times 6,022,696 shares equals \$301,135, far less than the \$657,771 owed to Her Imports by the Cabello entities.
- 31. This alternative represents an equitable method to protect the value of the Her Imports, approximately 200 shareholders, whose ownership value in Her Imports suffered due to the misappropriation of \$657,771.

- II. in the alternative, if the Defendants fail to pay the damages in 45-days, the Court orders NATCO, the Plaintiff's stock transfer agent to cancel Cabello Real, Ltd., and Cabello Real FZE share ownership of Her Imports to the amount of the monies owed, which would include any and all shares issued to the Cabello entities; transfer ownership rights and administrative control of the Cabello.divino Instagram account to Her Imports; and transfer ownership and administrative control in the non-functioning URL www.herimports.com to Her Imports.
