5 Secrets to Cheat Traffic Court If Ticketed

Have you pled guilty to any type of traffic violation recently, or in the previous 1 to 2 years?

1. Accident without proof of car insurance


If you pled guilty to this, 4 points will be assessed on your license! If you go get insurance after the stop, you will have 4 points assessed on your license unless you get a lawyer. A lawyer can prevent the points from being assessed by getting the ticket amended.

If you're in an accident and you're not at fault, but did not have insurance, your license is still in jeopardy of being suspended for not driving with insurance.



2. Driving while license suspended

If you're found guilty, your license will be revoked for a year. This is a 12 point ticket! Contact your lawyer because she **WILL** have points *reduced*.



3. Pulled over, and driving while not having car insurance

This is a 4 point ticket which is double the amount of points for failing to stop at a stop light or speeding. If you pled guilty or paid 2 tickets for driving without insurance, you have a very high risk of having your license suspended. You may not go to jail, but you will not be able to drive for a while.

Want to know a secret? Your lawyer will be able to get this amended and keep you driving.



4. Don't take the Standard Field Sobriety Tests or the Breathalyzer

People underestimate how much they drink. If you're pulled over and you're asked to do the sobriety tests which consist of the one leg stand, walk and turn, and the horizontal gaze nystagmus, simply refuse.

These tests are meant for you to fail, and if you fail the test, you are helping the prosecutor make a case against you. If you are cited for driving under the influence, make sure and call your lawyer immediately because there are strict time constraints on protecting your license. The shortest of which is 15 days.

A lawyer will help you protect your driving privilege. If you refuse the breathalyzer and you are told that your privilege to drive will be revoked for one year, contact an attorney immediately. In many situations, the one year revocation can be avoided. Call your lawyer asap if you refuse the test. Your chances are better with one rather than on your own.



5. Don't wait before it's too late ...

When it comes to traffic tickets, many people who feel wrongfully accused, wait until it is too late to do anything. Some just choose to not do anything because they simply don't know any better.

Involve a professional and experienced traffic attorney as soon as you can. Whether you have a court date in the future, or whether you have previously been found guilty of something in the past, it may not be too late.

Even if you pled guilty to a ticket in the past year or two, often an attorney can get those tickets and points removed from your license. If ticketed for driving while suspended, hire an experienced traffic attorney to help you get the 12 point violation down to 0 points. An experienced lawyer can help you get your suspended license reinstated.
