

Matthew 17:22-23 "When they came together in Galilee, he said to them, "The Son of Man is going to be delivered into the hands of men. They will kill him, and on the third day he will be raised to life." And the disciples were filled with grief. (NIV)



The disciples appear to have missed the point. Jesus has told them about His death and resurrection, but they got hung up on the bad part of His message. Of course, it could be that they were shocked and couldn't get past the image of Christ being killed. I guess if we had been in their shoes at the same time, we might have dwelled on it, too.
