Buyer must quarantine kitten/cat with no exposure to any other pets in the household. Buyer is to take the kitten to a veterinarian within 72 hours of arrival. If kitten is found to have a life-threatening issue or to be medically deficient, breeder must be notified immediately. Breeder operates a disease-free home and cattery. This kitten is in good health, free of any major disease or any hereditary malformations or other genetic defects to the best of the breeders' knowledge at the time of sale. Breeder offers money back guarantee if the breeder is notified **of a life-threatening issue** within 72 hours accompanied by a written veterinarian statement describing any life-threatening issue.

This kitten is guaranteed against Pk-def (Erythrocyte Pyruvate Kinase Deficiency) and Pra-b (Progressive Retinal Atrophy). This kitten is guaranteed from HCM (Hypertrophic Cardiomyopathy) for 3 years from date of birth. If the kitten/cat passes within that time from HCM, a necropsy must be performed and a written veterinarian statement stating cause of death was related to HCM must be submitted to breeder and a replacement kitten of equal or lesser value will be given when there is one available. NO REFUNDS WILL BE ISSUED.

We do not guarantee against pyometra (nongenetic infection of the uterus) or feline herpesvirus. This kitten is in good health at the time of sale, and embodies the characteristics of the Bengal breed. A valid Florida Health Certificate will be provided. This kitten is purebred and is registerable with a limited registration with TICA(not for show/not for breeding).

All of our Bengals are vaccinated and negative for Feline Panluekopenia, Feline Viral Rhinotracheitis, Feline Calicirvirus, rabies, treated with Drontal for worms; and given preventative monthly for fleas, ticks, and earmites. Kittens are taken to the vet at 8 and 12 weeks old for their first set of shots, worming, and exam and a veterinary visit and shot record will be provided to buyer. Under

normal circumstances, kittens are released to go to their new homes at 12-14 weeks old so vet visits for remaining kitten vaccinations must be scheduled by buyer accordingly.

Buyer agrees to have kitten seen by a vet within 72 hours of pickup and then for its next set of vaccinations and worming within 3 to 4 weeks of prior set and then all future exams and vaccinations as recommended by veterinarian and to give kitten preventative for fleas, ticks, and ear mites. The breeder has done everything possible to produce healthy sound kittens and to raise the kittens in the best way possible in regard to diet, exercise, socialization and veterinary care. There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc. The buyer assumes the responsibility to carry on with the appropriate vaccinations, vet exams, exercise and feeding schedule, as supplied by the breeder.

If this cat/kitten is purchased as a Pet, Purchaser is to spay/neuter this kitten by the time the kitten reaches 6 months of age. Seller will give Purchaser said kitten's TICA paperwork when Purchaser provides proof of spay/neuter from a licensed veterinarian. Failure to provide proof of spay/neuter will result in the forfeiture of registration papers and buyer will pay seller the difference between purchase prices and \$3,000 US. Under no circumstances will this kitten/cat ever be sold or given away to wholesaler/s, retailer/s, be donated for a raffle, abandoned or be placed in any shelter or refuge type facility. If purchaser becomes unable to keep this kitten/cat FOR ANY REASON buyer agrees to return said kitten/cat to breeder at buyer's expense to be placed in a selective home. There will be NO cash refunds upon return. Kitten/Cat may NOT be resold unless written permission is given. This kitten/cat shall NOT be allowed to roam outdoors freely at any time. No kittens/cats from MR Bengals may be sold, placed, leased, loaned, traded, co-owned or given away to another breeder or person unless written permission is received by the seller.

The cat/kitten cannot leave the buyers possession until they are spayed or neutered. If buyer at any given time decides to sell this cat/kitten MR Bengals will be given first opportunity to buy the said cat/kitten back at ½ the purchase price. Buyer must spay/neuter before placing cat with anyone else. Buyer agrees to provide immediate veterinary attention to the kitten/cat upon any signs of illness or distress. Breeder will not pay any veterinary bills unless agreed to in advance and in writing. If this cat/kitten is found to be neglected or mistreated the buyer will surrender this cat/kitten to seller unconditionally. No refund of purchase price will be given. Buyer agrees that if there should be legal action in regards to this cat/kitten, the buyer will be responsible for all legal fees, including seller's attorney cost, interest and cost of action. All legal action must be held in the seller's current city and state.

Contract may be subject to change without notification and will go off current contract used by breeder. By giving us form of payment for purchase of cat/kitten(s) you have accepted terms of our contract. All kitten/cat sales through breeder are covered by the terms of contract regardless of signature/s. Agreement may be verbal, electronic or written as to include out of state buyers. It is the buyer's responsibility to review terms of this contract.

Breeder has no immediate plans to discontinue breeding Bengals but guarantees are only valid as long as kittens are still being produced. Buyer is responsible for checking local and state hybrid laws regarding the legality of the hybrid breed. Breeder is not responsible for any legal fees or fines acquired once a

hybrid is purchased by buyer. If this contract is breached for any reason the buyer is required to return cat/kitten to breeder immediately at buyer's expense. Seller is also able to bring legal action against buyer if any part of this contract is breeched in the amount of \$3,000.00 per infraction. The seller neither makes nor implies any warranties or guarantees, express or implied, other than those written in the agreement including, without limitation, the warranties of merchantability and fitness. This document constitutes the entire agreement between the seller and buyer with respect to this sale.

The buyers signature below indicates that he/she has read, agrees and does understands all the conditions of the Sales Agreement and Contract of Sale. This contract shall be deemed a legal binding document between the two parties (buyer and seller) regardless of signature once kitten is purchased and all rights and guarantees are NOT transferable. Buyer is also aware that all proceedings, including disputes, with seller are to remain between breeder and buyer.
