HOLY COMMUNION LUTHERAN CHURCH ~ July 21, 2024, COUNCIL MINUTES

Present: Colleen Cloninger, Jerry Peeler, Reid Simms, Roxanna Britton, Harold George Clemmer Jr., Alan Cloninger, Jeff Clemmer, Greg Carter, Jamie white, Brittany Peeler (secretary).

Jeff Clemmer opened the meeting. Greg Carter conducted opening prayer.

Jeff Clemmer asked for an approval of minutes and the financial reports for June 2024. Alan Cloninger motion approve everything Jerry Peeler seconded. No opposed.

Old Business:

Cemetery Update: Jeff Clemmer said that the cemetery survey report is going to Harold George Jr. It will be a very indepth survey. We will know where everything is. I.e. water lines etc.

LED Sign Maintenance: McLamb came to fix the sign and completed an update. Around 530 -6pm people reported that the sign was too dim and/or off. Church needs to make sure the sign is on the summertime setting. The sign is also currently reading that the fellowship hall is for rent.

Security System Update: No updates (Still researching).

TNZ Painting: Tony Story is Supposed to come back to finish painting, but Jeff told him not to come back until the roof is fixed. The roof is still leaking.

Contact Cards: Jeff's wife is having cards printed. Cards will be completed and ready to start giving them out soon.

Membership Lists: Discussion on sending a letter. Jeff is has not sent out tithing letters and is continuing to work on this as well as membership lists.

Women's Group: Beth will have women's group meeting sometime soon. Date still TBD.

Song selection: It was reported that the bulletin is working, and they are getting selections.

LCMC Discussion: Jeff to call for them to come out and discuss with the council and congregation about their organization. Jeff has put this on hold temporarily until we get the organist hired and church time changes.

Tithing Letter: Jeff still composing tithing and membership letter.

Roof: Roofs are still leaking. Jeff Clemmer, Alan Cloninger, and Greg Carter continue to work with vendors on getting this fixed. Tim Watts has been contacted and will be coming out to look at it and fix it. The church has not made final payment since it is still leaking.

New business:

Discussion on the resume received for organist. 1 person submitted resume – Katherine Kast

Alan Cloninger made a motion to hire her if she accepts the offer that the council has agreed upon. Colleen Cloninger seconded and there were no opposed. Discussion then opened on rate of pay. Further discussion on other offers. Final Motion: Alan Cloninger made motion to hire and authorize Jeff Clemmer to negotiate paying Kathryn 200 to 275 which includes travel. Reid Simms seconded and no opposed.

Worship Service Time Change Discussion: Jeff Clemmer suggested that the church have a congregational meeting and let the majority decide on a new worship time. The Council to suggest times to choose from. Straw vote from Council: majority-10:30am. Harold George Clemmer Jr. made a motion to have it at 10:30. Colleen seconded and 1 opposed.

Fellowship Hall discussion: Lutheran family services will use the fellowship hall. Previously, there has been no charge. Discussion: Does the Council agree to conitinue with allowing them to use the fellowship hall at no charge? Alan Cloninger made motion continue with tradition. No opposed.

Sunday School Discussion: Pastor Seaford to teach Sunday school for adults. Alan Cloninger made motion to wait on Sunday school and table conversation. Greg Carter seconded and there were no opposed.

Fellowship Hall Requested: Fellowship Hall has been requested by Amy Holland to host the next clothes drive: Sept. 13th, Sept. 14th, Sept. 15th. Alan Cloninger made a motion to approve. Greg Carter seconded and no opposed.

Air conditioning/Ice Machine Repair: The air conditioner near the cemetery needs to be repaired Randy ward has been contacted to repair it. The window unit in the ice room is also broken. Jeff Clemmer to purchase one for \$575. The Ice machine is also broken and needs repair. Randy can do the repair, Quote for a new top and fee for 3k. Alan Cloninger made motion that we pay to fix top of icemaker, and the Withers brothers get and install a new ac, and we authorize Jeff Clemmer to get the big ac fixed as long as it does not cost more than 2k. Greg Carter seconded and no opposed. Alan Cloninger volunteers to cover cost of window unit with Jeff Clemmer.

Camera Equipment: A joystick controller for PTZ camera is needed for livestreaming the worship service. Two estimates have been received from Rushing Winds - \$975 and 1,225. Carolyn Huggins Grandchildren have offered to cover the cost with her memorial fund in the amount of 1,055.00. Alan Cloninger made a motion to use the memorial fund to cover the cost of the joystick controller and Greg Carter seconded. No opposed.

Social Media Discussion: Greg Carter to reach out to Lauren Falls about social media presence. HCLC needs to be active on YouTube, Instagram and Facebook.

Homecoming Discussion: Selina asked for homecoming dates - Alan Cloninger made a motion for Oct 26th, 2024 – Greg Carter seconded and no opposed.

Landmasters Lawn care to begin trimming bushes around the church.

Discussion on CD: CD of \$100,000.00 reached maturity July 20th, 2024. Current rate is 4.75 with an accrued interest of \$2,745.89 as of July 18th. A Rate of 4.50 is currently being offered if this is rolled over for another 7months. Council is rolling it over unless there is an objection. No objection.

School Supply Donations: School supplies donation for-\$179.67 for this year will be given to Carr school. Taking more donations – motion needed to spend school supplies money to buy supplies for Carr school. Alan Cloninger made motion to spend \$125. Greg Carter seconded and no opposed.

National Night Out Discussion: Tabled.

Alter Flowers Discussion - discussion on if church invests in artificial flowers to save money on Alter Flowers every Sunday. Church to continue to pay for real flowers.

Request for New mop bucket and squeegee to be purchased. Harold George Clemmer Jr to purchase.

Need to schedule Dellinger's extermination – discussion.

Reformation Sunday on Oct. 26th to be "homecoming".

Cleaning Crew- Jeff Clemmer to review cleaning company contract to find out what they are cleaning. Jeff Clemmer has found some places that have not been cleaned.

Amy Lewis - Jeff Clemmer discussed Amy and said she has been loyal and good to the church. He reported that she knows that the church is hiring someone. Council to discuss final date of her contract. Council voted to provide love offering. Greg Carter in charge of getting love offering together.

Clean up date for church - Graveyard clean up and inside clean up - Sept 7th. 2024 – Jeff Clemmer to send list of cleaning supplies needed for Alan Cloninger to get.

Worship and music committee - Deanna to help and get music going. Continue to work on getting song selection requests.

Current Insurance on parsonage: Insurance is asking that we increase our coverage. Jeff Clemmer to sit down with Insurance company and bring information back to next meeting for Council to discuss numbers and what is covered.

Open Floor Discussion:

Jeff Clemmer talked to Miss Peache this week. She's a lifelong member. He encouraged Council to make visits and call church members. Reid Simms talked to Leon and Nancy. Further discussion on who Council has talked to and visited.

Meeting closed in prayer.




