HOLY COMMUNION LUTHERAN CHURCH ~ JANUARY 2025, COUNCIL MINUTES

Present: Alan Cloninger, Jeff Clemmer, Harold George Clemmer Jr., Jamie White, Brittany Peeler, Greg Carter, Reid Simms, Pastor Seaford, Katherine Kast.

Opening of Meeting "Opening Prayer" – Pastor Seaford.

Approval of Agenda – Motion Alan Cloninger, 2nd Harold George Clemmer Jr. – No opposed.

Approval of Minutes for December 2024 Council Meeting -Motion Jamie White, 2nd Alan Cloninger– No opposed.

Approval of Financial Reports– Motion Harold George Clemmer Jr., 2nd Alan Cloninger – No opposed.

OLD BUSINESS

- Bids on kitchen are being accepted. **UPDATE:** Jeff Clemmer received a bid from TNZ Tony Story. The bid is for \$12,500 with a 50% deposit. This quote does not include the floor. New American bid includes granite counter tops. Council discussed differences between 2 bids. Discussion Tabled.
- Discussion Sunday School class for adults. **UPDATE:** Sunday school is averaging between 5-6 people. Discussion on putting the Sunday school information on the sign. Discussion Tabled.
- Postcard's reminding members of the new time and upcoming plans for Sunday School. **UPDATE:** Cards were mailed to all members.
- The community meal fund is showing a negative amount of -\$721.28. **UPDATE:** \$3000.00 donation received was deposited into this account. Discussed
- Poinsettias for Christmas. It was decided instead of placing poinsettias in the church for Christmas, to use money donations for the repairs of the church. **UPDATE:** Donations were made in the amount of \$1,475.00 Discussed
- Discuss cleaning service. **UPDATE:** Jeff Clemmer met with Kris Kiser of Gaston Janitorial. Will continue using services in 2025. In February they will wax the floors for \$325.
- Looking ahead-the wood is rotten around the door near the choir area in the Sanctuary and will need to be repaired. **UPDATE:** Thomas Windows completed repairs. The church was not billed but gave a donation letter for repairs. Church to send a thank you note in the bulletin/newsletter.
- The bushes in front of the church will be cut down to the level of the windows. This will be done in cooler weather. **UPDATE:** Waiting until Spring to complete. To do this now would kill the bushes. Discussed
- Voting is planned for Tuesday, November 5, 2024, in the fellowship hall. **UPDATE:** Received payment of \$400.00 for us of fellowship hall on January 14, 2025. Discussed.
- Capital Improvement account current balance as of 01/15/2024, \$5,607.47. Discussed.
- Need to vote on new Ice maker in the amount of \$3400.00 installed. **UPDATE:** Council Discussed. Still Pending.

NEW BUSINESS

• Discuss Ash Wednesday Service, March 5, 2025. Lent Services. – Discussed: Previously HCLC met with other churches to have a study group every Wednesday. Discussion on if we will combine with another church. Pastor Seaford is unable to work Ash Wednesday. Roxanna Britton has the palms for the ashes. Discussion on who could do Ash Wednesday. Action Plan – Seaford to cover Palm Sunday and Easter.

Shrove Tuesday Pancake Dinner discussion. Harold George Clemmer Jr. and Greg Carter to do the dinner. Discussion on having a service before Good Friday. Jeff Clemmer to reach out to Our Savior to discuss partnering. Ash Wednesday – Alan Cloninger to do ashes at 12pm and then Jamie White will do them Wednesday night if Gene Armstrong is unable.

- A plumber will be coming to install a deep sink for the kitchen. Discussion.
- Letter to inactive members. -Discussion.
- Deacon list for 2025. Discussion. Jeff Clemmer to be Deacon next month (Feb.), Reid Simms (March), Jamie White (April), Alan Cloninger (May), next meeting council will finish deacon list.
- Amy Holland requesting use of fellowship hall on January 11, 2025, for a clothes drive. Would like to use the fellowship hall January 9, 10, for setup dates as well. **UPDATE:** Due to inclement weather, the clothes drive will be held on January 18, 2025. – Discussion.
- Received \$3000.00 check from Dallas High Shoals Christian Ministries. Discussion on where the funds should be placed. **UPDATE:** Funds were deposited into the Community Meals account. – Discussion.
- Election of new church council officers for 2025. UPDATE: All council members who were to rotate off in 2024, have agreed to continue to serve another year. – Discussion.
- Fellowship Hall ceiling needs to be painted; broken tiles need replacing. The amount given by Tony Story is \$4500.00. He will also give a bid on kitchen updates. **UPDATE:** Pending. Discussed.
- Christmas Eve Candlelight Service will be at 7:00 p.m. on Christmas Eve. Alan Cloninger will lead the service. The reading of the Christmas Story and Christmas Carols, no communion. **UPDATE:** Christmas Eve was a success! - Discussion.
- Christmas Eve Invitations were printed and purchased by Alan Cloninger. Will be mailed to all members. Requesting all families take cards to give to family and friends. UPDATE: Invitations were mailed to members as well as members taking them to give to family and friends. – Discussed.
- ELCA: Discuss going forward with leaving the ELCA. - Discussion on increasing membership.
- Katherine asked for guidance regarding the Church's vision for worship and bringing in people to sing. Alan Cloninger to reach out to Beth Rhyne and see if any of the students she has would want to sing.
- Alan Cloninger made a motion to hire Tony Story to begin renovations. Harold George Clemmer Jr., 2nd. No opposed. Tony Story to also install handrails.


