# Preventing misconfigurations from happening ever again

In the heart of a transformative period, Save the Children, a global entity operating across 65 countries, faced significant IT and administrative challenges. With a sprawling Microsoft-connected IT infrastructure serving a vast network of 25,000 individuals, the organization encountered a critical issue: a simple misconfiguration by an employee altered a local email setting globally, inadvertently disrupting email access for 20,000 users!

This incident underscored the complexities and risks inherent in managing a global IT system and highlighted the urgent need for a more refined, secure, and efficient management solution.

# The challenge: Managing complexity across 65+ borders

Save the Children's global IT team faced the daunting task of overseeing and securing administrative rights across diverse regions, each with its unique IT setup. Operating in over 65 countries with 30 distinctive IT teams and 19 of them using the same Microsoft 365 tenant, the administrative situation is quite complex. The critical need to empower local administrators with the ability to perform routine tasks, such as Multi-Factor Authentication (MFA) resets, without granting overly broad global admin rights, presented a significant operational hurdle.

### The solution: CoreView

Introduced by Microsoft, CoreView emerged as the solution for Save the Children's complex challenges. Initially sought for its role-based action controls and virtual tenant segmentation capabilities, CoreView quickly demonstrated its value far beyond initial expectations, particularly in license management.

#### Robust security through granular access controls

By using CoreView's virtual tenant technology and fine-grained role-based access controls, Save the Children was able to implement a strong security system. This setup enabled helpdesk employees and local administrators to perform specific administrative tasks safely, without exposing sensitive operations or data to undue risk.



#### Enhanced license management and operational efficiency

CoreView helped Save the Children to manage users and licenses better for each country's needs. This way, they could see how licenses were used and allocated well and **make the licensing process easier and faster.** The reports and dashboards showed important information about license usage, accounts, permissions, and security, improving organizational performance.
