

AGREE IN A POST COVID WORLD?

Will we ever agree in a post COVID world? Great question ... and one that I believe is on the minds of so many of us who have strained relationships with friends, and family members, or are frustrated trying to sway the other side to their way of thinking.

My advice: LET IT GO!

The hard right and the hard left will never agree. Should we even want them to? That would leave us with a single party system of government that history has shown is unsustainable. The American system of government was designed for disagreement and disparities. Our Forefathers honed the dissent of many voices into a functioning and workable government. All grounded in the disagreement of democracy.

One could argue that American leaders today, 244 years into the Great Experiment, could be expected to be steadfast in upholding our Constitution: protecting free and fair elections, a free press, and to represent the American people through a representative government. We learned the hard way, through the government response to COVID, that the Shining City on a Hill may need some renovation.

None of the response, sadly, involved We The People. State legislatures have been shut down, the unelected bureaucrat imposing 'one size fits all' rules and mandating regulations that resulted in business closure, school closure, with outcomes and ancillary damage we have only begun to quantify. None of the responses tapped into the self-reliance and common sense that has seen Americans through WAY WORSE without being micromanaged every step of the way. None of the responses allowed for debate.

The propagandized, unrelenting media narrative of 'one size fits all' throughout the COVID response was, largely, willingly accepted by 330 million Americans. We gave up our right to debate when we allowed an unelected bureaucrat to run roughshod over our lives. Accepting 'the pandemic according to Fauci' didn't leave anyone room to gracefully reconsider other options. It prevented politicians, bureaucrats, and your neighbor from changing course without having to admit defeat or even reconsider based on new incoming data. They put more emphasis on not being wrong than on being right.

We The People were left to take sides, as if picking an absolute was a self-righteous rite of passage to affirm our political affiliation: you were either Karen or Kanye. But then the virus changed, and the rules didn't, the messaging proved manipulated, and the data didn't add up, the resolute can begin to reconsider.

A new space has opened up where the 'one size' approach doesn't fit anymore. Just like that, the many variants of 'compromised', 'vaccinated', 'essential worker' broke up the far left and far right into many subtle variations of response and versions of 'stay safe'. We're starting to see that rigidity and resoluteness fade away. Allow your adversary the space to save face, change their mind, and LET IT GO!

UPDATE ON BRANDON STRAKA

Several months ago, we were fortunate to have Brandon Straka as a guest for a WVRWF Event. Many of you have enquired as to the results of his battle stemming from the charges against him from January 6th.

- Brandon Straka was sentenced in federal court after a yearlong legal nightmare stemming from U.S. Government charges against him for being on Capitol Grounds on January 6th.
- Brandon DID NOT enter the US Capitol Building.
- He DID NOT witness or participate in any acts of violence, vandalism, theft, or destruction nor was he charged with such crimes.
- Brandon has consistently denounced the violence and destruction of January 6th.
- Brandon was sentenced to three months home confinement, 3-years of probation, 60-hours of community service, the maximum fine of \$5000, and \$500 restitution (though it was acknowledged by the court that he did not actually cause any damage). Sentencing took place AFTER a year of pre-trial court supervision and two days in jail under 24-hour lockdown. The government also asked the court for the ability to monitor Straka's computers, phones, emails, social media, and bank accounts for three years, but the court denied their request.
- Brandon was present on the east side Capitol steps (opposite the west side where the violence synonymous with that day occurred) for EIGHT MINUTES filming the scene he witnessed: a large group of people attempting to make their way toward two large metal doors, which were wide open. The crowd Straka witnessed was not "rioting" or engaging in any destruction, as had happened earlier on the opposite side of the Capitol Building.
- On January 25th, 2021, the FBI raided Brandon Straka's home and presented him with a warrant for his arrest and to search and seize his property. He was taken to jail in handcuffs and spent two days in 24-hour lockdown inside a small concrete cell. When released, he learned the government had charged him with two felony charges and one misdemeanor charge. This began a yearlong nightmare of relentless, endless harassment and abuse from the federal government, media, and Big Tech.
- Brandon is now placed on a TSA terrorism list which results in hours of invasive and intimidating screening every time he travels.
- He was evicted from his apartment following his release from jail due to media coverage labeling him as an "insurrectionist" guilty of "killing people" at a "MAGA riot."
- Immediately after his arrest, Brandon was permanently banned by numerous companies including PayPal, Venmo, Stripe, Patreon, MailChimp, Constant Contact, Anedot, Classy, and more.
- The government has repeatedly tried to find a conspiracy related to January 6th and conducted numerous interviews with Brandon, attempting to find links between the violence that day, White House insiders, and the Trump Administration. Brandon has consistently denied that any such conspiracy exists.

After living through this harrowing and crushing experience, Brandon is ready to come forward and tell his story. The world needs to understand what is being done to January 6th defendants who have, at worst, committed petty crimes. All people charged are being treated as dangerous, violent terrorists and their lives are being torn apart. Brandon has personally experienced this.

"I have consistently condemned all violence and destruction that took place on January 6th as well as ALL political violence. But hundreds of people with nonviolent, petty charges have been dragged through hell for the purposes of creating political theater. I am now ready to come forward and will be available for interviews to share my firsthand account of the atrocities being committed against good people who had the misfortune of being present on January 6th, 2021, without any intentional criminal wrongdoing."
