## Trump, RNC Raise \$125 Million in Third Quarter



**Campaign saw \$8.5 million cash infusion from small donors in 48 hours after impeachment inquiry announcement.**

President Trump and the Republican National Committee together raised \$125 million in the past three months, the re-election campaign said, continuing its upward fundraising trajectory this year.

Mr. Trump and the RNC had reported raising \$105 million in the second quarter and about \$76 million in the first three months of the year. Campaign manager Brad Parscale said Tuesday on Twitter that the re-election effort began this month with

\$156 million in the bank. The campaign said it saw an \$8.5 million cash infusion from small donors in the 48 hours after House Speaker Nancy Pelosi announced a formal impeachment inquiry of President Trump. Eric Trump, one of the president's sons, tweeted last week, "A BIG thank you to @SpeakerPelosi and the Democrats...People are sick of your nonsense but please keep it up—you are handing @realDonaldTrump the win in 2020!"

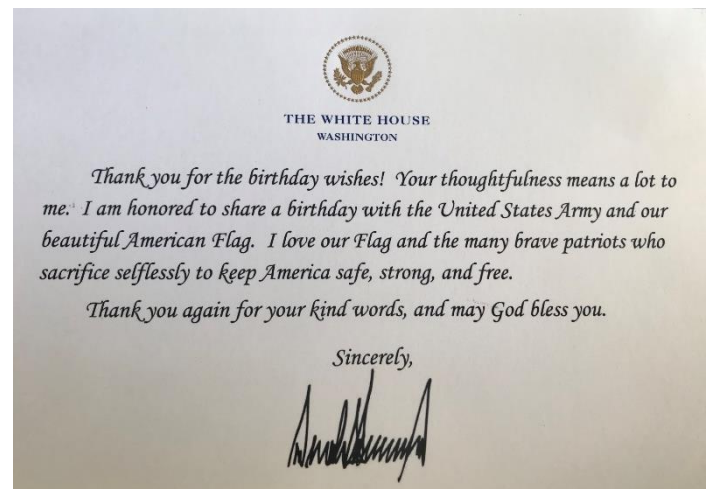

The president’s partnership with the Republican Party means he can solicit checks of more than \$360,000 from each donor, far exceeding the \$2,800 each Democratic candidate can ask of donors for that party’s primary election.

Four of the 19 Democratic contenders announced their third-quarter fundraising hauls on Tuesday. Taken together, they raised \$62 million in the most recent three months. Two of the strongest Democratic fundraisers, former Vice President Joe Biden and Massachusetts Sen. Elizabeth Warren, haven't yet said what they raised. The eventual Democratic nominee can join with the Democratic National Committee just as Mr. Trump has with the RNC and accept six-figure donations from each donor.

## Laws of Potential Consequence Passed in 2019

(As of 9/17/19)

EIPCa position on the bills: Unsure, neutral, fair (but does not go far enough), good, suspicious, harmful, UNCONSTITUTIONAL, commentary.

\*EIPCa position letter was written and filed with legislative committees

\*AB 17—Salas §§14002, 14000, 14001, 14004, 18503  
No employer can require employee to bring ballot to work or submit ballot to someone at work or do anything discourage a voter from voting.  
No protection for other vulnerable populations

AB 57—Low §13211.7

Requires candidate names to be phonetically transliterated on ballots written in character-based languages (unless candidate identifies with the character-based name.

AB 299—Salas §3019.5

Improves system a voter can use to track VBM; mandates that County must communicate all updates of ballot status to SOS so they have the latest information. More transparency for VBM voters. CAUTION: only helpful if voters know about this; provides after-the-fact concerning info—doesn't protect votes.

AB 334—Oberholte §7441

Standard OP for Republican Central Committees

AB 504—Berman §§2220, 2221, 2222m 2224, 2225, 2226, 2227

Tweaks residency confirmation process.

AB 566—Berman §15305

Requires ROVs, on the 2<sup>nd</sup> day after an election, to report to the SOS the total number of unprocessed ballots. Also requires same stats to be reported daily on any day ballots are processed after that. Could put undue pressure on ROVs to hurry up rather than taking precautions to process envelope ballots with integrity.

\*AB 679—Gonzalez §2028

Allows registration at business address if person lives there while having a family fixed at another residential domicile.

Makes voter roll cleaning of those registered at illegal addresses almost impossible

\*AB 693—Berman §2170

Allows non-provisional ballot to be cast by a same-day registrant if status is verified by VoteCal on the spot. Open admission that the state does not and will not follow NVRA Section mandate to verify applicants' eligibility (citizenship, age, residence) before placing them on voter rolls

AB 698—Oberholte §9030

Requires acceptance of signature variation on petitions. Initials for first and middle name will be accepted. More legitimate determination of will of people

\*AB 1036—Aguiar-Curry §§2105, 2131

Mandates extensive “civic outreach and voter engagement” pilot program in Yolo High Schools (pre-registration programs, mock elections). Requires all counties to design and implement programs to identify unregistered electors and register them.

Any county not in compliance will be reported to AG, and the SOS will design and require implementation of such program for the county. Sets up SOS authority to provide grants (HAVA money) to entities in “underperforming” counties (72% registration or less) to conduct voter outreach programs, increase accessibility for disability population, to effectuate targeted emphasis on secondary schools.

Expenditure of public funds that will likely be used for partisan activity targets vulnerable population. Borders on citizen harassment; fails to acknowledge freedom NOT to participate, removes local control—nanny state

AB 1044—Irwin §2188.2, 12172.5 of Government Code

Allows SOS to require applicants for voter rolls to take a prescribed training on data security before receiving rolls.

May protect sanctity of voter rolls.

CAUTION: could be used to delay access of eligible organizations and people

AB 1829—Berman §1000

Establishes election days as: first Tuesday after first Monday of March EVERY year; second Tuesday of April in even-numbered years; the first Tuesday after the first Monday in November EVERY year.

Establish acceptability of signature variations on nomination petitions. Tweaks the way initiative

petitions are qualified, and when special elections are held. ???

SB 27—McGuire adds Chapter 7 (commencing 6880) to Part 1 of Division 6 of EC

Requires presidential candidate to file 5 years of tax returns with the SOS in order to appear on the Primary ballot. Purports to amend US Constitutional requirements for presidential candidates; Clear intention is VOTER SUPPRESSION

SB 151—Umberg §11320 (enrolled)

Allows for party preference of candidate for recall to appear on ballot. Requires partisan voter information guide to be mailed no later than 10 days before Election Day. Requires mailing of sample ballot no later than 21 days before Election Day.

Ballots mailed and early voting begins 29 days before Election Day yet we don't receive voter information until much later--illogical

SB 212—Allen (enrolled) amend Sections 5013, 5020, 5027, and 5028 of, and to add Sections 1018, 1019, 1020, 5010, 5032, and 5096 to, the Education Code, to amend Section 8141 of, to add Section 8141.3 to, and to add Division 22 (commencing with Section 24000) to, the Elections Code, to amend Sections 25040 and 25061 of, to add Section 25001 to, and to add Article 4 (commencing with Section 34910) to Chapter 4 of Part 1 of Division 2 of Title 4 of, the Government Code, relating to elections. Allows school boards to be elected using rank choice voting.

Election results can seem very unfair to voters: candidate receiving most votes may not be the winner

SB 505—Umberg §6000.1

Creates check list of standards for a presidential candidate to meet in order to appear on the ballot. Purports to amend US Constitutional requirements for presidential candidates; Clear intention is saving money and not littering ballot with candidates with no chance to win, but every eligible citizen has a right to seek office without further state requirements.

# Laws of Potential Consequence Expected to Pass

(As of 9/17/19)

AB 59—Kalra (on the way to governor’s desk) §§4005, 12283. Tweaks Voter’s Choice Act language to encourage use of university campuses for Vote Centers.

AB 681—Gonzalez (on the way to the governor’s desk) §§2152, 3203, 3205, 4100, 13102, 13502, 18402, 2119.5, 12100, 13503, repeal 3000

Urgency bill—makes it easier for voter to change registration on the spot—extension of CVR Complex. Change of registration by written request rather than affidavit of registration.

Voters will not understand but facilitates careless vote processing by confused elections officials (We filed an opposition letter, but the iteration of the bill at that time was entirely different than the bill now read, so the letter is irrelevant.)

AB 730—Berman (on the way to governor’s desk) amend, repeal, add section 35 of Code of Civil Procedure; amend, add, repeal EC §20010.

No person, committee or entity can release, with actual malice, intentionally deceptive audio or visual media (exception—if there is a visible disclaimer) [green with reservations]

\*AB 787--Gipson (Passed Senate Appropriations Committee) Article 3.6, section 2149 added; 2222 repealed; 2212 added.

Allows for voter registration and pre-registration drives to be held in jails and juvenile facilities.

Victimizes another vulnerable population.

Inmates will have no privacy to make their choices without fear of intimidation or reprisal. Sets up no safeguards that these voters can mark their ballot in privacy without fear of intimidation or reprisal

AB 963-Petrie-Norris (on the way to the governor’s desk) Chapter 10.5 (commencing Section 66850) to Part 40 of Division 5 of Title 3 of Education Code, and add §2148.5 to Election Codes.

Student Civic and Voter Empowerment Act. Partnership between SOS and CA Community Colleges, CSU and UC system to establish and conduct a Student Civic and Voter Empowerment Program

- Campus-wide emails during first session of academic year

- National Voter Registration Day, 4<sup>th</sup> Tuesday in September
- Last day to register
- First day of early voting and where
- Dates of primary and general
- link to SOS Students Vote Project

- Again one month before each statewide election

- disclaimer for specific information

- Printed and electronic academic calendars with key election dates

Given the current campus environments, this is guaranteed to be highly partisan and could turn incredibly ugly. Huge expenditure of money and borders on citizen harassment; fails to acknowledge freedom NOT to participate; could facilitate non-citizen registration and voting and jeopardize student funding status

AB 1707—Berman (on way to governor’s desk) §2302 Handheld devices in polling places OK

Pandora’s box?

AB 1784—Santiago (Senate Elections Committee) Chapter 6 (commencing with Section 19500) is added to Division 19 of the Elections Code Secure the VOTE



Act. Open-source Paper Ballot Voting System Program.  
???

AB 49—Cervantes (on governor’s desk) §3001  
CA Voter Protection Act of 2019. ALL VBM ballots must be mailed between 29 and 25 days before Election Day. If voters can be educated to watch for their ballot, there may be more protection for voters whose VBM ballot is somehow waylaid on the way to them. CAUTION: Typically, the bill has no “what if” clause—no teeth.

\*SB 72--Umberg (passed Senate and Assembly) §2170  
CVR at ALL polling places.  
Puts undertrained and under-supervised poll workers in a position to do great harm by making errors and allowing non-provisional ballots to be cast by ineligible voters.

\*SB 288--Wiener (Passed Assembly Elections Committee) §§7231, 7217, 7231, 7785,7800  
Allows non-citizens to be elected to Central Committees of Democrat and Peace and Freedom Parties. Un-American—facilitates TRUE foreign interference

\*SB 523--McGuire/Gonzalez (on governor’ desk) §2194  
Extends curing to 2 days before.  
Contains this statement: *(f) Notwithstanding any other law, information regarding voters who did not sign a vote by mail ballot identification envelope or whose signature on the vote by mail ballot identification envelope did not match the voter’s signature on file shall be treated as*

*confidential voter registration information pursuant to this section and Section 6254.4 of the Government Code. This information shall not be disclosed to any person except as provided in this section. Any disclosure of this information shall be accompanied by a notice to the recipient regarding Sections 18109 and 18540. Voter information provided pursuant to this subdivision shall be updated daily, include the name of the vote and be provided in a searchable electronic format.*

Is this a problem with our current or any future Inquiries?

\*SB 636--Stern (Assembly Elections Committee) §§303, 9050, 9051, 13282,  
Ballot Label just include condensed version (75 words) of ballot title and summary, including fiscal impact summary, followed by a list of names of the signers of the ballot arguments printed in the state voter information guide in support of and opposed to the measure.

Redundant—voters have this information in the voter guide. Will substantially lengthen the ballot, requiring a 3- or perhaps 4-card ballot. More potential for poll worker error. Encourages extended time in voting booth, ergo longer wait time to vote in person. May impact down-ballot races, as voters get impatient or fatigued or rushed and fail to vote all the way through the ballot.

SB. 696—Umberg (headed to governor’s desk--Urgency) §5001, 5201  
All parties with the word “independent” in their name must change their name to avoid voter confusion

# Caring for America

On August 8, 2019, members of the Westlake Village Republican Women, Federated gathered together at B.J.'s Restaurant in Westlake Village to support children in the Ventura County foster care system in collaboration with James Storehouse, a nonprofit organization located in Newbury Park. The WVRWF was able to assist numerous foster children as they embark on a new school year.

Jessi Bierling, a representative from James Storehouse, was present to explain how their organization (which derived its name from the Bible verse James 1:27) assists children from "cribs to college." There are currently 1,200 children in foster care in Ventura County. In 2018, James Storehouse provided emergency resources for 3,962 foster children throughout the Ventura and Los Angeles counties.

Jessi stated that many of the youth in the foster care system have never owned a new pair of shoes, and at this time of year it is their greatest need. Through the generosity of our members, WVRWF collected 65 pairs of brand-new shoes! Additionally, we collected \$740 in cash contributions which was donated to James Storehouse for the purchase of more shoes.

A huge thank you is extended to B.J.'s Restaurant for providing food for the evening. Sometimes it really does take a village... in this case, Westlake Village! With your kindness, the foster kids of Ventura County will be putting their best foot forward this school year!

## TO WIN THE WAR, WE MUST FIRST KNOW OUR ENEMY

Republican clubs, throughout the country, must be willing to fight like hell, "to keep, if we can, the Republic," from tyranny, per Benjamin Franklin, in 1787.

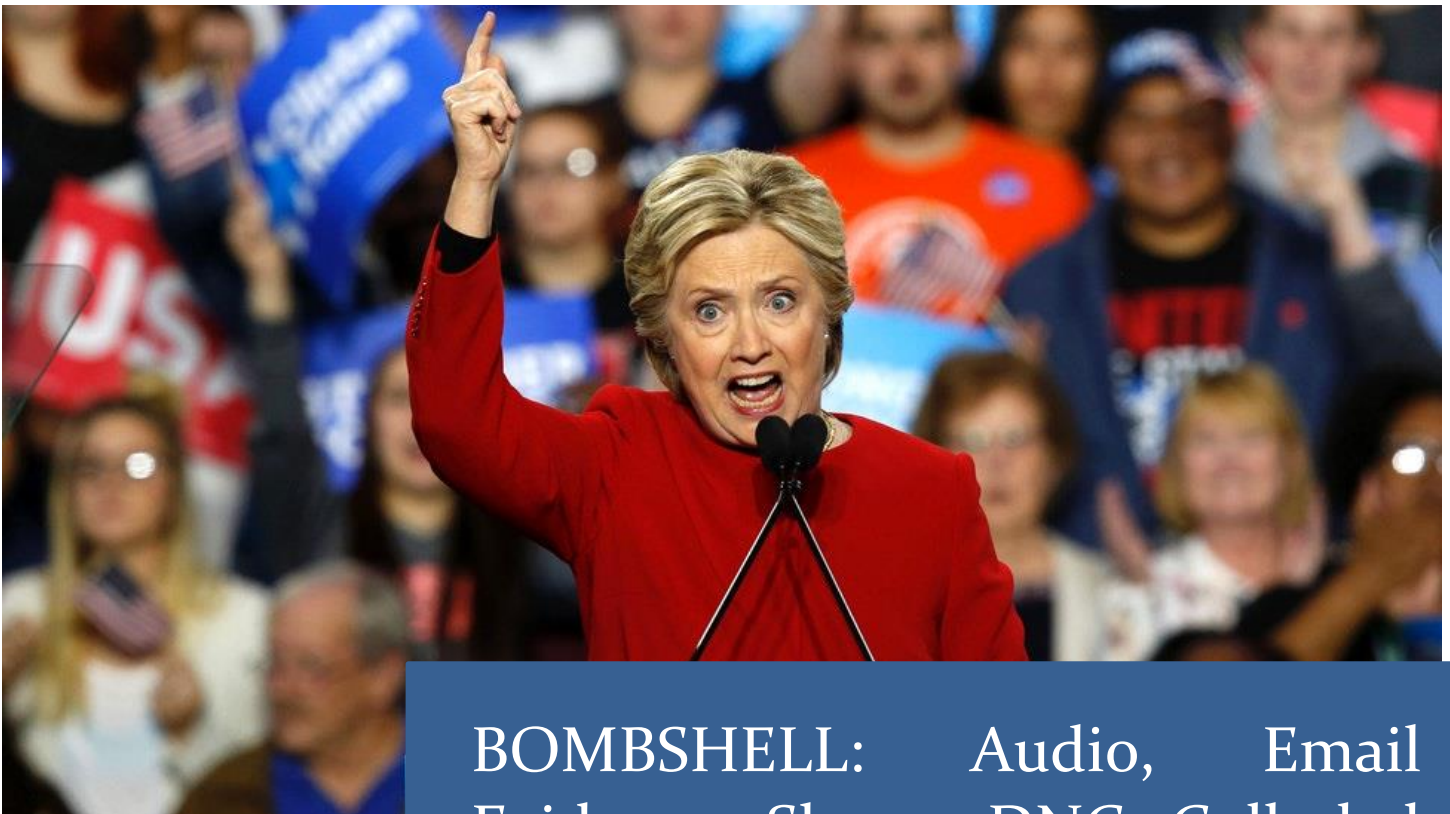

## BOMBSHELL: Audio, Email Evidence Shows DNC Colluded With Ukraine To Boost Hillary By Harming Trump, Report Says

The Blaze has released an audio recording that they recently obtained that appears to show Artem Sytnyk, Director of the National Anti-Corruption Bureau of Ukraine, admitting that he tried to boost the presidential campaign of Hillary Clinton by sabotaging then-candidate Donald Trump's campaign.

The connection between the Democratic National Committee (DNC) and the Ukrainian government was veteran Democratic operative Alexandra Chalupa, "who had worked in the White House Office of Public Liaison during the Clinton administration" and then "went on to work as a staffer, then as a consultant, for Democratic National Committee," Politico reported.

Chalupa was working directly with the Ukrainian embassy in the United States to raise concerns about Trump campaign chairman Paul Manafort and, according to Politico, she indicated that the Embassy

was working "directly with reporters researching Trump, Manafort and Russia to point them in the right directions."

The Ukrainian embassy political officer who worked at the embassy at the time, Andrii Telizhenko, stated that the Ukrainians "were coordinating an investigation with the Hillary team on Paul Manafort with Alexandra Chalupa" and that "the embassy worked very closely with" Chalupa.

The Blaze highlighted an email from WikiLeaks from Chalupa to Louise Miranda at the DNC:

*Hey, a lot coming down the pipe. I spoke to a delegation of 68 investigative journalists from Ukraine last night at the Library of Congress, the Open World Society forum. They put me on the program to speak specifically about Paul*

*Manafort. I invited Michael Isikoff, who I've been working with for the past few weeks, and connected him to the Ukrainians. More offline tomorrow, since there was a big Trump component you and Lauren need to be aware of that will hit in the next few weeks. Something I'm working on that you should be aware of.*

Transcript of the translated Ukrainian tape:

**Kolya:** Did they, those Russians, help Trump? Your people?

**Sytnyk:** I think they did. Yeah. I helped him, too. Not him, but Hillary. I helped her.

**Kolya:** Yeah. Right. Then her position tottered, right?

**Sytnyk:** Well, this is how they write about it, right.

**Ivan:** Hillary's humanitarian aid ... [indiscernible.]

**Kolya:** Well, I'm about ... the commentaries. At the time, we were not [indiscernible.]

**Sytnyk:** Trump ... his purely inner problem ... issue ... they dominate over the external matters. While Hillary, she is – how shall I put it? She belongs to the cohort of politicians who comprise the hegemony in the U.S. Both in the U.S. and the entire world, right? For us, it's ... sort of ... better. For Americans ... what Trump is doing is better for them.

**Kolya:** Well, we have lots of those American experts here now ... [indiscernible.]

**Sytnyk:** Well, there, you see why Hillary lost the elections? I was in charge of the

investigation of their “black accounting” records. We made the Manafort's data available to general public.

**Kolya:** So what?

**Sytnyk:** He was imprisoned. Manafort then was the head of the Supreme Headquarter of Trump, right? Then he was dismissed, too, including due to the “black accounting.” After that, he was sentenced to 80 years of imprisonment term. How about Trump? Did he not give a s\*\*\*. They have their system working there and it works smoothly.

**Kolya:** Everybody worked smoothly there.

**Sytnyk:** And when they carried out the elections, a week before the elections, the FBI reopened the investigation in respect of Hillary. So her rating dropped for 7 percent and that's why Trump managed to win the elections at a pinch. I'm still unable to understand why he's fighting with the FBI. They try to catch him on the hand. If it were not the FBI, he would not have won the elections. They torpedoed Hillary's ratings for 7 percent.
