PRESIDENT'S MESSAGE



There is also a shortage of fish as the government does not want fishermen in boats 90 miles of the coast of Florida – too much temptation to run.

This is what a communist country looks like in 2019. The only worse decision might have been to visit Venezuela. On the bright side however, I was able to book a lovely suite at a ramshackle hotel for Alexandria Ocasio-Cortez. I am sure she will enjoy her stay!

Dinner with Bill Whittle

Prior to the event, we all had about 20 minutes to kill before the doors opened. Naturally, most everyone was at the bar grabbing a drink and that's where I met Bill Whittle and his beautiful wife Natasha. I told him that we were all looking forward to him speak. Most guest speakers just say "thank you, I'm looking forward to it as well." Not Bill Whittle. He looked like a kid on Christmas eve, full of excitement when he said, "I can't wait to share my ideas with you. It's something like you've never heard before. I think it's going to blow your mind." Wow. Suddenly, the 20 minutes we had to wait seemed like an eternity.

When I first checked in, Donnell informed me that there would be a few high-school and college kids at the event (aka "millennials"; which was actually Bill Whittle's target audience for this particular speaking engagement) and that I should try to reach out to them and make them feel welcome and honored. I was happy to do so and it wasn't hard, because 2 of the 3 millennials in attendance were sitting at my table with one empty seat between them – for me. Perfect. I'd easily be able to get their thoughts on what Bill had to say.

Jeanne introduced Bill Whittle by stating that he is currently working on a media-game venture called "The Aurora Projec" which is a game set in the future that will serve to advance conservative ideals to millennials. Ultimately, *that* was what he came to talk about, but he had much more to say and he started off by saying, "This is a message of hope, but first, I need to scare you stupid!"

Bill then showed us a map of the U.S. and what it would look like if only millennials voted 20 years from now. All the states were blue except for Utah. Of course we all gasped in horror (and thought about moving to Utah). He then said the Left has intentionally PAID to make the states blue. He used George Soros as an example. Soros has paid billions of dollars to fund liberal marches and causes all over the country.

Bill Whittle accurately stated that "Pop culture is absolutely the battlefield." He conceded that the leftist media has done a phenomenal job at, in his words, "hypnotizing" the general population (especially the youth) through pop culture. Bill used the "Family Guy" as an example - "The show has gotten in young people's minds and "hypnotized" them to believe that America is horrible and racist and homophobic, etc." Bill Whittle understands that to target millennials through pop culture is the best chance we have in keeping America a great Repubic. We need to exploit these things to affect the ideology of younger people! (my own thought when Bill exclaimed those things). Bill realized that kids 'want to win wars and be heros. They also want to 'level up' (keep making more money and being able to upgrade their game which WE call 'succeeding'!), but they are being told by current pop culture that it's inappropriate and thus the gaming industry has become a place to escape and 'act out their biology!' Bill said "the gaming world is actually more realistic than the real world!"

Whittle went on to talk about Kanye West's influence and how it made him realize something just as important... When Kanye spoke out saying "I actually agree with Trump on some things and I think the dude is cool. I relate to him" – he was essentially giving black men permission to like Trump! After Kanye's comments, Bill said black men's support of Trump tripled!

Later in his talk Bill sited "Star Wars" as a shining example of how the leftist media not only squelches political truth, but also anything relating to traditional faith. He pointed out something I remember thinking to myself many times while watching some of the Star Wars movies – "it has spiritual/religious overtones all through it!" "There is good vs. evil and there is a savior (young Luke Skywalker)." All the franchises did so well because it spoke to us; our need for victory over evil and our hope for a hero/savior. The left saw this and said "no" according to Bill Whittle.

He believes the last installment of Star Wars, "The Last Jedi" was meant to "destroy the religion (it became)." "Luke Skywalker is now an old bitter, selfish, lazy and murderous man. Not a hero at all... there was too much toxic masculinity to contend with (?)"









After taking that path with the hero character, the franchise, for the first time ever tanked with "Solo."

A real life example that Bill Whittle talked about, regarding men wanting to actually do the right thing and be heros, is with the New York group called "Guardian Angels." This group appealed to men's biology and went to thugs in the area and challenged them to do the right thing, so they can be a hero in society instead of an angry victim. There are now Guardian Angel chapters in over 11 countries (in over 100 cities). They call themselves "volunteer unarmed citizen crime patrollers." It's in their biology!

Bill Whittle has also realized that, forever, Conservatives have put all our values in the past. To be a relevant influence, we need to take our Conservative messages into the future! And because of all the negative messaging in pop culture about Conservative values, they are not going to buy anything with an overt Conservative message. Which brings me to Bill's idea to capture millennial audiences by the millions through gaming: "Give it to them subliminally! They will eat it up!"

To elaborate on that, with the help of gaming experts, Bill Whittle has recently been designing an interactive computer game called "Aurora." He believes it can revolutionize the way we get conservative messaging to millions of young people. What does "Aurora" look like exactly? This is essentially the game theme:

"After a catastrophic failure of their nuclear engine and the loss of their primary crew, this small but dedicated team races to re-design and re-crew Aurora, reaching back into NASA's best days to move forward into the future – a future that depends on protecting and preserving the quintessential **American frontier values**: **courage**, **optimism**, **ingenuity and daring**."

Bill went on to say that "The characters are all young, cool, multi-cultural, and fit. And because I'm designing the game, they say what I want them to say – so it will be conservative thinking and action that is undeniable to the player's common sense and biology!" "There will be heros in an amoral community, which will get their (the youth's) attention." "The 2nd amendment will be alluded to when they see the absurdity of a sign that says "no murdering allowed" – like that will stop the bad guys (he said, sarcastically)." These things and more are all part of the conservative subliminal messaging that players will experience while playing "Aurora." That is Bill Whittle's conviction at least.

He closed by stating that "the power of peer pressure in pop culture is overwhelming UNTIL someone breaks the spell" – 'and that's what we're trying to do here. Break the liberal hypnotism that is so pervasive.'

When the event ended, I asked the young people beside me what they thought about Bill's gaming idea. The gal to my right said she thought it was very interesting even though she doesn't play computer games personally. The young man to my left pensively thought about it, then said "I think it could work – it really just depends on the marketing and it getting to the right people."

BREAKING: Mueller Report Released to Attorney General, NO FURTHER INDICTMENTS Included

On Friday afternoon, at 5 PM EDT, the Justice Department confirmed that Special Counsel Robert Mueller had indeed turned in his long-awaited report on supposed Trump-Russia collusion. Attorney General William Barr then released a letter to the ranking members of the House and Senate Judiciary Committees informing them that he "may be in a position to advise you of the Special Counsel's principal conclusions as soon as this weekend."

Under Department of Justice regulations, Barr must review the Mueller report for release; Deputy Attorney General Rod Rosenstein wrote a letter last year suggesting that no allegations concerning non-criminal activity would be released to the public. Late on Friday afternoon, multiple news outlets broke the story that Mueller had recommended no further indictments in his report.


The Mueller report represents the conclusion of a nearly two-year-long inquiry under Mueller's auspices, begun when Deputy Attorney General Rod Rosenstein appointed Mueller after President Trump fired FBI director James Comey.

Democrats have been clamoring for a full release of the Mueller report, presuming that a redacted report will be far less damaging to President Trump than the full report. House Speaker Nancy Pelosi (D-CA) and Senate Minority Leader Chuck Schumer released a statement calling on Barr to "make the full report public and provide its underlying documentation and findings to Congress," declaring that the "White House must not be allowed to interfere in decisions about what parts of those findings or evidence are made public."

Many in the media continue to report, despite the lack of further indictments, that prosecutions that have already taken place somehow provide evidence of Trump-Russia collusion. This is flatly false. None of the indictments already pursued concern collusion between the Trump campaign and the Russian government that implicates Trump or any high-ranking campaign officials. With that said, it is possible that Mueller recommended no further indictments thanks to DOJ regulations that state a sitting president cannot be indicted. We won't know the full extent of that possibility until we learn the details of the report.

Meanwhile, media members have already turned their eyes hopefully to the Southern District of New York, where the possibility of criminal indictment against President Trump on the basis of campaign finance violations remains.

A Leg Up On Legislation

California

February 22 was the cut off to introduce legislation for California's Congressional session and the Democrat majority is off to a roaring start introducing 2,576 bills before the deadline hit. Here's some highlights:

Independent Contractor Status Leads the Charge

How to determine if you are an employee or an independent contractor following a 2018 court case with Dynamex created the new legal standard, known as the "ABC Test". The

classification makes it more difficult and riskier for employers to utilize independent contractors.

Key bills regarding this issue are:

AB 5: Intends to "clarify the decision's application in state law." This legislative proposal will likely be the defining bill for the new standard.

AB 233: An industry-specific proposal that attempts to clarify that insurance agents and brokers should not be considered "employees" where certain specific conditions are met.

Efforts to Renew Mandatory Arbitration

AB 51: Regarding the use of mandatory arbitration agreements in employment agreements this new bill is a resurrection of AB3080 which was vetoed by Governor Brown.

California Chamber of Commerce has named AB51 a "job killer" stating: "AB 51 (Gonzalez) is a job killer due to the significant increased costs employers will face as a result of more litigation and the expense of delayed dispute resolutions. In addition, it is well understood that if signed into law, the proposal would be preempted by federal law. Both the California Court of Appeal and the U.S. Supreme Court have specifically held that state legislation trying to ban arbitration agreements is preempted by federal law. In fact, AB 51's limitation on the ability to form an arbitration agreement as a condition of employment conflicts with U.S. Supreme Court Justice Elena Kagan's opinion in Kindred Nursing Centers Ltd. Partnership v. Clark, that federal law protects and preempts state law regarding both the formation of arbitration agreements as well as the enforcement of arbitration agreements."

Sexual Harassment Bills Make Another Round

AB 9: Extends the statute of limitations for filing administrative claims for employment discrimination (including, but not limited to, sexual harassment) from the current one year limit to three years. It is a reintroduction of AB 1870 which was vetoed by Governor Brown last year.

AB 170: Makes employers jointly liable with "labor contractors" for all types of harassment (not just sexual harassment). Similar language was used in AB 3081, which was also vetoed by Governor Brown last year.

AB 171: Also similar to last year's AB 3081, this bill prohibits employers from taking adverse action against an employee because of their status as a victim of sexual harassment, and would establish a rebuttable presumption that adverse action taken against an employee within 90 days is unlawful.

AB 547: Another revisited bill, this one deals with mandated sexual harassment prevention training for janitorial contractors.

AB 628: Extends certain leave and other protections to victims of sexual harassment or family members of victims of sexual harassment. It is also like a proposal from 2018, AB 2366, which did not make it through the legislative process.

US House of Representatives

HR1: For The People Act VETOED! "Congress has the freedom to pass this resolution, and I have the duty to veto it," Mr. Trump said, adding that GOP voters were "overwhelmingly" against the resolution. Democrats are planning to hold a veto override vote on Mar26, but will unlikely receive the necessary two-thirds majority. The Democrat held House will likely use the controversy to add to their list of 'things we hate Trump for' continuing to ignore the mounting humanitarian crisis and, heaven forbid, actually present immigration reform legislation.

HR2: Infrastructure Bill one of the few items on their agenda that actually has the potential to draw broad bipartisan support.

HR6: The Dream and Promise Act of 2019 is the 116th Congress's version of the Dream Act, a bill which has been introduced since 2001 to allow the U.S.-raised immigrant youth known as "Dreamers" to earn lawful permanent residence and American citizenship. However, H.R. 6 includes protections and a path to citizenship not just for Dreamers, but also for Temporary Protected Status (TPS) and Deferred Enforced Departure (DED) beneficiaries. Amnesty by any other name, with a side dish of entitlements. Not a bad deal if it came with a wall as dessert ...

HR8: Universal Background Checks. David Kopel wrote in 'reason' blog, "HR8 requires that loans, gifts, and sales of firearms be processed by a gun store. The same fees, paperwork, and permanent record-keeping apply as to buying a new gun from the store. If you loan a gun to a friend without going to the gun store, the penalty is the same as for knowingly selling a gun to a convicted violent felon. Likewise, when the friend returns the gun, another trip to the gun store is necessary, upon pain of felony. A clever trick in HR8 effectively bans handguns for persons 18 to 20. The bill has some narrow exemptions. The minuscule exemption for self-defense does not cover stalking victims. None of the exemptions cover farming and ranching, sharing guns on almost all public and private lands, or storing guns with friends while on vacation. The limited exemption for family excludes first cousins and in-laws. The bill authorizes unlimited fees to be imposed by regulation."

10 Questions Every Democrat Candidate Needs to Answer

The implications are enormous, since a Republican would become Governor if all three were to resign, and the Democrat presidential candidates should tell voters whether they believe such horrendous behavior should be tolerated for the sake of political advantage.
