

AN EVENING WITH DENNIS PRAGER

"To be ungrateful to live in the greatest country that humans have ever made is disgusting."



The largest number of conservative Jews to ever gather in the history of the U.S. came together on the night of October 11 at Valley Beth Shalom in Encino, California, to hear Dennis Prager speak. Prager began speaking about the United States of America the way all patriots do, with tears in his eyes and a lump in his throat.

Comments such as, "I love this county," were met with standing ovation. The sounds of Jewish, American and conservative pride could undoubtedly be heard from the streets outside and I was very excited to be a witness and to be a part of it.

I first learned of Dennis Prager when I was in college, almost 10 years ago. My cousin, Mike, told me to check out an organization called Prager University. PragerU is a nonprofit organization that creates short videos on various political and economic issues from a conservative perspective - that is, the *right* perspective. My favorite PragerU video is one in which Gloria Alvarez, a Guatemalan political scientist and radio broadcaster, asked immigrants coming to America: "Why do you support the same policies in the U.S. that caused you to flee your home country?"

Prager asked a similar question of his fellow Jews: "Why do you support a party that wishes you ill?" The backwards way of thinking that characterizes the Left was the focus of Prager's speech at Valley Beth Shalom.

"There are no words to describe my deep disappointment in so many of my fellow American Jews for being on the left; not for being liberal, but for being Leftist....How does a Jew support the Left? The seed of Jew hatred on earth, today. How do you do that?"

And what often accompanies irrational thought is irrational action. Prager expressed his disgust with the mob behavior of the Left and pointed out how differently the Right reacted when Barack Obama was elected, possibly the worst president in U.S. history, and then reelected.

"They can't imagine that we are as disgusted with Barack Obama's presidency as they are with Donald Trump's presidency. Because, we act civilly when we are disgusted. We didn't blow bridges, and didn't blow tunnels, and didn't smash windows, and didn't break down businesses and didn't surround democrats in a restaurant."

A tendency of some individuals on the Right, of which I am also guilty, is to seek to rationalize the Left by giving them the benefit of the doubt. We tell ourselves, "They mean well." Even Ben Shapiro, a tough Orthodox Jew and conservative, regularly states on his podcast that he believes that most people on the Left are sincere.

Alternatively, Prager stated, "meaning well doesn't mean a damn thing! The road to hell is paved with good intentions.... That they are sincere is of no interest to me." This is a great reminder. As conservatives, we tend to be more civil and forgiving. We do not scream at the top of our lungs or resort to mob violence when we do not get our way. This is part of what makes the Right, *right*. But we cannot, in the name of civility, give the Left a free pass to run roughshod over our American values. That is how we got 8 years of Obama. We must be firm in our fight for the Judeo-Christian values upon which Western civilization was built.

Dennis Prager ended the evening with this greatest of all messages: "Prepare the world under God's rule." As Jews and Christians, this is our task. Only people without God could possibly believe the lies of the Left. "If all the Jewish professors at universities taught this, America would be in better shape."

POLITICON 2018 By Andrew Kelinsky



As is often the case, I was not in charge of my day nor my schedule. Believe me, walking around a convention center is not how I typically spend my Sundays. However, on October 21, 2018, that is exactly what I was doing. Semi-sleep deprived, prideful, and convicted, I explored the arena with a curiosity and keenness I had not felt in quite some time. I was intrigued by the different booths and the background noise of teenagers debating the topic of global warming.

I agreed to go to Politicon with my girlfriend. Like any wise man, I let her be in charge; and we attended the day on which well-known conservative pundits and activists were speaking. The set-up was as expected. Booths with different information, merchandise being sold, and different activities filled most of the open area. Sadly, I did not get a photo with the baby Trump balloon.



As much as I enjoyed the offerings in the common space, I dreaded the upcoming talks as it required listening to other peoples' ideas. (I like the sound of my own voice; however, both my girlfriend and the amalgamation of attendees seemed more interested in what the

speakers had to say.) Much to my surprise, I thoroughly enjoyed listening to fellow conservatives talk about a variety of issues and accurately blame leftist ideology as the primary cause. In classic fashion, Shapiro pointed out how the left is threatening Americans' first amendment rights; Tucker Carlson discussed his new book *Ship of Fools*; a panel of pundits from the Daily Wire -- headlining Shapiro and comically omitting the introduction of Michael Knowles – took questions from the audience; and Carlson closed the day with a discussion with the leader of the Young Turks.

Yet, I found myself most intrigued by a debate held between Sam Seder – comedian, actor, and progressive talk-radio show host – and Charlie Kirk – founder of Turning Point USA, a conservative non-profit that aims primarily to educate college students on true-free market principles. The topic of the debate: "Is Trump good for the middle class?"

My head swirled with many unrelated thoughts. "Are they going to discuss Trump's new tax law?" "How can Seder deny that Trump being in office has improved America's economy?" "It'll be so nice to go to a debate where right-wingers are the audience." No more than 5 minutes into the debate, Seder and Kirk already managed to disagree. Much to my surprise, liberals and left-wingers filled the room just as much as, if not more than, my fellow right-wingers. What was Christmas morning quickly turned into a tense Thanksgiving dinner.

Quickly enraged by the childish behavior of liberal supporters and dismissive rhetorical retorts by Seder, I remembered why conservative monetary policy is so important. In an age when we are a nation divided and most of the attention is on social issues involving race and gender, the question of economics is one that has seemingly been overlooked. The debate between Seder and Kirk reminded me that we are not just fighting for our rights, we are fighting for our livelihoods and the livelihoods of our families.



The debate consisted of the following:

Tax and Spending Cuts

The debate started by Seder pointing out that Trump's tax cuts are going to fail as spending has not changed, and he pointed to the failed tax and spending cuts by Brownback in Kansas. Seder slyly also contended that Brownback failed the state by shrinking the government. Kirk retorted by pointing to the

failed states of California and Illinois and to the prosperity of Texas and Florida, illustrating both the importance of decentralized authority and sound economics.

Kirk conceded that spending cuts need to couple the tax cuts, and immediately Seder claimed that cutting social security and Medicare is problematic. Seder is wrong. Social security and Medicare taxes cripple the middle class. These taxes cut earnings for individuals and businesses by 6.2% each or 12.4% combined.

Let's take an example of an average American who makes \$40,000 a year and works for 40 years. This person will have spent just under \$100,000 on these taxes. Obviously, \$100,000 is an expenditure over the course of a lifetime. The problem, however, has to do with return on investment. If the person could invest this money and get an average annual return of 5%, this person will have had more funds available to cover medical and retirement costs. Additionally, businesses must pay 6.2% per employee. When these costs are extrapolated across different demographics, wage amounts, and businesses, it becomes easy to understand the damage social security had and continues to have on America's economy. Until social security programs promise a comparable return year over year where Americans are receiving their cash, social security is doing more harm than good.

Wealth Inequality

Seder had the gall to contend that there was more growth and less stagnation of wages under Barack Obama than Donald Trump. Seder insisted that the wealth gap is growing, as indicated by the unaffordability of housing. Kirk responded by explaining that Seder's data was incomplete as he was not considering the growth of pension funds for government employees. Kirk also pointed to the rising costs of property taxes and development as part of the reason for the increase in housing prices and the decline in homeownership. (Public pension funds and other similar investments are often handled by firms such as Goldman Sachs, so the growth of these funds is not measured by government statistics.)

Seder ignored these points entirely. As a side note, the economy under Barack Obama dropped to all-time lows. Turning the economy around is like someone losing weight. When obese, it is easy to lose 100 pounds whereas for an elite athlete, losing weight and gaining muscle is a much more difficult endeavor. The economy improving more drastically under Obama compared to Trump is a meaningless comparison. Without mentioning or giving context, Seder grossly mislead a room filled with young minds.

Next, Seder contended that one person getting wealthy meant taking wealth from someone else. He used the example of Amazon being a business with no competitors and stock buybacks as a big contribution to the growing gap in wealth. Kirk argued that money from businesses gets re-distributed into the economy through dividends and other forms of payouts. Seder said these monies were just going to executives, which is why the stock buy backs are a problem. Kirk and Seder went back and forth with some stats and called each other liars. Theoretically, Kirk is right, but it is difficult to come up with any real determination as to how much of an effect buy backs have on the economy and what percentage of earnings get re-injected into the economy after distributions.

Regulations on Big Business and the Great Recession

Naturally, contention over the amount of necessary regulation for businesses and the Great Recession followed. Seder contended that markets fail to allow for competition, pointing to Amazon as an example. He concluded regulation is necessary to breed competition. Kirk responded by pointing to regulations as unnecessary barriers to entry, which prevent the start of small businesses that eventually grow into larger businesses that can compete with the Amazons of the world.

Seder then pointed to the repeal of The Glass-Steagall act as causing the Great Recession. Kirk agreed that the repeal was a problem but added that the main issue was the inaccurate rating of bonds by Fannie Mae & Freddie Mac. Seder tried to use histrionics and rhetoric as means to deal with failed regulation by government agencies. Seder blamed investment firms for making bad loans and blamed wealth, greed, and free markets as the primary drivers of the economic downturn in the mid-2000s. Kirk continued to hound him with the point that the loans and investments were

problematic in so far as the ratings mislead investors. Kirk pointed out that taking advantage of an opportunity is very different than failing to do a job or stealing.

Trade Policy

Kirk and Seder quickly switched gears and provided some lip service, but no real substance on trade policy. Seder criticized how Trump handled threats made against China and related tariffs on steel. He claimed the tariffs facilitated job loss and unemployment. Kirk did not address Seder on this topic as he wanted to discuss healthcare.

Healthcare

Seder took issue with the repeal of Obamacare and a free market in healthcare. Kirk argued that healthcare is too regulated, which is why insurance companies do not cross state lines. Seder responded by stating insurance companies could cross state lines but don't because they are unfamiliar with the market. Seder pointed to the Mercatus study and Nordic countries as examples of effective healthcare budgeting and systems. Kirk pointed out the high tax rates of the Nordic countries, which Seder never addressed but seemed to have no issue with the concept. Kirk did not mention that part of the effectiveness of the Nordic healthcare system stems from the small(er) and overall health of the Nordic people. This is where the debate ended.

Although, it is difficult to know with certainty, as conservatives tended to listen to Seder's arguments and just waited for Kirk to disprove them, Kirk's youth and inexperience showed as Seder had better control of the crowd. My conclusion? Conservative and right-winged (monetary) policy is more effective for both practical and philosophical reasons, which would require another piece to discuss.

In the words of Thomas Sowell, "The first lesson of economics is scarcity: there is never enough of anything to fully satisfy all those who want it. The first lesson of politics is to disregard the first lesson of economics."
