# Ocean Marine Engineering Website Terms and Conditions of Use

#### 1. About the Website

- 1.2. The Website is operated by Ocean Marine Engineering Pty (ACN: 669 265 114) t/a Ocean Marine Engineering. Access to and use of the Website, or any of its associated Products or Services, is provided by Ocean Marine Engineering. Please read these terms and conditions (**Terms**) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of its Services, immediately.
- 1.3. Ocean Marine Engineering reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Ocean Marine Engineering updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.
- 2. Acceptance of the Terms

You accept the Terms by remaining on the Website.

- 3. Copyright and Intellectual Property
  - 3.1. The Website, the Services and all of the related products of Ocean Marine Engineering are subject to copyright.     - (b) Ocean Marine Engineering will not be liable for any special, indirect or consequential loss or damage (unless such loss or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with the Services or these Terms (including as a result of not being able to use the Services or the

late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.

12. Independent Legal Advice

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

### 13. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
