

Terms and Conditions for Monthly Membership of NET Club

1. Membership Fee and Payment:

- 1.1. The monthly membership fee for NET Club is £40.00.
- 1.2. Membership is invoiced monthly and must be settled by the due date. Payment can be made by standing order directly into the bank or by card select the Autopay option for ease.
- 1.3. Attendance for each meeting should be logged on the website in advance

2. Benefits of Membership:

- 2.1. As a member of NET Club, you will have access to various benefits, including but not limited to networking events, NET Club Whatsapp Group, and other resources as they arise.
- 2.2. NET Club reserves the right to change or modify the benefits and services offered to members with reasonable notice.

3. Member Conduct:

- 3.1. All members are expected to conduct themselves in a professional and respectful manner during all networking events and interactions with fellow members.
- 3.2. NET Club reserves the right to terminate the membership of any member who engages in disruptive or inappropriate behaviour.

4. Substitute Attendance:

- 4.1. Members of NET Club may designate a substitute to attend networking events or meetings on their behalf if they are unable to attend.
- 4.2. The member is responsible for informing the group in advance, by booking them in to the meeting on the website and notifying the group co-ordinator
- 4.3. The substitute must comply with the same professional conduct and behaviour standards outlined in Section 4.
- 4.4. The member remains responsible for any membership fees associated with the substitute's attendance.

5. Referral Incentive Program:



- 5.1. NET Club values the growth of its community and encourages all members to actively promote and introduce new individuals or businesses to the group.
- 5.2. To incentivise member referrals, NET Club has established a Referral Incentive Program. Under this program, if a new member joins as a direct result of your referral, and they commit to a minimum of three consecutive months of membership, you will be eligible to receive a month's free membership in the form of a credit on your account.
- 5.3. To qualify for the referral incentive:
- a. The new member should mention your name or referral code at the time of registration.
- b. The new member must maintain an active membership for a minimum of three consecutive months from their registration date.
- 5.4. Once the new member fulfils the commitment, NET Club will issue the credit note to you, which will be used against the following month's Membership invoice.

6. Notice Period:

- 6.1. Members may cancel their membership at any time, the notice period is 1 month.
- 6.6. To cancel your membership, you must provide written notice by email <u>Gill@tewkesburycoworking.co.uk</u> or Whatsapp to <u>07939 260118</u> at least one month before you wish to end membership.
- 6.3. You will be responsible for the membership fee for the entire notice period after submitting your cancellation request.
