#### **Terms & Conditions**

These Terms & Conditions are to be read in conjunction with the Evergreen Sponsorship Memorandum of Understanding (MOU).

#### **Deliverables**

- All *Harvest Sponsor* benefits for the 2025 Expo, plus:
- 4 x dedicated social media shoutouts spaced throughout the 12-month sponsorship term
- Logo, business name, and short description featured year-round on the Expo website
- Inclusion in 2 e-newsletters (1 pre-Expo and 1 seasonal follow-up)
- Feature in a shared Evergreen Sponsor spotlight carousel post (Instagram & Facebook)
- **Promotional presence** (flyers, postcard, or signage) at up to 2 Southern Highlands Wellness Gatherings per year
- Opportunity to include 2 promotional inserts across tote bag or off-season event outreach
- **Priority access** to 2026 exhibitor bookings (before public release)
- 10% discount on 2025 Expo workshop or presentation fees
- Recognition as a **Founding Evergreen Sponsor** (2025 only)

### **Sponsor Commitments**

- Expo-related content must be submitted by **July 30** and includes:

  - Business description (25–40 words)
  - Sponsor spotlight content (100 words + 1 image)

- Year-round content (for social posts and updates) may be submitted quarterly or in one annual batch
- Sponsors are invited to contribute up to:
  - 4 social media posts
  - 2 promotional inserts
  - 2 Wellness Gathering materials (attendance optional)
- All content must align with the Expo's ethical, wellness-based values
- Sponsor responsibilities are considered fulfilled once all agreed deliverables have been completed or offered

### Limitations

- Evergreen benefits are non-transferable and non-refundable once confirmed
- Social media shoutouts must be relevant and wellness-aligned; inappropriate content may be declined
- Physical promotion at Wellness Gatherings is limited to one A5 flyer, postcard, or small sign
  —materials must be clearly labeled
- Year-round visibility begins from the date of confirmation and continues for 12 months
- Inserts and features are capped to ensure fairness and quality across the year

### **Refund & Cancellation Policy**

- Sponsorship is **non-refundable** once payment is received, unless the Expo is cancelled or under exceptional compassionate circumstances
- Monthly payments are binding for the 12-month term and non-refundable if cancelled partway through
- In exceptional cases, early termination may be approved at the discretion of the Organiser

### **Communication & Dispute Resolution**

- All concerns or requests must be submitted in writing via email
- Dispute resolution will be conducted entirely in writing to maintain clear records
- If a matter cannot be resolved informally, both parties agree to seek mediation via a mutually agreed third party
