By completing this Application Form, you (as “Ultimate Beneficial Owner”) agree that Fairway Group’s nominee company, FPTL Nominees Limited, is authorised to establish a bare nominee arrangement (the “Nominee Arrangement”) in your favour to hold your FlexGlobal Assets and in relation to which the following terms shall apply:

1. Nomineeship:

FPTL Nominees Limited (the “Nominee”) will hold your FlexGlobal Assets as nominee and on bare trust absolutely, on your behalf, as the Ultimate Beneficial Owner.

The Nominee will undertake not to transfer, deal or dispose of your FlexGlobal Assets, unless expressly instructed otherwise by you and the Nominee shall not be under any duty to monitor, enhance or preserve the value of your FlexGlobal Assets.

The Nominee duties will be confined to:

- i. holding your FlexGlobal Assets until receipt of further directions from you;
- ii. accounting to you for any dividends or distributions which may be paid to the Nominee, as accrued; and
- iii. exercising any voting powers, as holder of the FlexGlobal Assets, only in accordance with your instructions.

2. Indemnification:

The following are the terms and conditions specific to the arrangement promoted as “FlexGlobal” which, in conjunction with Fairway Group’s Terms and Conditions of Business, Fairway Group act on your behalf and which Fairway Group will understand you (as “Client”) to have accepted unless otherwise agreed by Fairway Group in writing. These Terms and Conditions shall prevail to the extent they contradict or conflict directly with the Fairway Group’s Terms and Conditions of Business.

FlexGlobal is a nominee arrangement established in Jersey for the purpose of creating an investment savings vehicle for use by internationally mobile individuals. An account (known as the “FlexGlobal Account”) will be opened to hold the assets of such individuals (known as the “FlexGlobal Assets”) on a segregated basis and held by FPTL Nominees Limited, pursuant to a declaration of bare nomineehip, established in favour of such individuals, in accordance with the terms of the nominee arrangement contained in the Application Form to which these Terms and Conditions apply.

The FlexGlobal Account will be established for the purpose of holding funds with an investment manager (or investment managers) as recommended by the financial advisers of such individuals. 9. GENERAL INSTRUCTIONS - we ask that any instructions are confirmed in writing which includes electronic mail.
10. FEE SCHEDULE - the published FlexGlobal Fee Schedule may be varied from time to time, with at least 3 months advance notification of any amendments, by electronic mail.
11. FEE SETTLEMENT - the fees associated with FlexGlobal will be settled in accordance with the published Fee Schedule and are nonrefundable. Fairway reserves the right to withhold Client monies until all outstanding documentation is received and all fees have been settled. Following payment of proceeds, the Client’s Nominee Arrangement will be formally terminated.
14. THIRD-PARTY PAYMENTS - other than in the event of demise of the Client, third-party payments from FlexGlobal are strictly prohibited.
15. COMMUNICATIONS - all communications, including general administration enquiries, should be sent by electronic mail.
16. REGULATION - Fairway Group companies are regulated by the Jersey Financial Services Commission under reference TCB0174. Voisin Law is regulated by the Law Society of Jersey.
