## JANUARY 19TH—BOOK CLUB MEETING

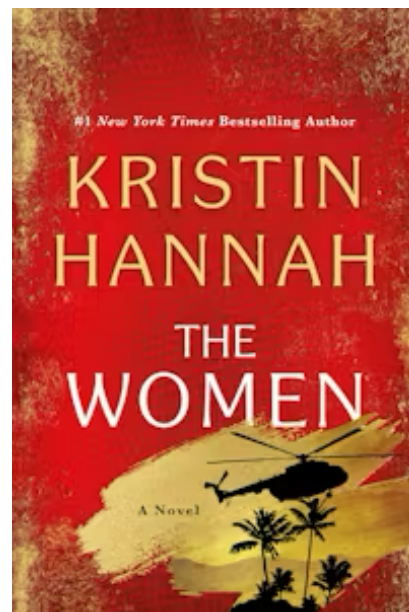

## Legislative Report

As of January 20, 2026, President Trump has signed 458 Executive Actions; there were only 220 signed in his first term. <https://www.whitehouse.gov/presidential-actions/>

**Election Integrity:** President Trump has been highlighting the deficiencies with electronic voting systems and mail-in ballots, calling them “corrupt”.

**Local Action:** Stay tuned with local action on the election integrity front by following Restore the Vote Ventura (RTVV) at <https://restorethevoteventura.org>. Ventura County Patriot Meetup founder Debbie Cohen, of which RTVV is a sub-group, was chosen by Supervisor Janice Parvin to serve on the newly created Ventura County Election Advisory Council. The EAC meets every two months and is open to the public. Bring the EAC your election integrity concerns so they can alert the Board of Supervisors of matters important to voters.

**State Action—Countering Gavin’s Gerrymandering:** In November 2025, California voters approved Prop 50, a gerrymandering scheme which used race to redraw district lines. To restore election integrity sanity, Carl Demaio’s Reform California has thus far collected 1.1 million signatures to get voter ID on the ballot this November. Demaio is urging a final push to collect signatures for voter ID and to save Prop 13 via petition. We need 100,000 more signatures by February 6, 2026, to counter the ~ 25% that are rejected during validation. **Reporting from CalMatters:** The following excerpts and links are from CalMatters, reporting on Supreme Court impacts on California legislation. Let this be a reminder of how critical our work to get Republicans elected to state office. Our current legislators cannot distinguish the basic differences between boys and girls according to biological reality.

### Transgender Californians have a lot riding on Supreme Court decisions

Though California is a relatively safe place for transgender youth, LGBTQ advocates warn that efforts to eliminate policies safeguarding transgender kids — led by right-leaning states and the Trump administration — [may change that](#).

As CalMatters' Carolyn Jones explains, a handful of California's policies may be at risk of being reversed or undermined as lawsuits challenging transgender protections play out in court. Two major cases are:

**Student athletes:** The U.S. Supreme Court is currently reviewing a case based on a pair of lawsuits challenging Idaho and West Virginia's bans prohibiting transgender women from playing on women's teams. Legal experts say the high court appears poised to uphold states' rights, allowing them to keep the ban.

Because California allows students to play on school-sponsored sports teams that align with their gender identity, a ruling upholding states' rights would also uphold California's policy. But it could also embolden the federal government to penalize states for protecting transgender athletes. Last year, President Donald Trump said he would withhold federal funding from schools that allow transgender females to play on girls' and women's teams.

**Parental notification:** In 2024 Gov. Gavin Newsom signed a law banning schools statewide from requiring school staff members to inform parents if a child identifies as transgender without the child's consent.

After the law went into effect, a pair of teachers from Escondido sued the state, arguing that it "violates their faith and ethics," according to the law firm that filed the suit on behalf of the teachers.

A federal judge sided with the teachers in December, but the state successfully requested a temporary injunction on the ruling while it prepares an appeal. The plaintiffs have asked the U.S. Supreme Court to reject the stay and implement the ruling immediately, but the court has yet to issue a decision.

**CEO Act:** Kevin McNamee, former city councilman and Mayor of Thousand Oaks, is promoting the CEO Act which would require annual educational funds to follow the student not the school. Reach out to Kevin for more information:

**“Gerrymandering”**

Gerrymandering occurs when a politician or party requests that the boundaries of their district is revised, and is done in a way that give the party or politician a political advantage over its rivals.

The manipulation of voting districts goes far back in time. In 18<sup>th</sup> century England, politicians created “rotten boroughs” with only a few eligible voters, then they could buy other votes to gain seats in parliament.

The name gerrymandering comes from the name of a former Governor of Massachusetts in 1812. At that time the parties were the Federalist Party and the Democratic-Republicans. His administration came up with new state senatorial districts and gave an advantage to Democrat-Republicans. The new district he drew looked like a salamander, hence the term Gerrymandering.

Ideally, voting districts would be set up in a way that makes sections equal in size and the number of constituents. In many redistricting attempts over the years, there have been clear concerns that the changes do not provide equal

sized districts and are created by looking at past voting patterns as well as demographics to put a politician in a district with more representation by their party.

The Voting Rights Act of 1965 prohibits manipulating the district to allow less privilege for minorities. The court ruled in *Miller v. Johnson* (1995) that the use of race as a predominant factor in drawing boundaries shall not be allowed.

Originally, gerrymandering was not considered an issue under the remit of the federal courts, however, in *Davis v Bandemer* (1986) the Supreme Court held that it could be unconstitutional if the electoral system “is arranged in a manner that will consistently degrade a voter’s or a group of voter’s influence in the process of the whole.” This is known as the Bandemer decision.

Post the Bandemer decision, it was again decided that gerrymandering is not an issue for the Federal courts. Numerous gerrymandering schemes have occurred. A famous one being the North Carolina’s district 12, known as the “I-85” district, as the district ran along a highway and was almost as narrow as the highway.

Gerrymandering is clearly not the best way to go about the voting process. Both sides have been guilty, and it is not clear if we will ever have a solution. Hopefully, one day there will be a fair and equitable process for re-districting. Until then, republicans will have to keep up with the democrats.
