

Have a Support Network: Identify people to involve in planning who can help in an emergency situation. They may include nearby family, friends, caregivers, neighbors, and co-workers.

TAKE NOTICE OF THIS IMPORTANT INFORMATION

As we are clearing out our medicine cabinets, please take NOTICE from Al Nienhuis, Hernando County Sheriff:

Prescription Drug Drop Boxes

There are 3 permanent drug drop-off boxes located at these locations:

- Main office is located at 18900 Cortez Boulevard, Brooksville (Regular Business Hours)
- District 2 office located at 7499 Forest Oaks Blvd, Spring Hill (Regular Business Hours)
- Hernando County Detention Center located at 16425 Spring Hill Drive, Spring Hill (24 Hours)

Citizens are now able to properly dispose of unwanted, unused, and/or expired prescription and over the counter medications as well as veterinarian prescriptions. The drop-off box is available in the main lobby of the Sheriff's Office during normal business hours. There is no cost to drop off unwanted/unused medications.

The following items cannot be disposed of in the drop-off box and can be disposed of at the locations listed below:

- Needles, Sharps, and/or Syringes Please take to the landfill at 14450 Landfill Road in Brooksville only.
- Please take any liquids to the landfill at 14450 Landfill Road in Brooksville only.
- Inhalers Please take to the landfill at 14450 Landfill Road in Brooksville only.

Please keep in mind that the drop off box located inside the lobby at the Sheriff's Office is small. If you have a very large quantity of unwanted medications,

it may be best to go directly to a landfill near you, as we are unable to handle more than a few bottles at a time. Visit www.hernandosheriff.org for more info.



Please take **NOTICE** of this important information for all Heather Community Owners for your own safety and the safety of others in our community.

Hernando County Code Enforcement mandates ordinances concerning posting address numbers that must be followed for every building.

"On every single building and multiple unit buildings the address number must be affixed horizontally in a conspicuous place so that the number is clearly legible from the roadway." Chapter 23, Article 5, Section 23-180 by the County Code Enforcement Division.

It is imperative that each homeowner add or replace the address number on your homes.



DON'T FEED THE WILDLIFE!

That has changed significantly over the years and at this time the owners are mostly working people struggling to live in an atmosphere that is well kept and cost-effective to meet their needs.

I have been pursuing information regarding all of this and more and so far, our choices are to pay \$3300 for the site and a monthly service fee or there is a way to avoid this and have all that we need up front with no charge. I am pursuing this diligently and will have all the information I need soon and will continue to inform you of what I believe will be in your best interest. As President of the Board, which I have been for many years, it is my responsibility to do due diligence for the owners. I have always done this and will continue until I leave my position.

Ingredients:

- 1 lb package brown sugar
- 1 can condensed milk
- 2 tablespoons butter
- 2 tablespoons marshmallow fluff
- ½ teaspoon vanilla

Add crushed walnuts if you want nuts.



Directions:

In pan empty brown sugar and condensed milk and the 2 tablespoons of butter. Bring to boil. Continue to simmer for a full five. (You will see crystalizing on sides of pan when ready) Take off stove, add marshmallow and vanilla and nuts if desired.

Put into a parchment lined 9 x 9 baking dish or spray pan fully with oil. Let harden and cut into squares. I cut them before total hardening to make it easy to cut.


