Wauchope Mini Bus Hire - Hire Agreement

Below is the Terms and Conditions to be adhered to for the Hire of our Mini Buses. Please read carefully and sign at the end if you agree and understand. All buses are inspected prior to hire, including checks of tyre pressures, oil and coolant levels, fluid levels, lights, and general vehicle condition, to ensure the vehicle is in safe operating condition at the commencement of the hire.

Please feel free to contact us to ask any question or clarify any information. We look forward to working with you.

Hirer:

1. Bookings will not be confirmed until the "Bus Hire Application Form" is completed and any other requested documents provided and the \$100 booking fee is processed. If the booking is cancelled within 7 days of the hire date a further \$100 will be charged to the card supplied, as outlined under cancellation.
2. The organization/person hiring the vehicle is responsible for the behavior of passengers and to ensure that illegal drugs are not consumed whilst passengers are on the bus.
3. The hirer is responsible for ensuring road rules and regulations are adhered to e.g., compulsory wearing of seatbelts.

Driver:

1. No persons under the age of 25 years will be permitted to drive the bus as per our company insurance policy.
2. Copies of current driver's license to be provided to Wauchope Mini Bus Hire at the time of booking for all proposed drivers.
3. 12-seater bus is class "C" and the 14-seater bus is class "LR"
4. It is the driver's responsibility to pick up the keys during normal office hours – Mon-Fri – 6:30am-6:00pm, Saturdays – 7:00am-1:00pm, unless agreed otherwise at 57 High Street, Wauchope NSW 2446, from Doherty's.
5. The driver/s will be responsible for all traffic infringements
6. In the event of an accident contact the police, ambulance etc. as required by law. Advise Wauchope Mini Bus Hire on 65853666 during business hours or leave a message on out of hours phone – **0493820832**.
7. The vehicle must at all times be driven only by the driver/s nominated and authorize on the application form. No unauthorized person is to, at any time or under any circumstances, drive the bus.
8. Should the vehicle suffer mechanical or physical damage due to misuse, or an incident incurred while in the possession of hirer, the hirer will be responsible for the cost of any repairs required to vehicle.

Conditions Of Use:

1. Smoking in the vehicles is not permitted
2. The vehicle shall be returned in the same clean and tidy condition as at the time of pick up. Failure to do so will incur a cleaning charge of \$150
3. The vehicle doors and windows should be closed and locked whilst the vehicle is unattended
4. The vehicle must not be driven on unsealed roads unless prior approval is obtained.
5. The vehicle is to be returned at the specified time. Failure to do so will incur additional charge of \$50.00 per hour + GST or part thereof.
6. On return vehicle is to be parked, locked and keys dropped back into office, or lock box.
7. Included in each vehicle is: First Aid Kit, Fire Extinguisher, Rubbish Bin and Bags.

Refueling:

1. The minibus will be provided with a full tank of fuel at the commencement of the hire.
2. The vehicle must be returned with a full tank of fuel or filled up at our service station on return and paid for by Hirer.
3. Customers are responsible for all fuel used during the hire period.
4. The hirer is responsible for ensuring the correct fuel type is used to refuel the minibus. Under no circumstances should the vehicle be refueled with the incorrect fuel. If incorrect fuel is used, the customer will be responsible for all costs associated with draining, recovering, transporting, repairing or otherwise rectifying the vehicle.
5. If the vehicle is returned with less fuel than agreed upon, a refueling charge will be applied to cover the cost of fuel and the time required to refuel the vehicle.
6. E10 Fuel or Truck Diesel is NEVER to be used to fill or refill any of our minibuses. **Accepted fuels are U.L.P - 91, Premium 95, Premium 98, Diesel or Premium Diesel.**

Method Of Payment:

1. Full payment for the entire rental period is required prior to the collection of the vehicle
2. Payment details can be made via cash, eftpos, or Electronic Funds Transfer.

Cancellation Fee:

1. A cancellation fee of \$100.00 will be charged for any cancellations within 7 days of the hire date.

The person responsible for the hire of this bus is required to sign below, acknowledging they have read and accept the terms and conditions of the bus hire agreement and that the details on this form are true and accurate.
