PART 1 - Vote to Approve 2026 Budget - to Keep Monthly Dues at \$260/mo

Per the new Declaration adopted September 12, 2023 Section E-10, the members are required to adopt a balanced budget for the upcoming year. The Board is required to present a proposed budget for the members to approve at the Annual meeting. This budget requires two thirds vote of the members present or represented by absentee ballot or proxy at the meeting to pass. If the members do NOT approve the proposed budget, the Members will have to find another way to balance the budget at the meeting.

The Board is proposing the following budget for 2026 which consists of \$322,380. In order to meet this expense, to have a balanced budget would require maintaining the monthly dues at \$260/mo. If an Owner pays the full year upfront before January 31, 2026, they will be entitled to a 10% discount. Assuming all members paid in advance, we would meet this budget. Assuming half the members paid in advance and half paid their dues on a monthly basis, we project to have a surplus of \$7,600.
