## DARC NET CONTROL SCRIPT

Good evening, this is <CALLSIGN>, Net Control for the Delta Junction Amateur Radio Club Emergency Services Net. My name is <NAME>. This net meets Thursday evenings at 7PM local time. A secondary roll call will follow this amateur ARES net on <146.520 or 446.000> to test simplex operation and reliability.



The purpose of this net is to provide amateur radio operators in the Delta Junction, Alaska area with training for reliable communications in the event of an emergency, encourage interest in, and to provide training for, the Amateur Radio Emergency Service (A.R.E.S.), and to allow stations to check their battery and/or emergency power capabilities.

This is an open and directed net and everyone is invited to join in. We encourage our membership to try their base, mobile and handheld radios on alternating weeks to check in. This serves many functions including familiarity with operation and the opportunity to test your equipment.

We will ask for visitors after the regular roll call. Please transmit as directed by net control. Stations are requested to end each transmission with their call sign. Stations are further requested to remain on frequency until net traffic has concluded and the net is closed. If you need to leave early, please notify net control.

Stations having emergency traffic please use the words "BREAK, BREAK" with your call sign. Net control will acknowledge and turn the frequency over to the station with emergency traffic. As I ask for station check in, I will pause briefly. If no response is detected by net control, I will respond with "nothing heard" and continue. If another station can hear the reply, please relay by saying "RELAY: and your call sign and net control will acknowledge.

Current ARES Emergency Status is Level <0> (look up on <u>kl7drc.org</u> or ask)

Is there any emergency or priority traffic, please come now.

## DARC NET CONTROL SCRIPT

Any stations with formal written traffic, please come now.

Are there any short-term stations that need to be in and out, please come now.

I will now continue with club roll call. I will take regular club check-ins and then after roll call I will ask for any new or missed member stations;

Any missed or new member stations and any further traffic, please come now.

Please stand by. The ARRL Weekly Audio News follows on this repeater.

## <Play ARRL Audio News>

This concludes our transmission of the ARRL Audio News.

If there is nothing else, I will close this net. Please join us weekly on Thursday evenings at 7PM for the Delta Amateur Radio Club A.R.E.S. net on the 147 DOT 030 repeater. If you would like to be part of the Delta Amateur Radio Club, please contact any of our members, or attend one of our monthly meetings held every 2nd Tuesday at 6PM at the Mt. McKinley Bank in Delta Junction.

This is net control <CALLSIGN> closing the Emergency Services net on 147.030 @ <time> with <#> check-ins. We now turn over the repeater for routine traffic.

If you wish to test your simplex capabilities, Net Control < CALLSIGN > will be moving to 146.520 (or 446.000) simplex.
