HOW TO USE THIS GUIDE

- THIS CARE PLAN APPLIES TO ALL LT FENCING CO. FENCE AND GATE INSTALLATIONS. IT IS WRITTEN AS A SINGLE UNIVERSAL STANDARD, WITH SUBSECTIONS FOR SPECIFIC FENCE AND GATE TYPES.
- FAILURE TO FOLLOW THE REQUIRED MAINTENANCE OUTLINED IN THIS GUIDE VOIDS YOUR LIFETIME WORKMANSHIP WARRANTY.
- DO NOT ALTER, REMOVE, OR OBSCURE YOUR LT FENCING CO. FENCE SIGN OR IDENTIFICATION. REMOVAL IMMEDIATELY VOIDS THE WARRANTY.




SOIL, GRASS AND DRAINAGE

- GRASS OR GROUND COVER MUST BE MAINTAINED AROUND THE BASE OF ALL FENCE POSTS AND GATE POSTS.
- HEALTHY GRASS HELPS RETAIN SOIL MOISTURE AND PREVENTS CRACKING, SHRINKAGE, AND SOIL SEPARATION DURING DROUGHT CONDITIONS.
- BARE, DRY, ERODED, OR CONSTANTLY WET SOIL IS CONSIDERED IMPROPER MAINTENANCE.
NOT COVERED BY WARRANTY:
- POST MOVEMENT CAUSED BY DROUGHT, SOIL CRACKING, EROSION, OR POOR DRAINAGE.

WATER EXPOSURE & CHEMICALS

- PREVENT CONSTANT SPRINKLER OR IRRIGATION SPRAY ON POSTS, RAILS, OR PANELS.
- AVOID EXPOSURE TO FERTILIZERS, POOL CHEMICALS, SALT, OR CORROSIVE MATERIALS.
NOT COVERED BY WARRANTY:
- DAMAGE CAUSED BY MOISTURE SATURATION OR CHEMICAL EXPOSURE.





ALTERATIONS AND INTERFERENCE STRICTLY PROHIBITED (VOIDS WARRANTY):

- CUTTING, DRILLING, WELDING, PAINTING, OR MODIFYING ANY FENCE OR GATE COMPONENT.
- ADJUSTMENTS OR REPAIRS PERFORMED BY ANYONE OTHER THAN LT FENCING CO.
- REMOVING OR ALTERING FENCE SIGNS OR IDENTIFICATION.



GENERAL INSPECTIPON & REPORTING

- VISUALLY INSPECT YOUR FENCE AND GATES AT LEAST ONCE PER YEAR.
- REPORT CONCERNS PROMPTLY WITH PHOTOS OR VIDEO.

WOOD FENCES & WOOD FRAME GATES

REQUIRED:

- STAIN OR SEAL WITHIN 120 DAYS OF INSTALLATION. OIL BASED STAINS AND SEALERS ONLY (WE USE WOOD DEFENDER)
- POWER WASH AND REAPPLY STAIN OR SEALER EVERY 3 YEARS (OR SOONER IF FADING OCCURS).
- KEEP SOIL AND MULCH BELOW THE BOTTOM OF BOARDS.

NOT COVERED:

- WARPING, CRACKING, SPLITTING, SHRINKING, OR COLOR VARIATION.

VINYL / PVC FENCES

REQUIRED:

- CLEAN 2-3 TIMES PER YEAR USING MILD SOAP, DISTILLED WATER, AND A MICROFIBER CLOTH.

PROHIBITED:

- PRESSURE WASHING, ABRASIVES, BLEACH, OR SOLVENTS.

ORNAMENTAL IRON / STEEL & CHAIN LINK (GALVANIZED OR BLACK)

REQUIRED:

- CLEAN 2-4 TIMES PER YEAR WITH MILD SOAP AND DISTILLED WATER.
- INSPECT COATING REGULARLY.
- TOUCH UP CHIPS OR SCRATCHES IMMEDIATELY USING COLD GALVANIZING SPRAY OR BLACK SEMI-GLOSS RUST-INHIBITING PAINT.

PROHIBITED:

- PRESSURE WASHING OR WIRE BRUSHES.

R-PANEL / METAL PRIVACY FENCES

REQUIRED:

- WASH PANELS 2-3 TIMES PER YEAR.
- INSPECT AND TIGHTEN FASTENERS ANNUALLY.
- TOUCH UP SCRATCHES PROMPTLY WITH COLD GALVANIZING SPRAY OR MATCHING EXTERIOR METAL PAINT.

GATES (ALL TYPES)

REQUIRED:

- LUBRICATE ALL HINGES EVERY 6 MONTHS.
- KEEP GATE SWING PATHS CLEAR.
- INSPECT ALIGNMENT AND LATCHES QUARTERLY.

HINGE TYPES

- GREASEABLE / BULLDOG HINGES: GREASE EVERY 6 MONTHS.
- J-BOLT HINGES: INSPECT NUT TIGHTNESS EVERY 6 MONTHS.
- STRAP HINGES (WOOD GATES): GREASE EVERY 6 MONTHS AND INSPECT FASTENERS.

PROHIBITED:

- OWNER ADJUSTMENTS, AUTOMATION CHANGES, OR THIRD-PARTY REPAIRS.
