Acceptance of previous minutes:

Motion made and passed unanimously to accept previous minutes: (one board member not present)

GUEST: Ask a nurse program:

Motion made by Carl, Kandi Second motion unanimous vote of three (not in present Rochelle and Dawna) Dawna returned and voted in favor (computer connection issue)

Dawna shared treasurer report by screen share.

Website Updates

Kandi updated website added W9 form, and new professional services agreement. Also updated funding request due by date as per voted on 25th of each month. All links have been tested and verified to be working properly.

Project Updates

CVPR

Jessica B property should have been surveyed and parks department will be discussing this at the next meeting (tomorrow night) Planning meeting will be held for community input. Feedback form on FB. Lovely natural features at the new park location. If there is a community led design, there may be a strong ability to have some funders pitch in to fund the community led design. Discussions about a trail greenbelt area behind the park.

Communication HUB

Carl- will be doing interviews soon. Needed to find a time that all board and interviewees could do them. Interviews should be done in the next week or so. Once done, Tyler Bird will design the website. We should be set for the first paper hopefully by June 1, 2022

Kristi- timeline hello neighbor has an article about being handed off to Communication hub. Hello neighbor will come out in May.

Funding Requests

Twin Sisters funding request for \$10k. Cat was able to provide us with more information regarding this request.

Members shared thoughts and ideas of this request.

Concern about this request-funding that is received for FCA is to be used for funds inside the CV area.

Yes, this is a 501c3 entity but is being used to support farmers out of the area. This does not seem to be best model for this area. Does not feel it fits into the charter the funds are for.

Worried about current economy and food shortage, asked Sam for a tour of the facility. It seems like the foodbank needs a lot of items but doesn't have much butter, milk, etcetera if economy gets worse, we continue to have a shortage. Cat explained that Farmers can give a certain amount of food and what is not sold is then given to the foodbank but no guarantee. Cat talked about potentially paying farmers and then bring in more produce to bring in more customers but still does not guarantee produce to the foodbank where our focus is on those who cannot afford expensive foods right now.

Feels the foodbank needs more dairy, etcetera.

Feeling of money request is not the correct use of funds as this is for paying to keep farmers with twin sisters not for providing the community with food without charge.

Ally stated that the request is for providing affordable food to the community but not for supplying the foodbank with food per se, as that would be an added benefit.

- Farmers do need to get more money and get the farmers markets up here, they are not as affordable as it is being said. What it is doing is providing three markets with the food not just in this community.

Food bank has been the focus for the community as the source for community who needs food up here.

After discussion was had, vote was made

Felt the request for funds is too far out of wheelhouse

Motion made to not fund this project Dawna seconded this motion 4 votes for "no" (unanimous vote) (Rochelle not present)

Would like to foster support for Twin sisters and keep them in the community, this is a discussion for a future time.

2 other funding requests were sent in recently, not complete yet but hope to have them in May meeting.

Board Development Update

A month or so ago, there was discussion about having a probationary period for new board members to ensure they have had a time to ensure they are fully aware of the board duties for them and ensure FCA is a good fit for them.

We want to encourage to have many different community members on the board not just people with previous board experience.

Board member supports the idea as people don't really understand how much work does happen. This would require a bylaw and policy change.

Like the idea to give someone a chance to "try out"

Two community members have made application for board position, we need to know that someone can handle the technical aspect and a chance to learn especially if they want to help the community.

Board member agrees with having a probationary period. Eventually we will go back to in person meetings but there will still need some technical knowledge.

There is a lot of work that could be done not as a board member that people can still contribute

Open for community input.

Joni gave word of caution, sometimes when filling out grants or paperwork you must list board members and contact information so you may want to think about that.

Jessica: We are a community that has a good diversity and being able to talk to the diversity of the board members, someone who can't read doesn't mean that they can't contribute.

It was suggested to table this for another month. Or put a poll out there for community.

Another board member suggested that we just go ahead and make a vote now for this probationary period as we haven't gotten new members anyway. This may help gain members as they decide if this is a fit for them without being so scary and big commitments.

Another member agreed that this may be a better way to go since we are not getting any bigger.

After further discussion it was decided that a vote would be had tonight.

Kandi made a motion to have a 90 probationary period for a new board member, Dawna Seconded this

Carl asked for a 60-day probationary period versus 90 days. Dawna seconded this for a 60-day probationary period.

Carl withdrew his amendment for 60 days and Dawna second the 90-day probationary period. Vote obtained 4 voted for 90-day probationary period. Rochelle was in favor of a probationary meeting but not for 90-day length.

Rochelle joined the meeting at 7pm and was brought up to speed on the probationary period vote. Rochelle lost her connection prior to making the vote.

Rochelle stepped away from the meeting at 7:10pm, Ivy sat in in her place.
