Advance Payment: Payment for treatment programs is required in advance. This payment must be made prior to the commencement of treatment and before being accepted into the program.

Court Reports

Requested Progress Reports are charged at \$75.00 plus GST

Completion Reports prepared at the conclusion of the Program are charged at \$95.00 plus GST

Payment into Trust: Fees must be paid into a trust prior to application approval. This ensures the immediate start of treatment and monitoring once the application is accepted.

Refund Policy: Patients unable to complete the treatment program for legal or personal reasons are eligible for a pro-rata refund based on the unused portion of the program.
