



PRIVATE LIMITED COMPANY (LTD)

- Structure includes at least 1 director, 1 shareholder (individual or corporation is accepted) and 1 ultimate benefit owner (must be natural person), not have more than 50 shareholders
- There is no minimum or maximum share capital requirements. This type of business allows to issue & transfer shares
- Mandatory to have a company secretary and local office to ensures the company and its operations comply with all aspects of Hong Kong company law. Require to do accounting & auditing
- Profit tax rate fluctuated from 8.25% 16.5%, tax exemption for profits made outside of Hong Kong. Company information will be opened to the general public



1. We do not collect Nominee deposits like other service providers do but we need to collect both <u>incorporation fee</u> + <u>accounting fee</u> (start from USD 1,800) to protect benefits and transparency for our local Nominee director.

- 2. We need to collect the KYC compliance check fee of US\$ 350.00 each additional director/shareholder.
- 3. To enhance the company security, there might be an additional fee for Local Nominee selection after the KYC compliance process is completed. The fee varies depending on the compliance check result.
- 4. If you are unable to commit to monthly accounting document submissions or prefer to handle bookkeeping in-house, you may pay a USD 2,000 Nominee Deposit fee. This deposit will be refunded if:
 - a) you stop using our nominee director service, or
 - b) the Singapore company is dissolved.
 - => We will collect the Accounting review fee from USD 800++ once you submit the bookkeeping records for review.
 - 5. In order to use our nominee directorship services, the engagement in our tax filing service is compulsory each year*
