We hope our event will be one of the fastest growing in Shasta County and becomes a premier adaptive rodeo event in this area. We are currently in the process of lining up our volunteers for this year. We certainly hope that you would consider joining us as a volunteer for this amazing event.

We welcome student organizations, church groups, civic groups, businesses, and individuals to volunteer for this event, that will touch your heart like no other. Hosting a successful event requires a lot of volunteers. There are many areas you can volunteer for including parking, food service, working games and activities and on-site transportation among others. We also have carnival-style games and other activities available for our participants and their families.
