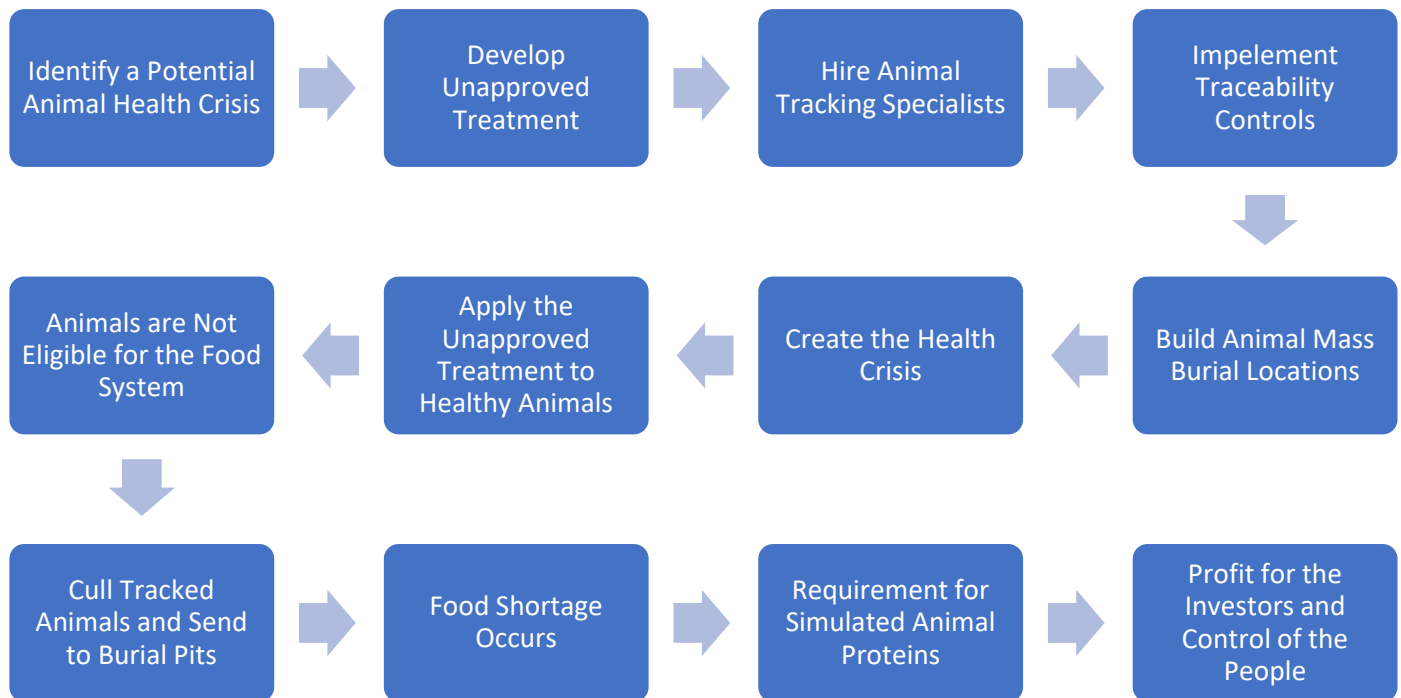

Controlling Your Food Supply is Part of the Plan

A plan is being implemented by globalist investors through The Canadian Food Inspection Agency and Health Canada...

The Canadian Government recently approved several novel food ingredients...

Simulated Beef

In 2015 and 2020, Health Canada approved a yeast derived soy leghemoglobin product owned by Bill Gates, JP Morgan, and Google to be used in fake or simulated meat products. Most people do not know how this simulated meat product was developed. This product uses genetically modified yeast organisms that are subcloned with a heme biosynthesis pathway and a LGB2 gene. The soy-boy concept is taken to the extreme with glycine based proteins produced by the yeast.

The products replace bovine hemoglobin in plant-based foods so that human diets can be restricted in meat. While the stated primary purpose is to improve flavor and aroma, the company stated the product is unpleasant in taste, so it limits the inclusion level to the amount needed to achieve the genetic modification's goals. The product increases heme-iron content that is normally only from meat.

The 2020 approval allow the company to produce pork and chicken alternatives rather than just beef alternatives. Just in time to be commercialized before the 2025 and 2026 avian flu "outbreak".

Simulated Milk:

An Israeli owned company petitioned Health Canada to approve a yeast derived milk protein in which a genetically modified yeast organism is subjected to chemicals to make it grow milk proteins.

- The product was not tested for pollutant chemicals that it used in production.
- The genetically modified yeast was not tested for its safety.
- The milk protein derived from the genetically modified organism was not used itself in toxicology testing, instead a natural milk protein obtained from cow milk was used in its place.
- After not testing the actual product itself, Health Canada approved the product saying it passed testing.

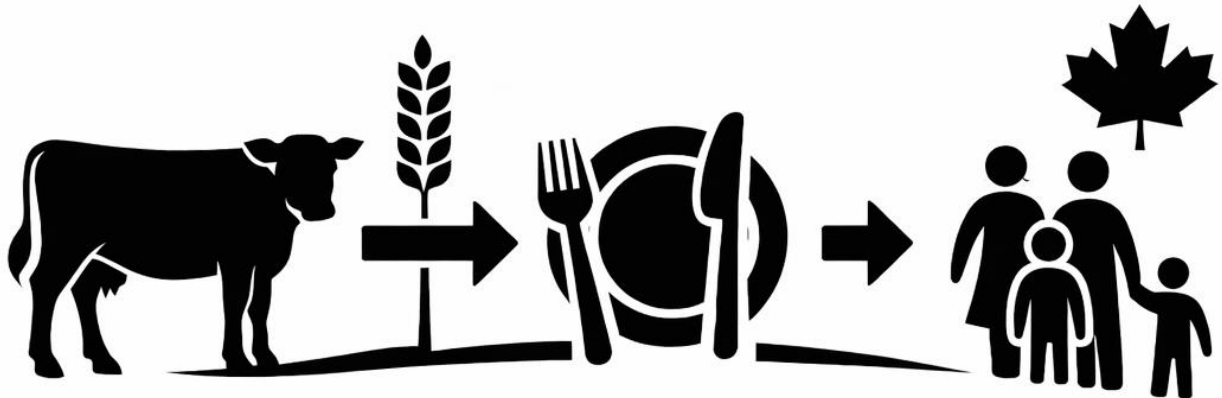
These products and the expressed interest by the Canadian Government will allow the elimination of animal and milk proteins from diets and realization of the owners' goal.
