

Eastern Sask Rising PRIVATE MEMBERSHIP ASSOCIATION

MEMBERSHIP AGREEMENT

The Eastern Sask Rising Private Membership Association is like a private family. What is communicated or happens inside a private family home, among the family members are private matter and are immune from and not subject to censorship or control by any administrative agency or representative of any local, provincial, federal, territorial, global body. Private Membership Associations have an established history and maintain a unique standing in society.

The Eastern Sask Rising Private Membership Association conducts itself on the unalienable rights and freedoms of men and women. Men and women have the unalienable right to engage in private transactions without the involvement of outside bodies, agencies, etc.. This right is given to us under common law, natural law and God.

The Eastern Sask Rising Private Membership Association will be identified as **“The Association”** in the body of this Membership Agreement.

Definitions of common law and natural law used in The Association’s Membership Agreement:

The Association defines and uses the definition of Common law as a partnership that recognizes unions created by mutual agreement and mutual benefit and to do no harm

The Association defines and uses the definition of natural law as the unchanging moral principles of human conduct. These are universal moral standards that are seen across time, periods and societies that form the basis of a just society. It holds that the law is based on what is correct through the use of reason and choosing between good and evil.

Private membership Association Agreement as follows:

1. This Association of members declares that our objective is to provide all The Association members with a platform with which to conduct all manner of private business and the convenient exchange within The Association membership. The Association may also conduct private networking with other Private Membership Associations that The Association has connected to and approved of.

2. The Association keeps all activities in the private domain and adheres to the unalienable rights and freedoms of men and women to engage in interactions and transactions in the private without outside involvement.

3. I believe that the Holy Scriptures, the unalienable rights and freedoms for men and women and all common and natural laws guarantees our membership the rights of absolute freedom of religion, free speech, petition, assembly and the right to gather and freely pursue their economic, social and cultural development.

4. I hereby declare that we are exercising our right of “freedom of association” and the “right of self-determination” as guaranteed by the alienable right of men and women and common and natural laws. This means that The Association activities are restricted to the private domain only and is therefore outside the jurisdiction of government agencies , entities, officers, contractors and other representatives as provided by their said law.

5. I declare that it is the basic rights of all members to decide for themselves who and when to network with members of The Association or with other approved Private Associations in and outside the province of Saskatchewan, Canada. I expect the freedom to choose for myself any type of assistance within The Association or other private member associations. This assistance extends to physical, spiritual, mental or any private network activity.

6. The mission of The Association is to provide members with a venue to conduct all convenient exchange between members for mutual benefit; in the private domain with the aforementioned inalienable rights of men and women utilizing common and natural law.

7. The Association recognizes any natural man or woman who have joined The Association and is in agreement with the principles and policies as a member of this Association, providing said individual has not been sanctioned , excised, or other wised banned by The Association. The Association will provide a medium through which its membership may associate for actuating and bringing to fruition the purpose heretofore declared.

8. I understand that Membership to The Association and any of its groups may be terminated by the Association overseeing committee and any two (2) members at any time, should they conclude thru common and natural law that I am interacting

with them or any other member in a way that is contrary or detrimental to the focus, principles and betterment of the Association.

9. I understand that the Association is protected by inalienable rights of men and women, by common and natural law and that it is outside the jurisdiction and authority of local, provincial, federal, territorial and global agencies and authorities. If there is a complaint that cannot be resolved by the two members exchanging business, there is method provided in the Framework to rule on the issue. The ruling of the Association committee in the conflict resolution process will be documented and will be final.

10. I agreed to join the Association under the common and natural law, whose membership seeks to help each other. For the purposes of The Association, I am voluntarily changing my capacity from that of a public member to a private member. My activities with the Association are a private agreement matter that I refuse to share with local, provincial, federal, territorial or global investigative or enforcement agencies. I fully agree not to pursue any course of legal action against a fellow member.

11. I affirm that I do not represent any local, provincial, federal, territorial or global agency whose purpose is to regulate, approve, enforce, entrap, investigate or interrupt products or services in The Association private domain.

12. I enter into this agreement of my own free will without any pressure or coercion. I have read and understand this document and my questions have been fully answered to my satisfaction.

I understand that I can withdraw from this agreement and the Association and terminate my membership at any time and that my membership can be revoked if I engage in abusive, menacing, destructive, harassing behavior towards any member of this association or any Private Member Association that The Association membership transacts with.
