DEFENSE

The Member or Owner agrees to indemnify Declarant, it's officers, employees, owners, agents and IHR-HOA, the Pool Management Company, if any, and any other individuals or entity associated with IHR-HOA or the Pool Management Company (all of which are referred to herein as "Operators") from any and all actions, claims or injuries arising from the use by Member or Owner, and its guests or invitees of the premises by any person, or for any condition existing on said premises. In any suit or action for damages arising from alleged negligence of Member or Owner in which the Operators, individually or collectively, are included as a defendant, Member or Owner will assume all the burdens, costs, and expenses of the defense thereof, including attorney's fees, and the cost of settlement or judgment obtain against the Operators, individually or collectively, by reason thereof.

HOMEOWNERS INSURANCE

The Member or Owner agrees to verify with its homeowners insurance carrier that said Homeowner has liability insurance covering his/her use of the pool, including any harm or injury to the guests and invitees for the activity for which Homeowner is utilizing IHR-HOA facilities now or at any time in the future.

ACKNOWLEDGEMENT OF RISK

I hereby acknowledge and agree that participation in activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with participation and that said list in no way limits the operation of this Agreement.

In consideration of my participation or use of the IHR-HOA facilities, I, the undersigned participant, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my, guests participation or use of the IHR-HOA facilities.
