**PLEASE READ BOTH PAGES 1 & 2 BEFORE SIGNING**

I acknowledge that the equipment listed is the property of the **Bronx Buccaneers Youth Organization** and that I am renting the listed equipment for use with the **Bronx Buccaneers Youth Organization 2025 Season** at the rental rates listed below which are separate from registration fees. I understand that while the equipment is in my possession, **I AM SOLEY RESPONSIBLE FOR THE EQUIPMENT RENTED TO ME**. I accept the equipment "as is". I acknowledge and agree that the **Bronx Buccaneers Youth Organization** should not assume responsibility for, nor guarantee the personal safety of participants, nor does the **Bronx Buccaneers Youth Organization** warranty, guarantee, or assume responsibility for the borrowed equipment. I will not modify or mark the equipment in any manner to make it unusable or undesirable for future participants.

**I understand that I am only eligible to rent equipment after more than half (½) of my registration fee has been paid.**

I agree that any equipment lost, stolen or damaged in any way or manner at any time will result in me paying full price for the equipment. I also agree if the equipment needs repairs, I will report those repairs to a member of the coaching staff to get them fixed as soon as the problem arises.

Therefore, I promise to take care of all rented equipment and to use the equipment **ONLY** in the manner consistent in which it was intended for. I promise to return all rented equipment in good or same condition prior to leaving this team.

I acknowledge that I am obligated to return the equipment at the conclusion of the **2025** season or when requested to do so. I acknowledge that if I fail to return the equipment described or if the equipment is damaged except what is deemed normal wear and tear, that I shall be responsible to pay the **Bronx Buccaneers Youth Organization** the replacement cost of the equipment. Failure to return the equipment will constitute as theft and will result in disqualifying my player from any future participation with the **Bronx Buccaneers Youth Organization** or any other team in the League. I also understand that criminal charges may be brought against me.

**Release and Acknowledgement**

I further hereby release, waive, agree not to sue, and agree to hold harmless, defend and indemnify the **Bronx Buccaneers Youth Organization & Under The Lights Football & Cheering League**, either board, officers, coaches, members, employees, volunteers, agents and representative from any and all liability damages, claims, demands, or causes of action of any kind and/or nature of which may arise from the use of the equipment rented from the **Bronx Buccaneers Youth Organization**. I further acknowledge that I/we have carefully read the foregoing Release and Acknowledgement and know the contents thereof and sign this Release and Acknowledgement as a free and voluntary act.
