Stacie Stebbins(Seller) of Beautiful spots Bengals is in effect as of the date signed below and is legally binding to all parties involved. Buyer agrees to buy and Seller agrees to sell the below-described kitten under the following terms and conditions:

#### **FUTURE EXPENSES:**

The Buyer assumes responsibility for all expenses of the kitten after they leave the possession of the Seller.

Examples of these expenses will include: food diet, litter box needs, toys and activities to keep your energetic kitten busy, and veterinary costs for both expected and unexpected treatments. Initial \_\_\_\_\_

#### **PAYMENTS:**

The down payment is placed to hold a particular kitten for a buyer. It is 300 USD. All down payments are non-refundable, since holding for one buyer could jeopardize the chance for the kitten to be sold to someone else. This money does go towards the final

price of your pet. Under NO circumstances will we allow a kitten to leave our cattery without the entire balance being paid and this contract signed! Initial \_\_\_\_\_

Forms of payment include: Cash (at pick up), Cashapp, Venmo, and Zelle

### **DELIVERY FEE:**

If Seller agrees to meet Buyer to deliver the kitten, a fee of \$200 for a 2 ½ hours drive will be expected upfront and is non-refundable if the Buyer chooses not to take the kitten of interest. Initial \_\_\_\_\_

### **RETURNING CAT:**

If, for any reason, at any time, Buyer is unable to keep or provide adequate care for this cat, Seller must be contacted. Seller agrees to accept the cat back. The buyer will be responsible for any transportation unless other arrangements are agreed upon. If the cat is returned to the Seller for resale on behalf of the Buyer, the terms of this resale will be agreed upon under a separate written agreement. If you have already found someone else to take the cat, they must fill out our application and be approved by us. Initial \_\_\_\_\_

### **SURRENDERING A CAT:**

Please do not surrender your cat to a shelter or sanctuary. We will take the cat back. If one of our cats is found to be in a shelter or sanctuary, it must be able to be released to us, the breeder, regardless of the circumstances that led the cat to be in such a place. Possession of the cat, once back in our custody, will be determined solely between us, the breeder, and the owner. The shelter or sanctuary holds no responsibility. Initial \_\_\_\_\_

This cat/kitten must NEVER be given or sold to any research or testing facility, humane society, shelter, pet shop, or any organization like it. NO EXCEPTIONS! Initial \_\_\_\_\_

~ Buyer(s) agree to maintain the proper veterinary care for the cat/kitten, including all yearly check-ups and vaccinations, as well as provide proper grooming to keep the cat/kitten happy, healthy, mat-free, and clean.

~WITHOUT SELLER'S WRITTEN CONSENT, this cat/kitten will not be given away or resold for any reason.

~In the event the buyer(s) can no longer care for this cat/kitten for any reason, please notify the seller and we will help you find a suitable home for your cat/kitten. We do not want any of our cats/kittens to end up in a shelter.

~This cat/kitten will NEVER be allowed to roam freely outdoors.

~I highly recommend that this cat/kitten NOT be declawed. This is an amputation of the tips of the fingers and toes and is an inhumane procedure. My cats and kittens love their little paws just the way they are! Initial \_\_\_\_\_

### **ROOM AND BOARD:**

If the kitten being sold is already of age to go home when being purchased, an additional fee of \$20/week for room and board will be added to the purchase price if, after making a deposit, the Buyer can not pick up the kitten for over a week. This is due to the cost of food, litter, time, and energy it takes to properly care for each kitten.

### **HEALTH GUARANTEE:**

~Your kitten is up to date on vaccines at the time of sale, but will need to complete the FVRCP series and will also need a rabies vaccine. The seller will provide your kitten's medical record so that you can take that to your vet, and they can see what is needed to complete your kitten's vaccination series.

Beautiful Spots Bengals guarantees the health of your kitten until he/she reaches ONE YEAR OF AGE. The Seller's health guarantee will offer another kitten, of equal or lesser value, as a replacement in the event said kitten should die as a direct result of an unknown (at the time of sale) congenital birth defect, or be diagnosed with a terminal genetic defect. An appropriate necropsy must be performed by a licensed veterinarian, and a veterinarian's certificate with full disclosure and a copy of this report is provided as proof of cause of death. The necropsy must include microchip information to verify the kitten's identity. We must have access to all

health/vet records. Any evidence of trauma, abuse, neglect, not receiving proper nutrition, failure to obtain veterinary care, or not providing required documentation will void the opportunity for replacement.

There shall be no refunds of holding fee, purchase price, shipping charges, or other costs. Shipping expenses of the replacement kitten will also be the responsibility of the Buyer.

We recommend that you take the kitten to your own veterinarian (at Buyer's expense) within 120 hours. You or your veterinarian shall immediately report to the Seller any medical problem found within this period. Failure to notify Seller within one business day of the appointment will void this warranty. If the kitten is found to be in "unsound health" by a licensed veterinarian within 72 hours, the kitten shall be returned to the Seller, and Buyer may request a replacement. Said replacement will be made as soon as a suitable replacement becomes available. A medical report signed by the examining veterinarian

must be provided to the Seller prior to a replacement being made. "Unsound health" shall be defined as: any condition which is "life-threatening" or "incurable" but shall not include "curable" conditions or infections, including but not limited to "colds, viruses, bacterial/parasitic infections or allergies." Exposure to other animals of any species during the 2-week quarantine period will void this warranty. Initial \_\_\_\_\_

#### **CARE OF KITTEN:**

If the seller deems the buyer is not providing proper care, the seller can repossess the kitten; no refunds available. If matters are to be taken to court, the buyer is responsible up to 5000.00 USD, court fees, and the seller will reclaim said kitten. This includes proper vetting and home life of the cat/cats. #### **BREEDING CAT:**

The cat/kitten is not allowed to be bred to any unregistered cats or cats not within the Bengal breed. If the buyer breaks the contract, the seller may repossess the cat/kitten, and the buyer will be charged 5000.00 USD for every kitten produced from the pairing. Initial \_\_\_\_\_

No offspring may be sold back or transferred to the state of Michigan. Initial \_\_\_\_\_

~Any disputes or claims shall be brought to the state of Michigan, and the reinstating of Venue will not be allowed in any other state. Also, any disputes or claims will be held ONLY at a Michigan court of the breeder's choice. Buyers will be responsible for all costs and legal fees for him or herself as well as the breeder (this includes breach of contract).

~Any disputes will be between seller and buyer and not made public by either party, including social media. This will result in a 5000.00 U.S. dollar fine. Initial \_\_\_\_\_
