2020/21 Pricing and General Info

Instead of billing you monthly, at CDA we have 4 nine-week sessions per school year. What this means for you is that if we're closed for say, Spring Break, you don't pay for that week as part of the nine included in your tuition and sometimes one session actually cover three calendar months because of holiday closures! Most lessons that are billed month monthly have ten billing cycles per school year, we have just the four. Session 4 may be 8 weeks due to recital.

Tuition must be paid in full before the first day of the session in order to reserve your spot in class. **Class sizes will be limited on a first come first serve basis.**

- Annual registration fee \$45 for young ones and level one classes (includes uniform for in person class, or prop kit for Zoom class). Siblings receive a \$10 discount.
- Annual registration fee \$25 for level two students, and non-academy classes (does not include uniform). Siblings receive a \$10 discount.
- Cascade Dance Company materials fee \$20 per student/year
- Musical Theatre materials fee \$10 per student/year

General information:

1) Tuition must be paid in full before the first day of the session in order to reserve your spot in class. There is a one-time registration fee, per school year, which includes a leotard and tights for CM, PB, and level 1.

Session 1: Tuition paid upon registration. Session begins 9/7

Session 2: Tuition paid before 11/9 Session 3: Tuition paid before 2/1 Session 4: Tuition paid before 4/19

- 2) All tuition statements will be emailed.
- 3) Late fees are incurred at \$10 per week past due date, alternatively If your child is enrolled in a full class all students on unpaid accounts will be automatically dropped and your spot may go to another dancer.
- 4) There will be a \$20 fee for returned checks.
- 5) There are no refunds, tuition transfers, or credits to your account. Pro-rated tuition will be allowed for mid-session start, but not for missed or dropped classes. If the studio needs to close in person classes due to Covid-19, we will immediately switch to Zoom or video classes and no refunds will be given for virtual classes.
- 6) If your student misses class due to illness or vacation, there may be a Zoom or Video option they can make-up with. Contact our office for info. In person make-ups will not be allowed this year due to Covid-19.
- 7.) Once registered in a class, your enrollment continues into the next session unless you contact our office directly and ask to drop. Statements for the next session will be sent out at least one week before the current session ends, and you must drop before payment is due for that session. If you have a card n file, it will be run on the date payment is due (again, with at least one week advance notice of your bill).
