4. EMA-911 Budget Discussion/Action

Robinson presented to the budgets. He stated that the only increase was 3% for employee increases. He further stated that the county hasn't decided what the increases will be at this point, but he wanted to put something in for everyone to consider. Krutzfeldt stated that the national average is looking at a range of 4%-6% and that Robinson should consider increasing that. Van Der Veer agrees that it should be increased if we want to retain good staff. Groenedyk states he doesn't want to see anything done until the court ruling or the consultant report comes back. He also questions why the groups continue down the same path. Both City representatives for the City of Oskaloosa also agree they want to see the consultant report back before moving forward. Robinson did states that the only concern is the requirement of budget certification before February 28th. It was felt that the consultant report would be back, as well as the court ruling, and the groups could move forward once they have that information. No action was taken.

5. **Radio system update Discussion/Action** Robinson provided an update to the radio system. They anticipate going live with the entire system in the next few weeks. No action was taken.
