 - Motion by Groenendyk to approve the agenda, seconded by Greenlee, all in favor, motion carried.
- 2. Approve meeting minutes from the January 10th, 2024 meeting
 - Motion by Toubekis to approve the minutes, seconded by Baxter, motion carried. Systma abstained.

3. Public Comment

A discussion was held regarding school safety in the county. Sheriff Van Renterghem
and Josh provided information to the group regarding their involvement with schools.

b) 2024-2025 Budget

A discussion was held about the overall cost and the EMA/911 shared cost. A motion was made by Sytsma to pay the EMA portion of the vacation time in the amount of \$3,575.04, seconded by Caligiuri, all in favor, motion carried. Van Deer Veer made a motion to pay the EMA portion of the comp time in the amount of \$8,778.00, seconded by Caligiuri, all in favor, motion carried.
