Additional Cemetery Information

Monuments

Interment rights include the right to erect a marker. The marker can either be a single flat marker, a single upright marker. Optionally, in the case of a side by side burial in adjoining lots, a double flat marker, or a double upright marker. The size of the marker is limited as per the cemetery by-laws.

Number of burials

Interment rights are suitable for the burial of a single (1) dead human body. Cremated remains are not suitable for burial.

Burial Depths

Interment rights allow for a single burial. Multiple burials, at multiple depths are not allowed.

There are no funding, payment or financing options offered by the YMHA.
