# IMPORTANT ANNOUNCEMENTS FOR THE 2022 SEASON:

1. VOLUNTEER REFUNDABLE FEE: All parents of athletes must sign-up for a minimum of 12 hours of volunteer time. A refundable fee of \$100 per family, cash/check will be collected at registration and will be held and returned upon completion of volunteer hours.

2. If an Athlete fails to notify his/her coach prior to a competitive shoot of their impending absence, the Parents will be responsible for lost entry fees incurred. Failure to pay for this loss shall remove the Athlete from the next scheduled competitive shoot.

3. Athletes are REQUIRED to participate in all fundraising events. Fundraisers are necessary in which to cover costs associated in the running of the LBTTT program.

4. No ammunition provided to any shooter by Los Banos Tiger Trap Team may be taken off the premises. Ammunition will be distributed by the coaches at practice (If ammo is available for practice) and shoots. **If you bring your own ammo to practices (when offered), events or competitions, you will not be provided ammo by LBTTT.**





## LOS BANOS TIGER TRAP TEAM - RANGE OPERATIONS GUIDE

1. **GENERAL:** Live firing conducted at the Los Banos Sportsmen's Range Complex is designed to provide authorized personnel access to a facility where they can become proficient with privately owned firearms. For purposes of this document, the terms "Range Safety Officer" (identified as RSO), and Coaching Staff mean the same thing.
2. **FACILITIES FOR USE:** Range availability is at the discretion of the RSO or Coaching Staff. Live fire shooting is normally limited to the following ranges and equipment:
  - A. **RANGES:** Trap and Skeet Ranges – Shotguns using only shot size #7 ½ or smaller, #1 1/8 ounce maximum load.
3. **RANGE LIMITATIONS AND SAFETY REQUIREMENTS:** Live shooters shall:
  - A. Fire only on scheduled ranges and have a RSO or Coaching Staff present.
  - B. Fire only authorized firearms and ammunition.
  - C. Fire only after completing a "Hold Harmless" agreement.
  - D. Ensure all projectiles impact within the established range safety limits.
  - E. Call "Cease Firing" and make safe all firearms when a shooter moves forward of the firing line or during any unsafe condition.
  - F. Call "Cease Firing" if a firing line becomes staggered (one shooter forward of another) anywhere on the range complex.
  - G. Use appropriate ear protection.
  - H. Wear appropriate eye protection.
  - I. Notify any RSO, Coaching Staff or Board of Director of any safety infractions.
  - J. Police all brass, paper, and other debris that accumulates on the range. Dispose accordingly in containers provided.
4. **AUTHORIZED AND PROHIBITED FIREARMS:** Fully automatic firearms are not authorized.
5. **AUTHORIZED PARTICIPANTS:** The following participant(s) are allowed to fire:
  - A. Current members of the Los Banos Tiger Trap Team.
  - B. Invited guests of the above, provided a RSO is present or Coaching Staff.
  - C. Member assumes full responsibility for the conduct of their guest(s).  
All guests must be approved to shoot by a RSO, on case-by-case-bases, prior to shooting.
6. **PERSONNEL RESPONSIBILITIES:**
  - A. **SHOOTING CLUB RSO(S):** must first approve anyone desiring to become a Los Banos Tiger Trap Team RSO by a majority consensus of current Coaching Staff upon review of applicant.
    1. Present current identification card in the following areas of NRA Credentials such as: RSO, Coach-Instructor, Coach.
    2. Obtain any special instructions
    3. Know location of First Aid Kit and Fire Extinguisher
    4. Conduct range inspection.
    5. Conduct range safety briefing using Appendix (3).
    6. Conduct live fire in accordance with this chapter. Failure of shooters to abide by procedures listed in this chapter will result in immediate eviction from the range and possible suspension of future shooting privileges. Report all incidents to the RSO.
    7. Turn in all borrowed gear.
  - B. **SHOOTING CLUB MEMBERS:**
    1. All shooters must check in with designated RSO on the scheduled range.
    2. All shooters and spectators must fill out "hold harmless" agreements.
    3. Shooters will conduct themselves in an orderly manner at all times and will be responsible for the conduct of any guests they bring.
    4. All shooters are responsible for their guns and ammunition while at the complex.
    5. Firearms that are out of the case and not being fired must be on a rack (actions open, chambers empty, with muzzles pointing up).
    6. Only load firearms on the firing line after the RSO or Coaching Staff has given command to load.
    7. Do not point firearms at anything other than authorized targets.
    8. Fire at your own target only.
    9. Give the command "Cease Firing" if an unsafe condition exists.
    10. Follow all instructions from the RSO or Coaching Staff at practice.
    11. Assist in policing the area of brass and any other debris.
    12. No pets allowed on the ranges.
7. **HOURS OF OPERATION:** Club practices on Thursdays, hours set by Coaching Staff.
8. **ALCOHOLIC BEVERAGES OR DRUGS:** Shooters may not consume alcoholic beverages or drugs (including prescription or over-the-counter medications) before or during live firing. The RSO may deny access to anyone in violation.
9. **MEDICAL SUPPORT:** In event of a medical emergency call **911**, and notify a RSO or Coaching Staff immediately.

### -CONSENT & WAIVER FORM-

#### PARENTS/GUARDIANS & ATHLETES: (PLEASE READ CAREFULLY)

In exchange for and as a condition of being allowed to participate in the Los Banos Tiger Trap (herein known as LBTTT) clay target program, Athletes and Athlete's parent or legal guardian, if Athlete is a minor child(ren), (hereafter referred to as the "Party" or "Parties"), agree to the following:

1. The Parties acknowledges that the LBTTT clay target program is a team-based program that provides team and individual competitions in the clay target sports which involve the use of FIREARMS. Failure of Parties to adhere to safe handling and use of firearms at all venues and locations may be grounds for removal from the LBTTT program.
2. The Parties request to participate knowing and understanding, that there are risks, and dangers associated with the use of Firearms, including but not limited to, serious bodily injury, death and property damage. The Parties agrees to assume all risks, inherent or otherwise, that may occur during, arise out of, or be about the Parties participation, including without limitation the risk of serious bodily injury, death and property damage. The Parties further agree to assume all risks, inherent or otherwise, fore-seen or unforeseen, that may occur due to, arise out of or be in connection with the participation of others in the LBTTT program, including without limitations, other competitors; instructors/coaches; staff or volunteers of involved organizations and individuals. The Parties acknowledge and agree that it is not possible to list all the risks Parties may encounter by participating in the LBTTT program. There may be risks that are not known to the Parties, or to others involved in the LBTTT program, including staff or volunteers of involved organizations, and may not be foreseen or reasonably foreseeable by anyone at this time of the activities in which Parties participate.

**NOTE:** *Please be advised: it is not possible to list all the activities and related risks that may be encountered by participating in the LBTTT program. Therefore, Athlete agrees to assume all risks associated with in the act of participation in the LBTTT program, et al. ( Including 2022 Ammunition Laws)*

3. Athlete further covenants not to sue and agrees to release , waive, and discharge the LBTTT Officers/Directors/Board Members, Instructor/Coaches, volunteers, and any acting agents, (collectively, "Released Parties) harmless from any and against any and all claims and demands, actions, suits, proceedings, liabilities, damages, losses, judgments and expenses (including reasonable attorney's fees and costs) by third parties (including Athlete's own family/Guardian) for any bodily injury, death or property damage or other incident occurring due to, arising out of or in connection with Athlete's willing and own participation or conduct (negligent or otherwise) to other athletes in the LBTTT program, including without limitation, the conduct (negligent or otherwise) of the Released Parties.
4. Fully allowed by law, Athlete agrees to defend, indemnify and hold LBTTT Officers/Directors/Board Members, Instructor/Coaches, volunteers, and any acting agents, harmless from and against all claims, demands, actions, suits, proceedings, liabilities, damages, losses, judgments and expenses (including reasonable attorney's fees and costs) by third parties (including Athlete's own family/Guardian) for any bodily injury, death or property damage or other incident occurring due to, arising out of or about Athlete's own participation or conduct (negligent or otherwise) in the LBTTT program.
5. Medical Attention: Athlete gives his/her consent to LBTTT Officers/Directors/Board Members, Instructor/Coaches, volunteers and any acting agents, of any LBTTT program event to provide, customary/emergency medical/athletic training attention, transportation and emergency services as warranted during participation in the LBTTT program.
6. Athlete grants to the LBTTT program, Sponsors and involved/affiliated organizations a **royalty-free** permission to reproduce, publish, distribute, or otherwise use in any reasonable manner Athlete's name, photograph, likeness and statements about the promotion if the LBTTT program, in all media forms, including but not limited to: Internet, news articles, advertisements, or other electronic or print materials. Athlete further covenants not to sue and agrees to waive, release and discharge LBTTT program Sponsors and involved/affiliated organizations, and all of their respective Officers/Directors/Board Members, Instructor/Coaches, volunteers and any acting agents, from and against any and all claims, demands actions, suits, proceedings, liabilities, damages, losses, judgments, and expenses (including reasonable attorney's fees and costs) arising out of or in connection with the use of the Athlete's name, photograph, likeness and statements, including without limitations, and all claims for invasion of privacy, publicity,

defamation and/or portrayal in a false light, copyright infringement, and any claims and/or demands for compensation, royalties or any other fees attributed to/arising from.

7. Athlete's signature below indicates that Athlete has read and fully understands and acknowledges this entire CONSENT & WAIVER and that it shall be binding upon Athlete, his representatives, heirs, assigns and next of kin.
