1.0 INTRODUCTION

Model: PIPE SPEAKERS 266

System Definition:

AA SYSTEM: The two speakers (Left/Right) purchased are regular 5V powered speakers.

AB SYSTEM: The two speakers purchased with one Bluetooth enabled “LEFT” speaker, eBULLY refers to this type of speaker, type B. The other “RIGHT” speaker is non-Bluetooth regular 5V powered speaker, type A.

Wattage: 2 x 5W (LEFT/RIGHT CHANNEL)

Bluetooth: 5.0 or below

2.0 FEATURES

2.0.1 Colorful lighting effects: (Patent pending)

Both type A and type B speakers are capable to display multitude of lights according to your music rhythm. RED is used to show LOW frequencies, GREEN to show MID RANGE and BLUE for HIGH frequencies. Music produces multi frequencies are mixing these three primary light colors to form different colors.

2.0.2 Special RCA Connections: (PLEASE READ)

Both type A and type B speakers have two connectors: A power jack and a RCA connector. The differences between the type A and type B are the following:

- 1) Type A is a non-Bluetooth speaker where its RCA jack is the audio **IN** for the speaker. Connect your music source to this RCA jack.
- 2) Type B is a Bluetooth speaker where its RCA jack is the audio **OUT** of the Bluetooth RIGHT channel. Connect the type B RCA to type A RCA allowing the “RIGHT” channel to be played on Type A speaker. See figure 2 for connection diagram.

2.0.3 Type B speaker position (ONLY FOR AB SYSTEM)

Place the type B speaker on the “LEFT” side, if you have purchased the AB system, and the A type on the “RIGHT” side. See figure 1 Below:

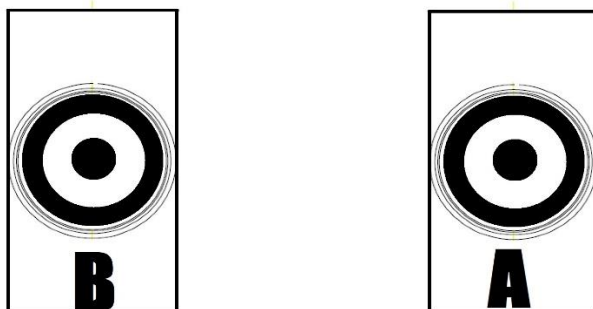

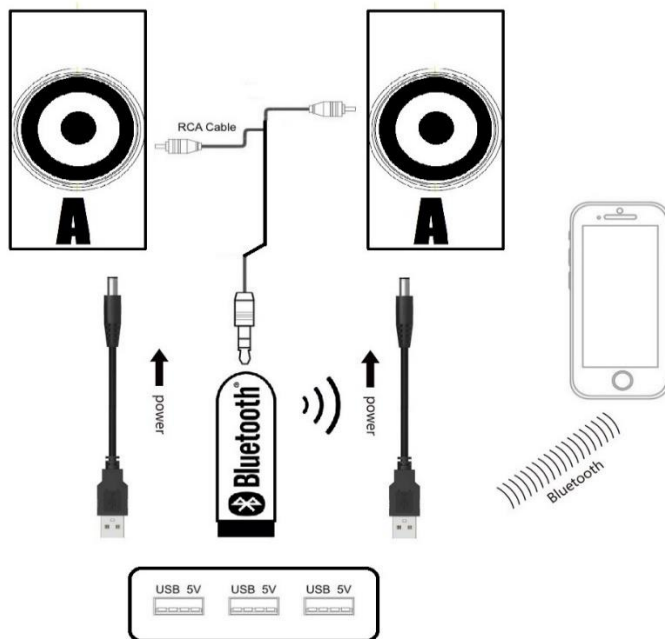
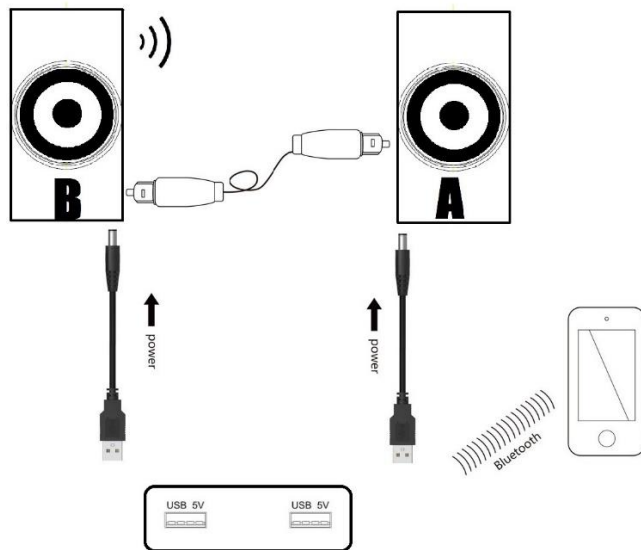

See below for how to connect the AA system speakers to your home entertainment center.

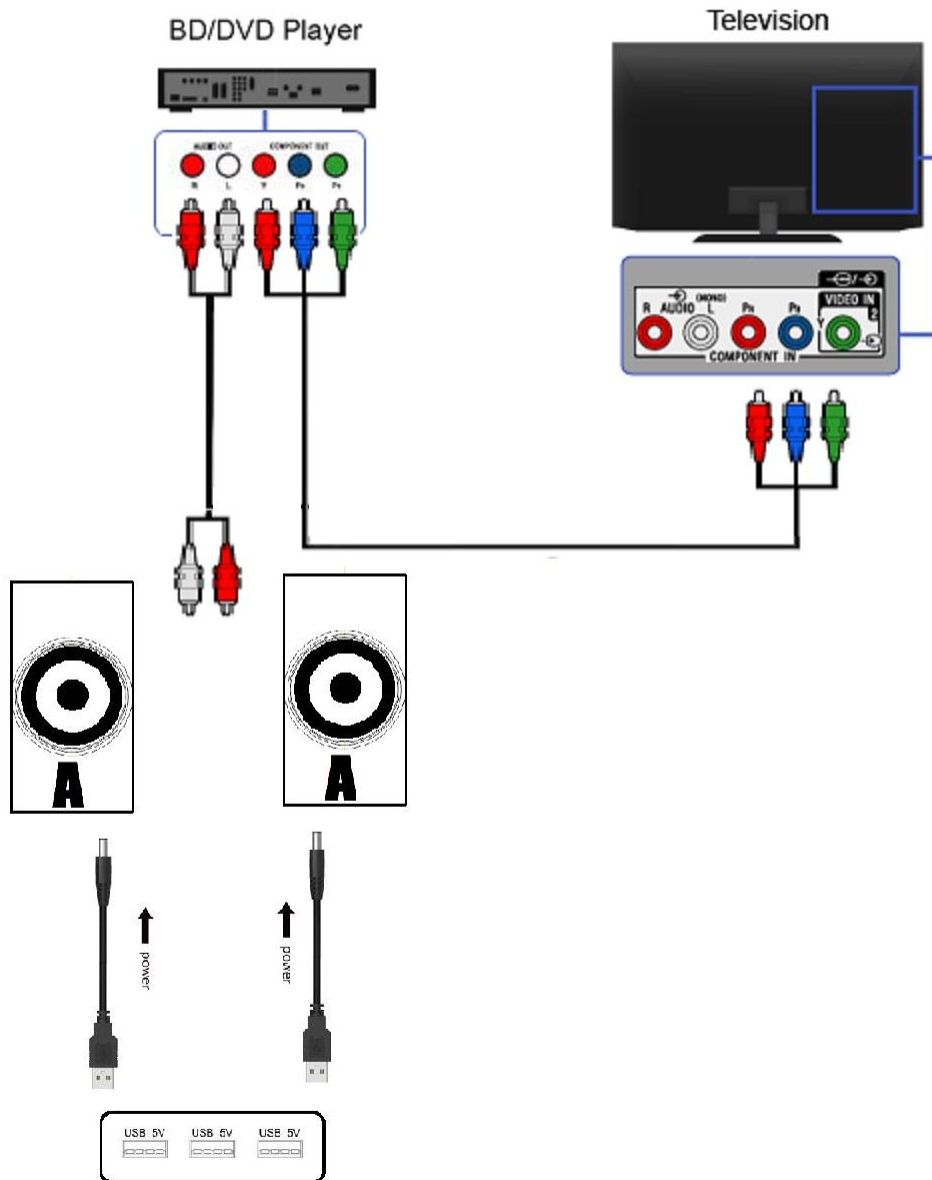
