1. Who We Are

2. Information We Collect

We may collect the following personal data from you:

Identity Information – Full name, date of birth, proof of ID (e.g. passport, driving licence), utility bill etc

Contact Information – Address, phone number, email address

Payment Information – Bank details or card information (for processing transactions)

CCTV Footage – Continuous recording for safety and security

Access & Usage Logs – Records of entry, unit use, and communications

3. Why We Collect Your Data

We collect and process your data to:

Set up and manage your storage agreement

Process payments and manage invoices

Maintain site and customer security (including CCTV and access records)

Communicate with you regarding your rental



Comply with legal and regulatory requirements

4. Legal Basis for Processing

We process your data based on the following legal grounds:

Contractual necessity – to provide the storage services you have requested

Legal obligation – for compliance with tax, insurance or legal reporting

Legitimate interests – including security monitoring and fraud prevention

Consent – where you have opted in for marketing or other communications

5. CCTV Monitoring

Our site is monitored by 24/7 CCTV. Footage is stored securely and only accessed for legitimate purposes such as investigating incidents or law enforcement requests.

6. Who We Share Data With

We do not sell your data. We may share it with trusted third parties under strict confidentiality, including:

Professional advisors (e.g. accountants, insurers, legal representatives)

Payment processing providers

IT and software support companies

Law enforcement or government agencies (when legally required)

7. Data Retention

We retain personal data only for as long as necessary:

Contracts and billing information – 6 years after the end of your agreement

CCTV footage – typically retained for up to 30 days unless an incident requires investigation

8. Your Rights

Under data protection law, you have rights to:

Access the personal data we hold about you

Request correction of inaccurate or incomplete data

Request deletion of your data (where legally possible)

Restrict or object to processing in certain circumstances



Withdraw consent for marketing communications at any time

We implement strong technical and organisational measures to protect your data, including:

Encrypted systems and secure servers

CCTV security

Access controls for staff

Regular data backups and monitoring
