§22-5-930(B)	Drugs: Possession with Intent to Distribute (PWID), 1 st offense <i>(does not include distribution, which is different)</i>	No new convictions for <u>20 years</u> from date <u>sentence is completed</u>	\$250 – solicitor’s office \$35 – clerk of court \$25 – SLED = \$310 total
§63-19-2050	Juvenile records <i>(does not include offenses carrying 5+ years and/or violent crimes)</i>	Completion of sentence + no pending charges/further convictions	None, but government may oppose this
