NCRC BY-LAW FOR TERMINATION OF A MEMBER or NON-MEMBERS

The officers have the right to ask anyone that is disrupting the harmony of a NCRC activity to leave the grounds of that show. If this person refuses, the officers have the right to call the appropriate authorities to escort this person off the grounds.

Grounds for suspension or expulsion from NCRC:

- 1. Any unsportsmanlike conduct by an Association member or non-member toward any judge, steward, timer, gate-keeper, director, officers, spectator, or any other member.
- 2. Anyone who acts against the rules of NCRC.
- 3. Anyone who makes any willful act to cause harm or destruction to people or property.
- 4. Anyone being in possession of any drugs or alcoholic beverages during any NCRC scheduled activity or arriving under the influence.
- 5. Anyone who displays conduct or attitude that is disruptive to the mission and/or harmony of the Association.
- 6. Anyone who is mistreating or abuse of a horse.
- 7. Anyone who abuses the Association's privileges or bringing discredit upon the Association.
- 8. Or any other infraction that the officers or Board of Directors deems harmful to the Association.

NORTH COUNTRY RIDING CLUB RIDER RELEASE

Liability: I hereby enter all riding lessons, events, shows, etc. realizing that riding is a dangerous sport. I further agree that if any damage or loss be occasioned to any horse, rider, vehicle, attendant, or article, I will make no claim therefore against North Country Riding Club, their agents, volunteers, or assistants. I agree to indemnify all claims or demand rising out of any injury to any person, or horse, or damage to any property caused to or by my horse, leased horse, or borrowed horse, attendant or self. I agree to follow all rules and regulations set forth by any activity administered by North Country Riding Club and their agents. Proper equine approved helmets must be worn by people under the age of 18 for all riding activities. All others are strongly encouraged to wear helmets while riding.
