Approved bitches must have good temperament. We will not service a bitch that shows shyness, aggressive behaviors or is not approachable.
Buyer:
Approved bitches must have vaccination up to date, including a clear Brucellosis test. Certificate must be sent to Boss Crown Bullies prior to breeding session and approved . Certificate/note of approval can be given.
Buyer:
Litter sizes may vary due to multiple factors outside of viable semen. Due to this fact, the STUD owner is not obligated nor offering any guarantee to the size of the litter produced, as a result of this breeding.
Buyer:
If less than two (2) live and are healthy puppies are produced, a second breeding will be provided to the same bitch (at zero additional charge for the stud fee) within one year of this whelping. The bitch's owner will be responsible for any additional semen collection and shipping expenses.
Buyer:
The Stud owner has a right to request documented proof from a licensed veterinarian of all breeding that resulted in less than two live and healthy puppies, failure to conceive. Documentation may include:
 Ultrasounds results completed at a 30-35 days from breeding date by a licensed veterinarian.
 A clear copy of an X-RAY completed at a 50-55 day from dreading date, by a licensed veterinarian
 All documentation must include bitch name, date of birth, identifying colors or marks, date that was completed, be written or typed with the veterinarian information/practice in the letter head. This <u>MUST</u> be emailed to <u>bosscrownbullies@hotmail.com</u>
