# Boss Crown Bullies responsibility

- Provide Co-owner with information of puppy.
- Provide a health checked by a licensed vet to the co-owner.
- Provide all information needed for dietary restriction/allergies for the dog best interest.
- Always keep in contact with the co-owner. Home visits or Facetime
- Help choose the co-owner with a vet of choice.
- Support with information in training for the best interest of the puppy.
- Pay for all vet expenses related to breeding.
- Information on what to expect when a female will be pregnant.
- Breeder will take the co-owner puppy back if any reason the co-owner is no longer able to keep guardian dog until the end of the contract.

## **Co-owner responsibly**

- The co-owner agrees to feed \_\_\_\_\_\_ dog food until the contact is completed.
- The co-owner will ensure all vaccination is up to date.
- The co-owner agrees to train the puppy to Boss Crown Bullies standard.
- The co-owner must keep the Boss Crown Bullies dog in close supervision at all times.
- The co-owner must always maintain physical control of the dog.
- The co-owner must keep the dog confined when going outside.
- All health records, pertaining to Boss Crown Bullies co-owner dog must be available to both.
- The co-owner must communicate with Boss Crown Bullies when dog is in heat.
- The co-owner must remain in contact with boss crown bullies.
- Provide adequate exercise for the dog on a daily basis.
- Consult Boss Crown Bullies when first sight of illness comes up.
- Deliver dog to Boss Crown Bullies when needed.
- Keep the dog well-groomed at all times.

# Other

## Removal

Boss crown bullies reserves the right to remove the dog from the possession of the coowner said above for non-compliance of this agreement.

# Accidental breeding

Any accidental breeding must be reported to Boss Crown Bullies immediately. Co-owner:

Accidental breeding will cause significant harm to boss crown bullies. A penalty fee of \$20,000 must be paid to Boss Crown Bullies immediately.

- Co-owner absconds with the puppy/dog, fails re advice Boss Crown Bullies any of the changes in the co-owner address or lastly ceases communication with Boss Crown Bullies.
