### Non-Breeding agreement/contract

**Non-breeding agreement:** *The buyer agrees that this puppy is being sold as a family companion, not for breeding purposes. Rescinding the Non-breeding Agreement requires the consent of both the Seller and the Buyer. If this puppy is bred and/or produces a litter(s) the Buyer is responsible to the Seller for breach of this contract and agrees to pay damages to the Seller. If the Seller sees i.e, social media, newspaper, website, marketplace, or any other selling platforms and/or hear that the buyer is breeding and/or selling litter(s) of any monetary amount, the Seller will file a lawsuit against the Buyer for financial damages. Buyer agrees that the ownership of this puppy is transferred by the buyer that the Non-breeding Agreement contract remains in effect.*

The breeder reserves the right to a second opinion veterinarian if puppy has serious physical condition.

The breeder guarantees the health of the puppy upon delivery once the purchaser assumes ownership.

The buyer shall maintain the pup with the description above in good condition, including to a regular immunization record.

The breeder has started socialization process, the purchaser's responsibility that the puppy is raised and properly socialized, obedience class and efforts must be made to ensure the continued development of proper behaviour.

### Life-threatening diagnosis

If the puppy exhibits a life-threatening or severe life-altering condition which would cause the puppy to be euthanized and is the result to a genetic defect, breeder will respond:

- Purchaser must notify breeder within 24 hours of vet diagnosis or this contract is voided.
- Vet records documenting the condition of the puppy must be provided by the purchaser's expense. [bosscrownbullies@hotmail.com](mailto:bosscrownbullies@hotmail.com)
- The breeder may require an examination by a vet chosen by the breeder.
- In the case that the animal is already deceased, the breeder will require that a complete autopsy be performed to gain the cause of death. Documentation must be forwarded to the breeder at the purchaser's expense.
- Before euthanasia is administered the breeder must be consulted or the contract is voided.

The purchaser shall not sell the puppy/dog to any individual or establishment in the business of buying and selling puppies for a profit or experimentations.

If the puppy is used for any of the above purposes the purchaser gives the breeder the right to enter any property, the pup/dog is on to repossess the pup/dog on the grounds.

The purchaser agrees to not sue the breeder should the breeder have to repossess the pup that was brought up in a false pretense.

The buyer is agreeing to not breed said pup at any time, unless changed by Boss Crown Bullies.

By this signature below, I agree to have this dog microchip # \_\_\_\_\_ spayed/neutered by no later than \_\_\_\_\_, and I understand that this spay/neuter is an agreement that this dog will not produce a litter of puppies either as purpose or by accident. I also agree to disclose spay and neuter information with Boss Crown Bullies once the spay/neuter is done by said date. I also agree that should puppy not be altered, and I will return said puppy back to Boss Crown Bullies.

The breeder shall not be held responsible for the development of any confrontational faults as a puppy grows, even purchasing for showing there are no guarantees that a puppy sold as show will prospect as expected.

Ownership of the dog is not transferable to any other party. If at any point the buyer is no longer able to keep or care for the puppy/dog. The buyer agrees to first contact the breeder.

Any **violations and/or breach of this private agreement** will constitute the agreed amount set of fines as follows:

**\$20,000.000** fine for **each** breeding breach.

The breeching party is responsible for all legal expenses. If this puppy is bred while this private agreement is in effect, ownership and physical possession of the dog, microchip# \_\_\_\_\_, shall immediately revert to the breeder with no compensation to the buyer.
