Airbrush Makeup- makeup application that gives you the opportunity to have multiple layers for desired coverage for a very natural, soft effect. Strip lashes are included. \$150

*Mink Lashes are an additional \$30

HAIR:

Bridal Hair Trial (60-90 mins)- A time to choose the exact look you want, so that on your wedding day, it can be mastered and applied efficiently. \$80 (Weekend trial \$100)

Bride Hair- An elegant style for your special day, this includes a smoothing treatment, blowout, style and placement of veil and/or hair accessories. \$160

Bridal Party Hair Elegant- An elegant hairstyle for your bridal party (does not include a blowout). \$80

Bridal Party Hair Natural- Curls only, no pins, no updo, no hollywood waves. \$65

Junior Bridesmaid Hair- An elegant style for a special occasion. (Under age 10) \$40

Travel Fees- Price is per stylist/artist; varies based on location.

Early start (before 8am) will require an additional fee of \$25 per stylist/artist.

Hair instructions for the Bride:

- We highly recommend a Hair Styling trial. If you choose to NOT have a trial, we do NOT GUARANTEE your hair will come out the way you have envisioned it on your Wedding Day.
- When you don't have a trial, and the hairstylists have to redo your hair more than once it can cause your hair to be limp as well as the curls may drop.
- Please have 2 different ideas for your hairstyle. The weather can cause limp hair as well as curls may fall quickly.
- Please arrive to the trial with freshly, showered, clean, hair and no product or oils in it. **If it is not squeaky clean we will not work on your hair. (No dry shampoo)**
- Please bring pictures to the trial of how you are envisioning your hair to be.
- Please bring accessories that you will be using for your Wedding Day to the trial.
- Ask your hairstylist if you should use conditioner or not on the day of the wedding.
- Ask your stylist if extensions are good for the hairstyle that both you and the hairstylist agree on.
- On your Wedding Day, please come with freshly, showered, clean, wet hair and no product in it. **If it is not squeaky clean we will not work on your hair. (No dry shampoo).**

Hair instructions for the Bridesmaids/Flower Girls/Mother(s)/All other wedding party:

- A trial is not required
- Have 2 different hairstyles in mind in case of unforeseen weather changes, or the amount or type of hair you have.
- Please bring pictures of how you are envisioning your hair to be.
- Please come with freshly, showered, clean, air dried hair with no product or oils in it. **If it is not squeaky clean we will not work on your hair. (No dry shampoo)**
- Inquire about extensions if you have thin hair and you want to achieve a hairstyle that has more thickness to it.
- If you have fine/straight hair, and you know your hair does not hold a curl well, do not use conditioner.
- If you have curly/thick hair and your hair holds a curl well, you may use conditioner but watch the amount you use.
- Do not flat iron your hair.
- Do not have any product your hair.

Makeup:

- We highly recommend a Makeup trial. If you choose to NOT have a trial, we do NOT GUARANTEE your makeup will come out the way you have envisioned it on your Wedding Day.
- Please come with a clean face with no sunscreen on.

Please have pictures of makeup that you are envisioning.

**We ask that you bring only 1 other guest to your trial. Depending on the day, it can get very busy and hectic. There is limited seating. Thank you in advance.
