Update on Cover with Parcel Post Postage Due Stamp

Back in the March 2023 issue of the newsletter I included an article about a 1914 cover assessed 1¢ postage due for which payment was confirmed using a U.S. parcel post postage due stamp (Scott JQ1). The cover is shown in Figure 1. It was annotated in German by the sender as containing "Briefkarten" (post cards). I speculated whether the use of the parcel post postage due rather than a regular postage due stamp had any connection to the class of mail. Fourth-class and parcel post rates applied to any items that were neither first-, second-, nor third-class. The fourth-class and parcel post rates at the time were one cent per ounce up to four ounces, then five cents for the first pound, with zone variations. Two-ounce, fourth-class matter might fit the rate characteristics of this cover; however, my initial thought was that it is unlikely because post cards in an envelope, with or without a written message, could have been included in first- or third-class, respectively. Also, as of July 1, 1913, parcel post and parcel post postage due stamps became valid for use in conjunction with other classes of mail. Therefore, I was inclined to discount the use of the parcel post postage due as being connected with other than first class mail in this case and believed that the use of that stamp was incidental. However, that was an incorrect conclusion.

One of the things that I didn't mention in the article was the cancel on the parcel post postage due stamp. The cancel is a New York duplex handstamp dated May 25, 1914, with the abbreviation "M.I.&R." at the bottom of the dial. A close-up cropped image of the handstamp is shown in Figure 2. John Hamman emailed me with a comment



that perhaps the "M.I.&R." in the cancel might provide a clue about why there was additional postage necessary. As it turns out, it is also a clue as to why a parcel post postage due stamp was used instead of a regular postage due stamp.

Update on Cover with Parcel Post Postage Due Stamp (Continued)

I was unfamiliar with the abbreviation "M.I.&R." I contacted Charles DiComo, President of the Empire State Postal History Society (ESPHS). Charles queried the membership and replied to me with information on "M.I.&R." handstamps in Ray Porter's *New York City Cancellations* exhibit found on Richard Frajola's *Phila Mercury* website. The exhibit shows an 1894 cover with a postage due stamp cancelled with an "M.I.&R." duplex, reproduced here in Figure 3. Also on the

Phila Mercury message board, Leonard Piszkiewicz posted a New York Times (NYT) article which indicated that the abbreviation meant "Mail Inspection and Rating," and the handstamps were used by the New York City Post Office department of that name.

According to the August 6, 1895, *NYT* article, a suspicious package was addressed to Theodore Roosevelt, President of the Board of Police Commissioners in New York City. This is the same Theodore Roosevelt who would subsequently become President of the United States. According to the article, the package was discovered by an individual at the "Mail Inspection and Rating Department of the (New York City) Post Office." The article stated that the function of the department was to "examine fourth class mail packages."

It stands to reason that because of the notation stating that the it contained postcards, the cover in Figure 1 was sent to the Mail Inspection and Rating Department under the assumption that it was fourth-class mail. There it was assessed 1¢ postage due as fourth-class mail; upon payment of the deficiency a parcel post postage due stamp was affixed and cancelled with the "M.I.&R." handstamp. Therefore, it appears that this was, in fact, *not* a case

where a parcel post postage due stamp was used incidentally after all. Rather, the item was most likely considered to be fourth-class mail (or parcel post). Thanks to John Hamman for his inciteful comment that spurned on the additional research, and to Charles DiComo, Richard Frajola, Leonard Piszkiewicz and the ESPHS for their assistance.
