\_\_\_\_\_ **NDS Missed Classroom Session Policy**

According to NDS policy, students are not permitted to miss more than 6 scheduled classroom sessions. All missed sessions must be made up. If a student misses more than 6 classroom sessions, they will be automatically unenrolled from both the classroom and drive sessions. In this case, the student will be required to re-register for another class and pay a re-take fee of \$425. This fee covers repeating all classroom and driving sessions from the beginning.

\_\_\_\_\_ **6-Month Completion Policy**

To complete the course, all students are required to finish the following within six months of their start date: all 17 classroom sessions, a minimum of 5 drive sessions, at least one hour of driver observation, pass the course final exam with a score of 70% or higher and pay all tuition and fees in full. If you don't meet these requirements within the six-month period, you may have to repeat the course at your own expense.

\_\_\_\_\_ **Payment**

Payment is due before the first-class session. If you have a balance on your account, you will be limited on how many drives you can schedule. If a third party is paying it is your responsibility to let NDS know the information.

\_\_\_\_\_ **Electronic Devices**

To ensure a focused learning environment, all electronic devices, including cell phones, must be turned off before entering the classroom or instruction car and remain off for the entire session, including breaks. Any violation of this policy will result in an absence for that session, and the student will be required to retake it. Continued violations may lead to expulsion from the course.
