The ABC's of the Birthright.

The simple facts.

The owner of the birthright is called the Donor. The donors right is able to be given to another as a interest or use. However that use can only be reclaimed by the original donor by reversion.

In a birthright use there are four parties

A (the man/woman as the original Donor ) B (the Monarchy as the Donee ) C (the government as the administator for the donee) D ( the citizen also called the trustee)

A (the man or woman as the original Donor ) gave to B (the Monarchy) consent to form a trust account at the time of application for a birth certificate.

The Monarchy "B" as trustee allows creation of "C" the government to act as administer of the trust according to law.

This is where you enter the transaction again, either as the competent Donor returning to claim his birthright or "D" "citizen" and subject to "C", the government.

As "D" in capacity of the citizen, you must apply to "C" for permits or licenses for use of the trust property you previously donated and now is legally controlled by B.

If instead, you would known about the law of reversion you may of chosen to redeem your birthright and used your authenticated certificate to claim the land where you wanted to live.

As it is now, you have probably not reclaimed your birthright, so have been presumed to be a citizen subject by having accepted the trust agreement by tacit acquiescence.

So what can you do now that you know you have a birthright waiting to be claimed?

So you fit in as either a trustee (holder) of property of the man king (man's system) or as a child of the creator with him and him only as your king and Savior being saved from the false leader or the man king and his fate.

So now that the life questions are answered let look into why the birthright is so important and why the world is like it is today what happened and why?

We of course must start with the creator because he is the alpha and omega the beginning and the end. The creator of all we see so it all comes down from him

### A Brief summary of the history of the loss of the Birthright

The creator created the first man from the dust of the land and gave them rules to live by and prosper all were content and happy. We came form the land like everything else on earth. Elemental elements are our makeup.

Then a deceiver entered the scene and of course promised a better way that there was much more to learn and be able to do and promised to teach if you would only follow him

The people Adam and Eve fell for the story and transgressed god law and partook in the forbidden knowledge. This transgression or SIN lead to their being expelled from their fathers land of Eden for transferring their loyalty to the deceiver, so their birthright from the Father to his land land was removed until their transgression against god law was forgiven. Only problem was no one was able to forgive them except god and he could not abide sin meaning transgression of his law . So they were out until they realized the error of their ways and sought god once again , then he would make a way for their sin to be forgiven.

So they were given and extended life time of like 800 years before they died or made peace with god and had to make it on their own working for all they received . Their birthright was then held in abeyance till preparations were made for it to be reverted back to them by their acceptance of God again and redemption by their near kinsman. A near kinsman was a family member related by blood (jus sangiuinus) who could pay the penalty to reverse the charges and set things right again.

So over time the people grew in number and had family's and grandchildren etc but without god they soon found they needed a leader to organize and keep order among the people so this is where they asked the prophets of god for a Man-king. A Man-king was just that he was one of the men chosen to be the king over the people as they still thought they new better than the creator and could rule themselves so god granted their wish as we read in 1 Samuel 8King James Version (KJV)

1 And it came to pass, when Samuel was old, that he made his sons judges over Israel.

2 Now the name of his firstborn was Joel; and the name of his second, Abiah: they were judges in Beersheba.

3 And his sons walked not in his ways, but turned aside after lucre, and took bribes, and perverted judgment.

4 Then all the elders of Israel gathered themselves together, and came to Samuel unto Ramah,

5 And said unto him, Behold, thou art old, and thy sons walk not in thy ways: now make us a king to judge us like all the nations.

6 But the thing displeased Samuel, when they said, **Give us a king to judge us.** And Samuel prayed unto the LORD.

7 And the LORD said unto Samuel, Hearken unto the voice of the people in all that they say unto thee: for they have not rejected thee, but they have rejected me, that I should not reign over them.

8 According to all the works which they have done since the day that I brought them up out of Egypt even unto this day, wherewith they have forsaken me, and served other gods, so do they also unto thee.

9 Now therefore hearken unto their voice: howbeit yet protest solemnly unto them, and shew them the manner of the king that shall reign over them.

10 And Samuel told all the words of the LORD **unto the people that asked of him a king.** 

11 And he said, This will be the manner of the king that shall reign over you: He will take your sons, and appoint them for himself, for his chariots, and to be his horsemen; and some shall run before his chariots.

12 And he will appoint him captains over thousands, and captains over fifties; and will set them to ear his ground, and to reap his harvest, and to make his instruments of war, and instruments of his chariots.

13 And he will take your daughters to be confectioneries, and to be cooks, and to be bakers.

14 And he will take your fields, and your vineyards, and your olive-yards, even the best of them, and give them to his servants.

15And he will take the tenth of your seed, and of your vineyards, and give to his officers, and to his servants.

16 And he will take your menservants, and your maidservants, and your goodliest young men, and your asses, and put them to his work.

17 He will take the tenth of your sheep: and ye shall be his servants.

## 18 And ye shall cry out in that day because of your king which ye shall have chosen you; and the LORD will not hear you in that day

19 Nevertheless the people refused to obey the voice of Samuel; and they said, Nay; but we will have a king over us;

20 That we also may be like all the nations; and that our king may judge us, and go out before us, and fight our battles.

21 And Samuel heard all the words of the people, and he rehearsed them in the ears of the LORD.

22 And the LORD said to Samuel, **Hearken unto their voice**, and make them a king. And Samuel said unto the men of Israel, Go ye every man unto his city.

So as you can read above god granted them a King over them (our ancestors) to track all of their goods (by registration) and made them work to take care of the land and property (by work) that they gave to the king as the donors to establish the kingdom. Basically shifting all of their responsibility as governors of their own households and property in absolute ownership with no superior called allod or allodial ownership to the King in exchange for a title or use of the property they donated to the kingdom with the king as the legal (without God) title holder. With the people only retaining a use of the property.

This title (legal Name) they received from the Man-King was the receipt of the **warranty** issued by the system to reclaim the property from the king if they ever wanted to return to the creator as their King and ruler. Now to be clear, the people now when they received their title (name issued by the king) **they could then use the property** of all the donors given to the king in exchange for taking care of it so if any donor returned to claim the property they were using it would be in good and was not wasting away, the people therefore became trustees of the king as trusted subjects to care for the kingdoms property.

If the donor (any of us ) return to claim our property by right of this warranty the trustees or people holding that property would have to give it back to the donor (or become a disseisor ) no matter how many years had gone by the people could still come back to the loving God . As now the people in their capacity as a trustee of the Man-king they had rules to follow and where not allowed to keep donor property for themselves anymore but just owned a marketable interest as holders in the property which is why we are called tenants today on our deeds as we just rent owning only the right to sell the rental rights of the property

So as the years went by and the kingdom grew a great bureaucracy developed and records were kept of all the transactions happening to keep track of the donors property. As the years went by fewer and fewer donors where aware of this right of

reversion back to the owners of the property. As the Man-King had amassed a great kingdom with a military (to defend the people) and administrators (to keep records) and land mangers (to grow food on the kings property he held for the people) the people had become accepting of the Man -Kings role in their life as they could see the work being done around them to keep the kingdom safe and became normal to just rent an interest or fee-simple

But what did they give up in this transaction by wanting a Man-king instead of the creator God as their leader? The following explains how we all do the same thing today by selling our birthright for some promise by the Man Kings. Adam was the first man to trade away his birthright.

#### Adam was a man.

This means that he was made in God's image (Genesis 1:26). So was Eve. This means that Adam was God's first-born earthly son, **the lawful heir to the whole world**. God made it for man, and then He placed man over it (Genesis 1:28). All of it. It was man's lawful possession, so long as man remained faithful to God by obeying his law. He broke the rule not to eat of the forbidden fruit which opened this Pandora's box we find ourselves.

By this transgression of God s law Adam traded his birthright to Satan-not for a mess of pottage (a bowl of stew), the way that Esau sold his birthright to Jacob (Genesis 25:29-34). No, Adam traded it for a lie, or at least a half-truth: "You will be like God" (Genesis 3:5). Eve was just deceived in this transaction, though was disobedient; Adam knew exactly what he was doing (l Timothy 2:14).

What was God's response? To disinherit Adam. Because in pure truth he could not have transgressors on his land . He threw Adam and Eve out of the garden. But because he loved them , He clothed them in animal skins (meaning that some animal was first slain by God). He also gave them extra years of temporal life. But from that day forth, they were legally( without God) as disinherited children. So is every man or women when physical born. Made in God's image, we are born as disinherited children. Read more in the book by Gary North , Liberating Planet Earth

Read this over carefully again ! It is the birthright (land) given to us by creator god that we traded away in exchange for a man to rule over us! Why would we do this ? Lose the dominion over our lands and become servants of a trust set up by a Man-King. The trust the Man-King rules over is what we today call fee simple ( the fee is owed for use of the property of another the original donor to the Man-King) This is why the need for the law of reversion to re vest the promised land ! That was given away by us ( our ancestors ) as the original donors of the land ,the gift of God the garden of Eden .

Christ dying was to reclaim our birthright — our dominion over the earth ! Remember Adam had no redeemer so they had to sacrifice animals to try to offer blood for their sins.? But their still was no kinsman redeemer . The reversion of our land is representative of our being accepted and returning back into the promised land ! #### Birthright

In ancient times, the birthright was a very important and sacred thing. It belonged to the firstborn. The family name and land were to pass to the eldest son. He would also receive a double portion of the inheritance. But it was more than just a right to the physical assets of a family. It was also a spiritual position, and in the case of the people of God, God would lead the family through patriarchs, or fathers (Hebrews 1:1-2). Additionally, in the special case of Esau and Jacob, that meant the one to whom belonged the birthright was the one through who the covenant promise made to their grandfather, Abraham, would be realized. Ultimately, the Messiah Yahoshua (we call Jesus) would come through the holder of the birthright was his. But like many, he failed to appreciate its value and sacredness. Genesis 25:29-34 (KJV}

"...When Jacob had cooked stew, Esau came in from the field and he was famished; and Esau said to Jacob, 'Please let me have a swallow of that red stuff there, for I am famished.' Therefore his name was called Edom. But Jacob said, 'First sell me your birthright.' Esau said, 'Behold, I am about to die; so of what use then is the birthright to me?' And Jacob said, 'First swear to me"; so he swore to him, and sold his birthright to Jacob. Then Jacob gave Esau bread and lentil stew; and he ate and drank, and rose and went on his way. Thus Esau despised his birthright." (Genesis 25:29-34)

A birthright is called an estate at law. An estate is the account name set up by a government trust for holding your birthright inheritance until you reach the age of majority. [competence in law] could be seven years if a smart boy or girl.

The person holding the legal title in this way was called the *fcoffee* (to use) and the beneficiary was called the *cestui que use*, an old French Latin term, meaning "the one for whom the use was held." Once established, uses were employed for other purposes. Since the law of forfeiture of property for treason applied only to the legal title and not to the equitable "use", it became common for the nobility of England, who were frequently engaged in civil wars, to convey the legal title of their land to some humble noncombatant, to hold for the use of their families, and thus avoid the loss of their property to their families, if they should be defeated in war and afterwards tried and convicted of treason.

The King/Queen of England was always English up until 1066. William the conqueror was the first none English monarch in England and there has not been an English King/Queen since. The state (of London) took custody of everybody and their property into a trust, the state became the trustee/husband holding all titles to the people and property, until a living man comes back to reclaim those titles.

The trust was created by government by authority of the Monarch therefore legal title was held by the government of the area as legal owners with the men and women as the beneficial owners if they returned from the jurisdiction of the sea to claim their life estate

### Jurisdiction is acceptance of the agreement

Law is an agreement. BOTH PARTIES must agree or there is NO law. Law is created by the ownership or assumed ownership of the lands.Jurisdiction is acceptance of the agreement. Your (birth certificate ) is a indenture to you and a deed poll to the issuer. "conveyance" includes transfer, assignment, delivery over, payment, gift, grant, alienation, bargain, charge, encumbrance, limitation of use or uses of, in, to or out of real property or personal property, by writing or otherwise; (« transfert »)

"personal property" includes goods, chattels, effects, bills, bonds, notes and securities, and shares, dividends, premiums and bonuses in any bank, company or corporation, and any interest therein; (« biens personnels ») When conveyances declared void as against creditors

2 Every conveyance of real property or personal property and every bond, suit, judgment, and execution at any time had or made, or at any time hereafter to be had or made, with intent to defeat, hinder, delay or defraud creditors or others of their just and lawful actions, suits, debts, accounts, damages, penalties, or forfeitures is void as against such persons and their assigns.

Saving as to conveyances by tenants in tail

3 Where a conveyance made by a tenant in tail is impeached under section 2, it is nevertheless as valid as against the heirs in tail and all persons entitled in reversion or remainder as if this Act had not been passed.

Saving as to conveyances made bona fide and for good consideration

4 Section 2 does not extend to any estate or interest in real property or personal property conveyed upon good consideration and bona fide to any person not having, at the time of the conveyance to him, notice or knowledge of that intent.

How far valuable consideration and intent to pass interest to avail

5 Section 2 applies to every conveyance executed with the intent in that section set forth, notwithstanding that it may be executed upon a valuable consideration and with the intention, as between the parties thereto, of actually transferring to, and for the benefit of, the transferee the interest expressed to be thereby transferred, unless it is protected, under section 4, by reason of bona fides and want of notice or knowledge on the part of the purchaser.

25 "'If one of your fellow Israelites becomes poor and sells some of their property, their nearest relative is to come and redeem what they have sold. 26 If, however, there is no one to redeem it for them but later on they prosper and acquire sufficient means to redeem it themselves, 27 they are to determine the value for the years since they sold it and refund the balance to the one to whom they sold it; they can then go back to their own property. 28 But if they do not acquire the means to repay, what was sold will remain in the possession of the buyer until the Year of Jubilee. A custom during Abraham's time was the passing down of birthright blessings. A birthright is a native right or privilege—it is something to which one has a right, by birth. Second is the trust created in fee simple (in trust) by that donation and charged to protect that land right with an Exclusionary power of appointment" which means a power of appointment exercisable in favor of any one or more of the permissible appointees to the exclusion of the other permissible appointees

Third is the donee in whos name the donation of the life estate was given to use the estate for life for a period of time with a power of appointment to transfer it to another at will.

The key to the 3 levels is the relationship of the bearer of the power to the land right donated. pg 589 Remitter prevents circuity of action

A remitter is an operation in law upon the meeting of an ancient right remediable, and a later estate in one person without any folly in him, in this case the ancient right is restored, and the new defeasible estate ceased and vanished. And the reason hereof is, for that the law prefers a sure and constant right, though it be little, before a great estate by wrong which is defeasible: moreover the law (which abhors suits of vexation) ever voids circuity of action, for the rule is circuitus est evitandus, and it is observable that the remitter is of the later title to that which is more ancient, and when two rights descend there can be no remitter if one cannot be remitted to the other, and regularly to every remitter there are two incidents, viz, an ancient right and a defeasible title united together [in the same person in the same right]

Remitter operates on seisin in law and is preferred to infancy and coverture
