## - RULES AND REGULATIONS -

1. Contestants must be 21 years of age by registration of the National Pageant and must be able to show proof of age. You must be able to travel freely throughout the United States of America. If you do not have a Government issued ID or a Passport you will not be allowed to enter.
2. You must maintain a beard (facial hair) at all times during your reign.
3. Judging for America's Bearded Queen Pageant will be on a cumulative scoring system including the Top 5 Question & Answer. Any ties will be broken by the contestant with the highest talent score.
4. Contestants will be judged in the following categories:
  - Creative Presentation
  - Personal Interview
  - Creative Fashion
  - Talent
  - Top 5 - On Stage Question & Answer
5. Talent presentation will be limited to seven (7) minutes. Prop setup and knock down time will be limited to five (5) minutes total. Talent presentation will be timed at rehearsals. Presentations over seven (7) minutes will have administrative points deducted.
6. Any type of talent presentation is acceptable, except those that may cause injury to the audience or any other person. No excessive body or facial glitter, fire of any kind, water or liquids or confetti (including confetti cannons) may be used in your talent presentation. No live animals of any kind may be used in any talent presentation
7. The use of or dispensing of illegal drugs, including marijuana, will not be tolerated while participating in the America's Bearded Queen Pageant. Immediate disqualification could result for those that break this rule.
8. Any contestant, contestant's dancer(s), helper(s), etc. who is caught in the act of stealing or tampering with another contestants' possessions **will be immediately disqualified** and removed from the location of the pageant.
9. Bearded Pageantry Inc and America's Bearded Queen Pageant does not discriminate against contestants using silicone and/or hormones.
10. Bearded Pageantry Inc reserves the right to make any decision concerning any matter not covered by these rules and regulations.
11. America's Bearded Queen will be required to sign a contract with Bearded Pageantry Inc before **any** prize money is paid. Failure to sign the contract will mean forfeiture of the title. You can find a copy of this contract at the end of this handbook. Please review it so that you are familiar with it.
12. Any contestant in the top 5 not staying on stage for the entire crowning and picture taking will forfeit their placement and prize money.
13. Within 7 days of winning the pageant, America's Bearded Queen must have and maintain an social media page, email address and cell phone for the entire length of their reign.

## - ACCOMMODATIONS -

**There is NO host hotel for this year's pageant.** You are welcome to stay anywhere of your choosing but please make sure you are aware of the distance between the host bar and where you choose to stay so you are not late to any required meeting or check in.

## - ADMISSIONS -

Contestants do not have to pay admission to the Rose Room on EITHER night of competition. All dressing room assistants, dressers, dancers, prop personnel, managers, lovers, etc. must pay admission to the event. **Station 4 (S4) and the Rose Room is a 21 and over club.** All persons entering the venue **must have** a valid Government or State issued ID.

- Thursday night admission will be \$20.00
- Two Night Pass will be \$25.00 (available at registration only)

In addition to the prizes listed above, **Seferino Garcia Photography** will be presenting the Winner and 1<sup>st</sup> Alternate with a full photo shoot, Hobie Waits of **Nailed by Hobie 2.0** will be presenting the winner with a full set of custom nails, sashes will be provided by **Sash in the City**, and there will also be additional sponsors providing their services as part of the prize package.

**ALL winners must be prepared to present their ID and Social Security number** when receiving their prize money. All prize money will be distributed at a location to be announced following crowning.

## **- GENERAL INFORMATION -**

Remember to print this handbook out and bring it with you to the National Pageant. It has all of the information that you will need.

I would like to mention a point I want every contestant to take to heart. We all begin gathering once a year to select a new America's Bearded Queen. Bearded Pageantry Inc and staff wants your week to be a pleasant experience but, no damage to the Host Bar will be tolerated. I want everyone to understand that Bearded Pageantry Inc will help the host venue prosecute any person or persons causing any damage. Let's have a good, safe time!

Each contestant is responsible for ensuring that each person in his party has proper identification. **Everyone must have a valid state issued ID for entrance into the Host Bar.** Please do not come asking for special help. Each bar owner is responsible to his state liquor board to follow the law, which includes each person having the proper identification. **Everyone except the Contestants will be required to be wrist banded AND hand stamped at the door.** Judges will take into consideration the fact that persons on stage will be wearing wristbands and have a hand stamp when being judged.

## **- MEETINGS AND REHEARSALS -**

All contestants are expected to arrive for all meetings and rehearsals approximately ten (10) minutes before the scheduled time. Contestants who arrive for a meeting or rehearsal after the scheduled time will be penalized administrative points.

The contestant registration for the Inaugural America's Bearded Queen Pageant will be held on Wednesday, November 3, 2021 at 12:00 noon in the Rose Room at Station 4. At registration, all contestants will draw a contestant number, receive their contestant ID card, and be given a backstage/dresser pass (this will NOT allow entry into the venue – it will just allow them access to the dressing room). If you have more than one assistant, only one may enter at a time and must use the same backstage/dressers pass for dressing room admission.

## **- CREATIVE PRESENTATION – 1 – 10 points**

Contestants may model, perform or lip sync their Creative Presentations. No props or dancers (additional individuals) will be allowed on stage during your Creative Presentation. If you choose to lip sync your Creative Presentation please place your music on a flash drive as an MP3 format with your name and Creative Presentation clearly marked. You can also email your music (clearly marked) to [beardedpageantryinc@gmail.com](mailto:beardedpageantryinc@gmail.com) **Contestants will introduce yourself sometime during this category competition.** You are allowed no more than 3 minutes (it's not necessary to use the entire 3 minutes) total to present your Creative Presentation including your introduction.

**- PERSONAL INTERVIEW – 1 – 10 points**

Contestants will meet individually with the panel of judges who will question them on anything from personal issues to their professional life. Nothing religious or political will be allowed in Personal Interview unless a contestant brings it up first. This will be a timed category allowing up to 10 minutes per contestant (**if necessary**).

**- ON STAGE QUESTION – 1 – 30 points**

This category will be limited to the top five at the National Pageant only. It is not a category at the local, state or regional level. Questions will be given by the judges.

**- CREATIVE FASHION – 1 – 10 points**

Creative Fashion is open to anything from a full-length evening gown, creative evening gowns, traditional “suits” or anything creative fashion wise. Judges will be current with fashion and open to all types of creative fashion.

These cards will be handed out at Contestant Registration and filled out by the Contestants. You must fill this out legibly to be read by the MC during your Creative Fashion Category

**TALENT – 1 – 40 points**

Talent may be any type of entertainment presentation as long as it does not create any danger or injury to either the contestant or anyone else. No animals or reptiles may be used in your talent presentation. You may not use fire of any kind, confetti or confetti cannons, water, liquids or excessive glitter or facial glitter in your talent presentation. Talent presentation is limited to seven (7) minutes in length. Prop setup and tear down time is limited to seven (7) minutes. There is no restriction on the number of people or props that are allowed in your Talent presentation.

**Music or Videos for talent, along with your crowning number, can be submitted in advance. Submit to [beardedpageantryinc@gmail.com](mailto:beardedpageantryinc@gmail.com) by October 25, 2021.** All files must be saved using the following naming convention:

If you plan on using video, **format as MP4 or MOV using the naming convention above.** Other formats will not play and cannot be accepted. Optimal screen dimension: 16x9 wide screen. If you are using a simple graphic on the LED screen please format the size as 3148 X 1102 pixels.

MP3 (**music only**) files may be emailed directly while video files (MP4 or MOV) will need to be shared with [beardedpageantryinc@gmail.com](mailto:beardedpageantryinc@gmail.com) through Google Drive. Contestants are advised to make a backup copy of music/videos on a flash drive and to bring it as a safety precaution to rehearsal and the pageant. **Again, if you submit your music or video in advance it must be submitted by October 25, 2021.** If you find that you need to change your talent, substitutions may be made, when necessary, by submitting music/video on flash drive prior to your scheduled rehearsal. That will be the only time you may make changes to your talent music/video.

## TALENT REHEARSAL


**Each contestant MUST attend Talent rehearsal.** We have allowed a limited time in the schedule for individual contestant sound checks, blocking, and any curtain, fan or lighting cues. A technical form will be available at rehearsal for you to complete for the Stage Manager. Be sure you are well organized for this rehearsal as time is limited. We will also be timing the length of your talent presentation during rehearsal.

## DANCERS/PROPS

Back-up dancers will share the dressing area with contestants and will be allowed entry 2 numbers prior to yours unless the Dressing Room Coordinator allows them in the dressing room earlier. You should be prepared at the contestant meeting to confirm with the stage manager the exact number of back-up dancers and prop personnel you will require.

If you will be using any props for your talent presentation, you must bring those props to the venue at the rehearsal time. There will be a space designated for prop storage during the day. You may not bring any props in at any other time and you must remove all props from the club at the end of each night following your talent competition.

## STAGE DIMENSIONS



Competition for the America's Bearded Queen Pageant will be held in the Rose Room at S4 (left). The competition area is 11' deep (8.5' accounting for stationary motion lights along back) and 26' wide. The ceiling height is 12' high. The runway is 12' long and 4' wide at the end. At the base, the runway is 12' wide. The fans are built into the stage and marked in the diagram with stars. Any props used must be free standing and may not damage the wood floor. There are stationary motion lights on the stage along the back wall. Account for 2.5' clearance when staging as these lights and the LED screen should not be touched. When

making costume changes or setting props, keep clear of the lights as they are very hot.

**For rehearsals at the Rose Room inside Station 4 (S4) you MUST use the back entrance (back parking lot) as the front doors will not be open until later each evening. After entering the back door (patio) go up the stairs and in the side entrance to the Rose Room (glass doors). THIS IS THE ONLY TIME YOU WILL BE ALLOWED ENTRANCE USING THE BACK ENTRANCE. YOU MUST ENTER THROUGH THE FRONT ENTRANCE ALL OTHER TIMES including check in times for contestants each night of competition!**

### **- APPLICATIONS & ENTRY FEE -**

**THIS YEAR** the Inaugural America's Bearded Queen Pageant will be an open pageant, meaning **ANYONE** from across America, is welcome to enter. After this year, Bearded Pageantry Inc will begin selling preliminary pageants to America's Bearded Queen and (if enough prelims are sold) you must compete in a preliminary to qualify to enter, if not it will remain an open pageant. **The entry fee for this year will be \$150.00.** Your Contestant Application, included in this handbook, can be submitted up until the Contestant Registration on November 3, 2021 at 12 noon in the Rose Room.

You are welcome to mail your application along with your entry fee of \$150.00 before arriving to Registration. **IF mailing your application, the deadline for Bearded Pageantry Inc to receive your contestant application and entry fee is October 25, 2021. ANY applications or entry fees mailed after that date does not guarantee it will be received at the National Office.** If sending via USPS PLEASE send to:

## - SCORING -

Scoring for the America's Bearded Queen Pageant will be done on a **cumulative** scoring system. Each judge will give each contestant a score based on their performance in each category without regard to the other contestants. With this scoring system, more than one contestant may be given the same score. Scores are assigned as follows:

Creative Presentation	1 to 10 Points
Personal Interview	1 to 10 Points
Creative Fashion	1 to 10 Points
Talent	1 to 40 Points
<b>Maximum possible points</b>	<b><u>70 Points</u></b>
	<u>X 5 judges</u> (high & low scores of the 7 judges will be dropped)
<b>Total Possible Points</b>	<b>350 Points</b>
On Stage Q & A (top 5 only)	<u>1 – 30 Points</u> ( <b>not cumulative</b> )
	<b>500 Points</b> (high and low score of the 7 judges will be dropped)

There will be seven Judges for the 2021 America's Bearded Queen Pageant. In case of a tie the tie will be broken by the contestant's talent score. The Judges Comment sheets, Talent music and Master Score Sheet will be available to each contestant following the crowning of the 2021 America's Bearded Queen. The finalists will receive their judges comment sheets and a copy of the master score sheet when leaving the stage at crowning. The top 5 are expected to remain on stage for photos following crowning and the top 3 will receive their prize money at the host venue following crowning of the Inaugural America's Bearded Queen.

**Camera-ready artwork is preferred** but layout and typesetting services are available at a nominal charge. Photographs submitted must be no larger than 8 1/2" x 11". Copyrighted photographs you send for publication in the program must include a release from the copyright holder allowing publication of the photograph(s). Photographs without the release will not be published. **The preferred method of submission is electronic mail (email).**

If layout and typesetting services are needed your photograph(s) will be scanned then reduced or enlarged to fit your ad. Enlarging a photograph may cause some distortion, so please send **original photographs**. Glossy photographs scan the best. Photographs and/or logos should be bright and clear and void of dark backgrounds if possible. Do not send photographs of nude or even partially nude individuals OR copyrighted photos without a copyright release. Please mail all photographs, logos and camera-ready ads between two pieces of cardboard to prevent creasing unless you are sending them using electronic mail (e-mail)

If you wish, Bearded Pageantry Inc will do your page layout using supplied text and desired photos. Please type or print clearly all text you wish to be incorporated in your advertisement on a separate piece of paper. All type, logos and photographs will be printed in full color.

Location of your advertisement in the program, other than the center spread or inside covers will be at the discretion of Bearded Pageantry Inc. 1. **Titleholders obligations:** Titleholder shall attend and participate in, as a representative of Bearded Pageantry Inc, all State and Regional Preliminary pageants held during the year of Titleholders reign at such time and place as may be set forth by Bearded Pageantry Inc, the "Promoter". All expenses of the titleholder, as set forth in the Promoters Rules and Regulations, shall be at the expense of the State or Regional Preliminary Promoter. These expenses are, but not limited to, titleholders transportation, lodging and performance fee of \$250.00 per night of entertaining. The State or Regional Preliminary Promoter is required to use the services of titleholder only one night during their pageant (if a multi-night preliminary).
2. **Bookings:** All entertaining and/or appearances of an official nature by titleholder shall be cleared and approved at least ten (10) business days in advance by "Promoter" whose approval shall not unreasonably be withheld. Entertaining and/or appearances of an official nature shall be construed as those, but not limited to those, in which the titleholder is appearing mainly due to their title and therefore is representing America's Bearded Queen, the "Promoter" and Bearded Pageantry Inc.
3. **Titleholders responsibilities:** Titleholder agrees to hold the title, Bearded Pageantry Inc and the "Promoter", it's State and Regional Preliminary Promoters and franchisees in the highest esteem. Titleholder agrees that while appearing, entertaining or representing the title during the year of his/her reign to the following:
  - a. Not to be drunk in a public place;
  - b. Not to commit the acts of a sexual nature in a public place;
  - c. Not to commit acts of a violent nature in a public place;
  - d. Not to use illegal drugs;
  - e. Not to commit the act of stealing;
  - f. Not to have a sex change or gender reassignment surgery;
  - g. Not to participate in malicious gossip;
  - h. To attend and participate in the 2022 America's Bearded Queen Pageant at such time and place as set forth by Bearded Pageantry Inc;
  - i. Not to be deemed guilty of any other unreasonable act that is considered demeaning to the title by the "Promoter";

- j. To perform at least two (2) times during a State or Regional Preliminary pageant unless otherwise instructed by that State or Regional Preliminary Promoter;
  - k. Titleholder agrees to provide a satisfactory publicity photograph with crown within thirty (30) days of assuming the title for use by the “Promoter”;
  - l. Not to perform nude;
  - m. Titleholder agrees to keep a valid cellular telephone number in service during the year of his reign;
  - n. Titleholder agrees to have a valid email address and Social Media page (with crown photo) within seven (7) days of winning and keep it active and only used in a positive manner during his entire reign;
  - o. Titleholder agrees to receive permission from the “Promoter” before appearing at a pageant or contest in any other pageant system;
  - p. Titleholder may not enter any pageant during his reign. And most importantly;
  - q. Titleholder must maintain a beard (facial hair) during his entire reign!
4. **Promoters Responsibilities:** Promoters responsibilities to the Titleholder shall be:
- a. To permit the titleholder the booking rights as stated in Articles 1 and 2;
  - b. To provide titleholder with all necessary information on a timely basis, as available, concerning all State and Regional Preliminary pageants;
  - c. To pay all monies, awards and prizes as long as the titleholder is not in default under this agreement as follows;
  - d. \$1250.00 and other awards as listed in the Contestant’s Handbook for the pageant upon winning the title, and;
  - e. \$1250.00 upon completion of his reign which includes being present and entertaining at the 2022 America’s Bearded Queen Pageant;
  - f. To provide at least four (4) tickets to final night of the 2022 America’s Bearded Queen Pageant.
5. **Certain Rights Reserved by Titleholder:** As long as the titleholder is not in default under this agreement, he shall have the following rights;
- a. To enjoy the rights and privileges of said title;
  - b. To be allowed bookings, subject to Articles 1, 2 and 6 contained herein, and for such fees as stated for State and Regional Preliminary Pageants. Other private bookings, approved by the “Promoter”, shall be for whatever fee as the Titleholder feels is justified, and;
  - c. Must reside in the United States of America or be available for access to travel within the United States of America during his entire reign and immediately notify Promoter of ANY change of address.
6. **Certain Rights Reserved to Promoter:** The following rights are reserved to the Promoter:
- a. To have and retain paramount title to the Title at all times;
  - b. To change the title of America’s Bearded Queen at its own discretion;
  - c. To approve all bookings, subject to Articles 1, 2 and 5 contained herein, of Titleholder;
  - d. To reasonably set forth Rules and Regulations concerning the conduct of holders of the title;
  - e. To set the dates, times and location of all future America’s Bearded Queen Pageants and to make reasonable bookings for Titleholder. Said bookings

will be confirmed with Titleholder at least ten (10) days prior to said bookings and said bookings shall be made in a manner as to not cause conflict with Titleholders schedule.

7. **Promoters Remedies:** If Titleholder defaults under this agreement, "Promoter" may treat any one or more of the foregoing occurrences as a breach of this agreement and thereupon at its option may, without notice or demand of any kind (which Titleholder hereby expressly waives), to Titleholder or any other person, have, but not limited to, any or all of the following remedies.
- a. Revoke the title from the Titleholder;
  - b. Demand the return of all prizes, monies and awards given to Titleholder;
  - c. Refuse entry into any franchised America's Bearded Queen Preliminary Pageants;
  - d. Pass the title to the 1<sup>st</sup> Runner-up or any other person felt to be qualified by Promoter;
  - e. Refuse bookings of an official nature to Titleholder;
  - f. Assess fines for breach of any part of this agreement. Said fines shall not exceed the amount of \$250.00 per offense, but may be at a lower amount as set forth and determined by the "Promoter".
8. **Notices:** All notices to be given by one party to the other under this agreement shall be in writing, mailed or hand delivered as follows:

Mailed notices shall be sent by United States Postal Service, Certified or Registered mail, postage prepaid. Such notices shall be deemed to have been given upon posting in the United States mail.

**9. Miscellaneous:**

- a. All rights and remedies of "Promoter" under this agreement shall be cumulative and none shall exclude any other rights and remedies by law.
- b. The word "Promoter" shall be construed to mean Promoters in all cases where there is more than one promoter and necessary grammatical changes required to make the provisions hereof apply to corporations or individuals, or men, or women, shall be assumed as though in each case fully expressed.

**10. Release:**

Titleholder agrees to release and hold harmless Bearded Pageantry Inc, the "Promoter" and the official America's Bearded Queen Pageant, their agents, servants, employees and licensees from any liability, and/or responsibility whatsoever, resulting from, associated with or arising out of Titleholders

participation in the America's Bearded Queen Pageant System, in any duly franchised State or Regional Preliminary Pageant, and/or the title. Including, but not limited to, personal injury or loss of or damage to any personal property, regardless of whether the loss of or injury to occurs before, during or after the America's Bearded Queen Pageant, duly franchised Preliminary Pageants or any related activity including but not limited to any Bearded Pageantry Inc National Pageants, State or Regional Pageant or local preliminaries and their related activities.

Titleholder also hereby releases himself from any and all rights to any videotaping (sound and/or video), photography, recording, still camera or motion picture of the America's Bearded Queen Pageant or any franchised America's Bearded Queen Preliminary Pageant. Titleholder also understands that he has or will have no rights to any of the recordings arising out of said pageants that Titleholder may appear in or on, or the future sales thereof.
